The essays by Dr. van Nieuwenhuijze collected here concern the object of the social sciences, the nature and scope of theory, theoretical concepts as tools for investigation and explanation. Some of these essays deal with matters of pure theory, such as social sciences disciplines as such, middle range theory and the area concept. Others represent an assessment of specific notions, such as reciprocity, that seem to hold particular significance, whether temporarily as just another fad, or on a more permanent basis. Also, questions are raised about how to achieve theoretically sound dealings, for purposes of research, with matters like entrepreneurship and innovation, or labour ethos. The author probes deeply into matters of social change and development, thus elaborating his theory of society as process.

The present volume is the third in a series of methodological essays, the preceding ones being *Society as Process* (1962) and *Cross-Cultural Studies* (1963).
