

This important recent book takes a fresh look at an old problem—whether and to what extent the hand of an intelligent Creator can be discerned from the phenomena of the universe, as reflected overall in modern scientific fact and theory.

Spawned with the rising prestige of science during the Enlightenment, the controversy surrounding the argument from design has surfaced at various times in impassioned public debate, from arguments in the celebrated Scopes trial to recent attempts to have "scientific creationism" taught in the public schools. In *Chance or Design?* the argument over Evolution is seen as incidental only to the more basic inquiry on Design and Causation. In contrast to the rational skepticism of two leading figures of the Enlightenment, Hume and Kant, Horigan's thesis is that significant advances in modern observation provide three separate empirical bases for the discovery of intended design in creation, each of which informs and verifies the others, as in the application of scientific method.

With this book the reader may now seriously question whether the "reason/belief" split, long held to be an insurmountable barrier between scientific and religious thought, continues to be legitimate in the post-Modern era.

Typescript. Typescript, double-spaced, should be submitted (in triplicate) to Professor Robert E. Butts, Department of Philosophy, Talbot College, University of Western Ontario, London, Ontario, Canada N6A 3K7. Typescripts will not be returned unless return postage is prepaid by cheque, money order, International Reply Coupons or Canadian stamps. A bibliographical list of cited references beginning with the author's last name, initials, followed by the year of publication in parentheses, should be headed 'References' and placed on a separate sheet in alphabetical order. Simple citations should then be made by employing in the text, rather than by footnote, the reference list by citing author and year of publication, e.g., Jones (1958) or (Smith 1974, p. 46). A detailed guide to the new reference style appears in the March issue of each year. Discursive footnotes should be numbered consecutively throughout the typescript Typescript should not exceed thirtyfive double-spaced pages. Longer essays will be returned to the author(s) to be cut to the acceptable maximum. A summary abstract of approximately 100 words should accompany each article. All illustrations must be professionally drawn and lettered. All formulas and equations should be put in such a form as to help minimize the number of printed lines in the journal. In the following examples the form on the right is preferable to that on the left:
