Numerical simulations of thermals with and without stratification

The evolution of vertical and horizontal thermals is examined via three-dimensional numerical simulations. The two types of thermals are distinguished by the geometry of their sources: respectively spherical and horizontal cylindrical. How the evolution of a vertical thermal is affected by varying the Reynolds number from the laminar regime into the fully turbulent regime is examined. Although the rate of rise of a thermal increases with increasing Reynolds number in the laminar regime, it is shown here that it decreases with increasing Reynolds number in the turbulent regime. Known instabilities of vortex rings and vortex dipoles are shown to affect the evolution of the vertical and horizontal thermals, respectively. In particular, the short-wave cooperative instability, commonly seen in the evolution of contrails behind aircraft, is a major influence on the evolution of the horizontal thermal. The vortex dynamics during the encounter of both types of thermals with a strong thermocline is examined. It is found that, when blocked by a thermocline, the head of the vertical thermal is dispersed laterally by the action of small compact vortex dipoles that are produced during the collision. Evidence is presented for the propagation of circular waves in the thermocline that spread out horizontally moving away from the impact site. In the case of the horizontal thermal, the collision with the thermocline results in vortex dynamics similar to that which occurs when a dipole impinges on a no-slip wall.

Key words: buoyancy-driven instability, stratified flows, turbulent convection

1. Introduction

Thermals and plumes arise from a release of buoyant fluid that sinks or rises depending on its density relative to the surrounding fluid. A plume results from a continuous release of buoyant fluid, while a thermal results from a relatively brief rapid release. Here, we focus on the formation and evolution of thermals as opposed to plumes. Thermals result, for example, from an explosion, a brief discharge of fluid from a pipe, a drop of cold fluid falling into a warmer fluid, an explosive volcanic eruption, etc. There are two idealized models of thermals, which we propose calling the vertical thermal (VT) and the horizontal



thermal (HT) in analogy with similar nomenclature used for plumes (see e.g. Fay 1973). The source for a VT is narrowly delimited in space as would be, for example, a ball of hot air just after an explosion. As the VT rises it remains roughly symmetric around its vertical axis. A point source would be an idealized model for such a thermal. The source of a HT would, in contrast, be very elongated in one horizontal direction. This might arise from a brief injection horizontally of a jet of hot fluid into a colder fluid. Another application would be the study of the evolution of a VT that has been subject to strong horizontal wind that bent it over making it horizontal (see e.g. Lee & Seo 2000). One could also imagine the flow around a long pipe in which hot and cold fluids flow intermittently. An idealized model for the source of the HT would be an infinitely long horizontal cylinder of buoyant fluid that is suddenly released. An idealized model of the source of a HT would be a horizontal line source.

As we discuss further below, the initial fall or rise of these two types of thermals is associated with two specific vortex structures. The vorticity structure associated with the VT is a vortex ring surrounding the centre of the initial distribution of buoyant fluid and oriented so as to move in the vertical direction. For the HT, it is a vortex dipole elongated in the same horizontal direction as is the column of horizontal fluid that initiates it. These vortex structures are created by the baroclinic torque that arises from the force of buoyancy acting on the flow. There are important differences in the evolution of these two types of vortex structures that are reflected in the evolution of the corresponding thermals. The theoretical treatment of these differences in the evolution of buoyant vortex rings and buoyant dipoles is given by Turner (1960).

Due to their relative ubiquity, buoyant vortex rings and VTs have received much more attention than buoyant dipoles and HTs in real applications. Vertical thermals are also more easily produced in the laboratory than HTs. For example, VTs can be produced by simply dropping a 'blob' of dense fluid into lighter fluid. With this method, Woodward (1959) was able to investigate the entrainment of external fluid into the buoyant vortex ring, the main reason for the spreading of VTs. Many images of such rings and VTs visualized with smoke or other such passive scalar are easily found today on the Internet. However, some of the best images are still to be found in the book by van Dyke (1982). One surprising observation that can be drawn from these images is that there is a remarkable similarity between the structures formed by low- and high-Reynolds-number flow. See for example the pictures presented by Sigurdson (1991) comparing the visualization of the VT of Reynolds number $O(10^2)$ caused by a falling water drop and one of Reynolds number $O(10^9)$ generated by an atomic bomb explosion. The large-scale structure of the high-Reynolds-number thermal is well captured by the low-Reynolds-number experiment. On the laminar low end of the Reynolds number continuum, recent work by Atkinson & Davidson (2019) has revealed very surprising results in the axisymmetric VT case. In particular, they demonstrated that the tail of the thermal in time separates from the head and can form a secondary vortex ring, and that process of separation and formation of another ring can repeat.

Much attention has been given to the instabilities of both vortex rings and horizontally extended vortex dipoles. Below we point out evidence of such instabilities in the evolution of thermals. A theoretical study of the formation of azimuthal instabilities on vortex rings was conducted by Widnall, Bliss & Tsai (1974). Their predictions were verified by simulations of the Navier–Stokes equations by Shariff, Verzicco & Orlandi (1994). Similar instabilities occur in the elongated dipole vortex that is a model for the contrails generated in the wake of aircraft. Since contrails can be dangerous to aviation, much research has been devoted to finding a way to disrupt them. There is a long-wave instability on contrails

called the Crow instability which has been theoretically explained by Crow (1970) and reproduced in the laboratory by Leweke & Williamson (1998). Of more interest to us is the short-wave cooperative instability in which the strain produced by one of the vortices in the dipole affects the other and vice versa in such a way as to produce a sinusoidal modulation along the length of the dipole that results in large-amplitude small-scale vortical structures that strongly deform the primary vortices. Theoretical studies of this instability include those of Widnall *et al.* (1974), Bayly (1986), Pierrehumbert (1986), Landman & Saffman (1987) and Waleffe (1990). The instability has been demonstrated in laboratory experiments by Thomas & Auerbach (1994) and Leweke & Williamson (1998). Orlandi *et al.* (2001) have used numerical simulation to help understand this instability and to consider the feasibility of using temperature perturbations of contrails to promote the instability in such a way as to disrupt the contrails.

The effect of background stratification on the propagation of thermals is of considerable interest. Orlandi, Egermann & Hopfinger (1998) compared the results of an experimental study of a vortex ring descending in a linearly stratified fluid with an axisymmetric simulation. They found that the maximum penetration depth has a nearly linear dependence on the Froude number Fr = U/RN, with U the ring velocity, R the radius and N the Brunt–Väisälä frequency. The data of the ring position as a function of non-dimensional time Nt collapse onto one curve when the depth is scaled with N and the initial ring velocity. Here we turn our attention to the effect of a thermocline in the path of a thermal. The thermocline, a horizontal layer of strong density gradient, presents a barrier to the propagation of a thermal. Thermoclines exist in both the atmosphere and the oceans, and the issue of how convective motions penetrate them is very important to our understanding of both weather and climate. Interesting studies of this problem have yielded laws determining the strength needed for a thermal to penetrate a thermocline, and the stopping distance after such penetration (Richards 1961). Our focus, however, is on illuminating the vortex structures that are created when either type of thermal hits a thermocline.

In this paper, we present the results of fully three-dimensional simulations of the evolution of both vertical and horizontal thermals. For the VT, we explore the effect of increasing Reynolds number over a range from nearly laminar flow to turbulent flow showing how the intensity of small-scale disturbances of temperature and vorticity increases with Reynolds number. For a value of the Reynolds number sufficiently low to permit simple analysis of the vortex dynamics, yet high enough to generate interesting perturbations and instabilities, we compare the evolution of the vertical and horizontal thermals. Finally, we examine the collision of both types of thermals with a thermocline of sufficiently high density gradient and sufficient width to completely block their penetration. This reveals, in particular, interesting aspects of the vortex dynamics that result in the dispersal of the thermals.

2. Equations and numerical model

The physical problem that we explore here is the rise of a 'blob' of relatively hot fluid placed initially in the lower layer of a two-layer fluid with ambient temperature T_L in the lower layer and $T_H > T_L$ in the upper layer. The two layers are connected by a transition layer, a thermocline, in which the temperature changes smoothly from T_L to T_H , as will be described in more detail below. We take the spatial coordinates to be x_i (where i = 1, 2, 3) with x_1 positive in the vertical direction. The background distribution of temperature in the two-layer fluid without the blob perturbation can then be written as a time-invariant function $T_0(x_1)$. The total temperature is then

$$T = T_0(x_1) + \Delta T(x_1, x_2, x_3, t).$$

The initial condition on the velocity for these studies is zero velocity everywhere. The blob is initially represented by a Gaussian temperature perturbation:

$$\Delta T = T_m \exp(-(R/R_0)^2/0.75), \qquad (2.2)$$

where $R^2 = (x_1 - x_0)^2 + x_2^2 + x_3^2$ for the VT and $R^2 = (x_1 - x_0)^2 + x_2^2$ for the HT. In both cases, the initial height of the centre of the blob is $x_0 = 3$. As appropriate for a rising thermal, we take $T_m > 0$. Note that the initial temperature in the centre of the blob is $T_c = T_L + T_m$.

The Boussinesq approximation is the simplest approximation to the evolution equations that captures both of the essential effects that we are interested in exploring: buoyancy and stratification. We write the Boussinesq equations in non-dimensionalized form as

Here δ_{ij} is the Kronecker delta. The velocity also obeys the incompressibility relation

$$\frac{\partial u_i}{\partial x_i} = 0. \tag{2.5}$$

In non-dimensionalizing these equations, we use $T_m = T_c - T_L$ as the unit of temperature. We write the non-dimensional temperature perturbation as $\theta \equiv \Delta T/T_m$, the non-dimensional total temperature as $\theta_T = (T_0 + \Delta T)/T_m$ and the non-dimensional background stratification as $\theta_0 \equiv T_0/T_m$. All lengths are non-dimensionalized using R_0 . Velocity is made non-dimensional with the reference velocity $U_0 \equiv \sqrt{g\beta T_m R_0}$, where β is the volumetric coefficient of thermal expansion. The Reynolds number is given by $Re = U_0 R_0/\nu = \sqrt{g\beta T_m R_0^3}/\nu$. Thus, we can write

$$Re^{2} = \frac{g\beta T_{m}R_{0}^{3}}{\nu^{2}},$$

which is the Grashof number for our problem.

In the special case of an ideal gas, one has $\beta = 1/T$. Within the context of the Boussinesq approximation, we can write $\beta \approx 1/T_L$ further simplifying the above expressions to $U_0 \equiv \sqrt{g'R_0}$ and $Re = \sqrt{g'R_0^3}/\nu$, where $g' = gT_m/T_L$ is the reduced gravity. Finally, note that Pr is the Prandtl number given by $Pr = \nu/\kappa$, where κ is the thermal diffusivity. We will take Pr = 1 in this work, but see Atkinson & Davidson (2019) for a recent examination in the role of Pr in the evolution of laminar VTs.

In our numerical scheme, the evolution equations are discretized in space by using a staggered mesh scheme with the velocity components located on the faces of the computational grid cell and the pressure at the centre (see Orlandi 2012). In order to ensure inviscid conservation of total kinetic plus potential energy in the limit of an infinitesimal time step, θ and u_1 are defined at the same position in each cell. Even though our simulations are run with finite viscosity and diffusivity, we believe it is important to use such a conservative scheme to prevent any spurious energy transfer that may cause problems in our analysis of the energy budgets for the thermals. Furthermore, it is worth pointing out that the derivative of θ_0 in the advective term $u_1 d\theta_0/dx_1$, which appears in (2.4), is calculated on the staggered mesh by a centred difference approximation using the values of $\theta_0(x_1)$ evaluated on the discrete grid. Finally, note that the time derivatives in (2.3) and (2.4) are discretized by using a fractional step method as described by Orlandi (2012).

In the VT case, the dimensions of the computational domain are given by $0 < x_1 < 24$, $-10 < x_2 < 10$ and $-9 < x_3 < 9$. Uniform grids are used in the x_1 and x_3 directions, in order to use the cosine transformation in x_1 and periodicity in x_3 . These transformations allow us to directly solve the elliptic equation for pressure by inverting a tridiagonal matrix for each wavenumber. A non-uniform mesh is used in the x_2 direction allowing for higher resolution where needed. Simulations are performed with a grid $512 \times 256 \times 512$ at Re = 500, with grid resolution increasing up to $1024 \times 512 \times 1024$ for Re = 5000. For the HT case, which was run only at Re = 500, it was found that the width of the domain needed to be doubled to prevent the proximity of the sidewalls from influencing the results because, as we shall see, the HT spreads laterally faster than the VT. Thus, in the HT case we took $0 < x_1 < 24$, $-20 < x_2 < 20$ and $-9 < x_3 < 9$ on a grid $512 \times 512 \times 512$. We have used one-dimensional profiles of velocity components and pressure to confirm that the resolution in these simulations is satisfactory.

To mimic the initial asymmetries of an explosion-created initial condition for the thermals, we add to the Gaussian distribution random disturbances of amplitude $\Delta \theta = 0.45$ at each grid point where $R^2/0.75 < 2$ (except in cases where it is explicitly stated otherwise).

3. Thermals in an unstratified environment

In this section, we consider the evolution of thermals in an unstratified environment. Thus, we take $\theta_L = \theta_H$, which implies $d\theta_0/dx_1 = 0$ everywhere. One consequence of this is that there will be no loss of energy due to internal waves or interfacial waves radiating away from the thermals since such waves can only propagate into regions where a gradient of θ_T exists. We will return to this point in the next section when we consider the interaction of thermals with a thermocline.

3.1. Simulations of VTs for a range of Re

Our goal here is to look at the transition in behaviour from the laminar low-*Re* thermals, which have been studied in detail by Atkinson & Davidson (2019), to high-*Re* turbulent conditions. Figure 1 shows contour plots of θ in an x_1 - x_2 plane at $x_3 = 0$, at non-dimensional time t = 15, from four simulations with *Re* running from 500 to 5000. Figure 1(*a*) at *Re* = 500 shows a relatively smooth distribution of θ with the head having a cross-section typical in cases driven by a vortex ring. From this head, there extends a long tail. Midway up the thermal, we see that there is a strong gradient of θ near the edge of the vertical cylindrical tail. In the head itself, the gradients are even more intense than in the tail. This image suggests that the large random disturbances which were initially imposed have been damped by the action of viscosity and diffusivity. At this point, θ has attained a very axisymmetric distribution.




FIGURE 1. Contours of θ at t = 15 at $x_3 = 0$, with increments $\Delta \theta = 0.01$. The maximum value of θ in each plot is (a) 0.30 (Re = 500), (b) 0.42 (Re = 1000), (c) 0.27 (Re = 2000) and (d) 0.27 (Re = 5000).

At Re = 1000 the initial temperature perturbations give rise to azimuthal disturbances that amplify and result in large-amplitude asymmetric perturbations to the head (see figure 1b). Furthermore, the 'tail' of the thermal becomes disconnected from the head. Although this separation is also normal in the evolution of laminar thermals, as demonstrated by Atkinson & Davidson (2019), in the case shown here the separation is aided by fluctuations. With *Re* increased to 2000 (see figure 1c), small-scale clusters of θ pervade the head, giving the surface a texture of a 'cauliflower' nature (Scorer 1957). To some extent, this description also characterizes the upper part of the tail. As *Re* is increased further, these small-scale clusters of high-amplitude θ increasingly engulf the tail as well as the head. At *Re* = 5000 (see figure 1*d*), a significant portion of the tail has broken up into clusters of much smaller scale than seen in the *Re* = 2000 case.

3.2. Comparison with HTs

Next, we present results from a simulation of the HT and make a preliminary comparison with the VT. We are primarily concerned here with the large scales of motion in the vertical and horizontal thermals, rather than in the small scales that would be similar in




FIGURE 2. Contours of θ at t = 15 for the (a,c) HT and (b,d) VT with Re = 500. The contour increment is $\Delta \theta = 0.01$. The contours are coloured from blue to red for θ increasing from 0 to 0.3. The contours for $0.3 < \theta \le 0.35$ are coloured black. In (a,b), the x_2-x_1 plane is shown at $x_3 = 0$, and the horizontal black dashed lines indicate the vertical level x_1 from which the data for the corresponding panels (c,d) are taken. Note that the image in (d) is magnified by a factor of 2 relative to that in (b) to clearly show the azimuthal asymmetry.

both when Re is sufficiently high as to produce small-scale three-dimensional turbulence. Hence, we consider only the HT case at Re = 500 for this comparison.

The comparison between the contours in x_1-x_2 planes in figures 2(*a*) and 2(*b*), which are drawn to the same scale, shows that at t = 15, the lateral spreading of the HT is greater than that of the VT. The reason for this is found in Turner (1960) where it is shown that after a transition period, the radius of a buoyant vortex ring should increase as $t^{1/2}$, whereas the distance between a buoyant pair of rising 'anti-parallel' horizontal vortices will grow as *t*.

In figure 2(c), we see the effect on θ of the two important instabilities that act on the rising vortex pair, instabilities that are commonly seen in the contrails behind jet

aircraft. In the area of blue to green contours on the outer side of each of the two primary vortices, we see variation on a scale that is small with respect to the distance between the axes of these vortices. These structures result from the so-called short-wave cooperative instability. In the area of red to black contours, there are structures that are, at least in the axial direction, much larger. These long structures are due to the incipient long-wave instability (Crow 1970) that typically causes the two primary vortices to connect and form separate loops breaking up the parallel structure. For more on the instabilities of counter-rotating or anti-parallel vortices, see, for example, Leweke & Williamson (1998), Orlandi et al. (1998), Orlandi et al. (2001) and Nomura et al. (2006). In the case of the VT, it is instability of a vortex ring that should be expected to show up in modulations of θ . In figure 2(d), there is an azimuthal variation of wavenumber 2 that appears in the otherwise nearly circular θ distribution. This variation seems weak compared to the more pronounced effects of instability in the HT case. The instability growth rates and dominant wavelengths associated with the underlying vortex structure in each case will depend on geometric parameters as well as the circulation. In the case of the VT, these parameters are the radius of the ring as well as the radius of the core of the vortex that forms the ring (Widnall et al. 1974). In the case of the anti-parallel vortices of the dipole, the instabilities are similarly controlled by the radii of the cores of the two vortices and by horizontal distance between them. Apparently, in the examples provided here, the growth rate for the Widnall instability in the vortex ring case is significantly slower than that for the short-wave cooperative instability in the anti-parallel vortex pair case.

In addition to the geometrical parameters and circulation, at low Re the instabilities are significantly controlled by viscosity. Here at Re = 500 the Widnall instability produces an azimuthal mode 2 instability. At higher Re, higher wavenumbers can become dominant (see e.g. Shariff *et al.* 1994).

3.3. Spreading in time

In figures 1 and 2, the contour plots are all from the same time, a time that represents a stage when the thermal was fully developed. Next we will look into the evolution of both kinds of thermals. As above, we will consider a range of *Re* in the VT case, but only the case Re = 500 in the HT case. In order to make the figures easier to interpret, we have taken advantage of the approximate symmetries in both of these thermals to perform some spatial averaging. For the VTs, we take advantage of the approximate symmetry about the x_1 axis and perform an azimuthal average about that axis to produce an averaged distribution $\langle \theta \rangle$ as a function of $r = \sqrt{x_2^2 + x_3^3}$ and x_1 . For the HT, an average along the x_3 direction is appropriate, yielding an average as a function of x_1 and x_2 . In addition, we can exploit the near symmetry of θ with respect to reflections in the x_3 - x_1 plane to further average θ from the values on the two sides of this symmetry plane. Again, the result is denoted $\langle \theta \rangle$.




FIGURE 3. Superimposed contours of $\langle \theta \rangle$ at different times: t = 5 (red); t = 10 (yellow); t = 15 (green); t = 20 (blue); t = 35 (black). The scale of the axes and the contour interval ($\Delta = 0.01$) are the same in each panel. (a) HT, Re = 500, (b) VT, Re = 500, (c) VT, Re = 1000, (d) VT, Re = 2000 and (e) VT, Re = 5000.

In figure 3, the evolution of $\langle \theta \rangle$ is shown by superimposing the contours of $\langle \theta \rangle$ from different times while colouring the contours according to the corresponding time in the sequence, each time associated with a different colour. Comparing the evolution of the HT with that of the VT in figure 3(*b*) shows that the spreading of the HT is considerably faster than that of the VT, as was already noted above. Here, we also see that associated with increased horizontal spreading is decreased vertical velocity. In both of these types of thermals, the vertical velocity is associated with self-advection of the mean vorticity structure: in the HT case, the advection of one of the vortices in the dipole by the other; in the VT case, the advection of one part of the ring by points on the other side of the

ring. Thus, the further apart the anti-parallel vortices, or the wider the vortex ring, the lower is the vertical velocity. Hence, the broader HT in figure 3(a) does not reach as high by t = 20 (blue contours) as the narrower VT of the same Re = 500 shown in 3(b). Note also that comparing the images of the VTs among themselves, we see that there is not much difference in the width of the thermals or the height they reach at t = 20 comparing the cases with Re equal to 500 and 1000. The same can be said concerning the pair of cases with Re equal to 2000 and 5000. However, comparing the pair of VTs with the low values of Re (500 and 1000) with the pair with higher Re (2000 and 5000), we note a significant increase in the breadth of the thermals and a decrease in the height reached at t = 20. The presence of finer scales at the higher values of *Re* accounts for greater mixing and subsequent spreading of the thermal. We also note that, quite paradoxically, there are fewer contours at t = 30 (blue) in the pair of VTs at high *Re* compared to the pair at lower *Re*, in spite of the lower constant of thermal diffusivity κ . This is a result of a higher rate of thermal dissipation due to the finer scales that arise with sufficiently high values of Re. We will explore the effect of increasing Re on spreading and vertical velocity more quantitatively below.

3.4. The VT: mean fields and fluctuations




FIGURE 4. Contours of various statistical quantities at t = 18 for (a-f) Re = 500 and (g-l) Re = 5000. For all fields except for P, the colour table has red/blue as the maximum/minimum value. This is reversed for the P field. The contour increment Δ is given below each panel. (a) $\langle \theta \rangle$, $\Delta = 0.005$; (b) P, $\Delta = 0.005$; (c) $\langle \theta'^2 \rangle$, $\Delta = 0.001$; (d) $\langle p'^2 \rangle$, $\Delta = 0.002$; (e) Ω' , $\Delta = 0.07$; (f) K', $\Delta = 0.0025$; (g) $\langle \theta \rangle$, $\Delta = 0.005$; (h) P, $\Delta = 0.005$; (i) $\langle \theta'^2 \rangle$, $\Delta = 0.001$; (j) $\langle p'^2 \rangle$, $\Delta = 0.003$; (k) Ω' , $\Delta = 1.0$; (l) K', $\Delta = 0.0125$.

The comparison between figures 3(b) and 3(e) discussed above pointed out the importance of the small-scale fluctuations at high Re that are not present at Re = 500. To analyse this further, we examine some statistics of the fields in the VT simulations performed at Re = 500 and Re = 5000. Of particular interest will be the mean temperature $\langle \theta \rangle$ and the mean pressure $P = \langle p \rangle$, where we use the azimuthal average defined above. Contour plots of these are displayed in figure 4 along with variances of these and other quantities: the pressure variance $\langle p'^2 \rangle$, where $p' \equiv p - P$; the temperature variance; the velocity variance

 $K' \equiv \langle u_i'^2 \rangle/2$; and the vorticity variance $\Omega' \equiv \langle \omega_i'^2 \rangle/2$ (with the normalizing factor of 1/2 added for convenience).

In figure 4(*a*), showing $\langle \theta \rangle$ in the low-*Re* case (*Re* = 500), we see that the thinning of the neck connecting the cap of the thermal with the wake allows the clear definition of these two regions. The dynamics behind this thinning and the separation of the two structures is described in detail by Atkinson & Davidson (2019). Comparing figure 4(*a*) with the *Re* = 5000 case, we see that the separation between cap and wake is less pronounced. This contrast between the laminar and turbulent cases is also evident in the panels showing the fluctuating statistics $\langle \theta'^2 \rangle$, Ω' and *K'*.

In contrast to $\langle \theta \rangle$ and the fluctuation statistics just mentioned, the contour plots of *P* and $\langle p'^2 \rangle$ at both low and high *Re* stand out because the wake appears non-existent, at least at the level of contour increment used here. The predominant pressure signal is a strong minimum (note red marks the lowest-valued contours in figure 4*b*,*h*) in the core of the vortex ring in the head of the thermal. The lowest values of *P* coincide with the hottest part (i.e. highest values of $\langle \theta \rangle$) in the head.

Another observation is that, at Re = 500, the contours near the peaks of the variances are not smooth and elliptical, nor are they centred on the position of either maximum $\langle \theta \rangle$




FIGURE 5. Contours of $P^*(r, x_1^*)$ for (a) Re = 500, (b) Re = 1000, (c) Re = 2000 and (d) Re = 5000. The contour increments are $\Delta P^* = 0.025$. Low/high values are coloured red/blue.

or minimum *P*. Rather, the contours near the extremum of each of the variances are more distorted than $\langle \theta \rangle$ or *P* near their extrema, and each is in a different position with respect to that of any of the other variances. On the other hand, the generation of strong fluctuations at Re = 5000 leads to better mixing, and consequently the regions of high variance are more similar to the regions of high $\langle \theta \rangle$ and *P*.

3.5. Using P to track the thermal

Of all the fields investigated in § 3.4, *P* seems the smoothest in the head of the thermal. Thus, the location of the minimum of the mean pressure field $P(r, x_1, t)$ may be useful in quantitatively investigating the effect of varying *Re* on the spreading of the thermal. We define the function $P^*(r, x_1^*) = P(r, x_1^*, t)$, where $x_1^*(t)$ is the height of the point where $P(r, x_1, t)$ achieves its minimum value. In figure 5, we plot $P^*(r, x_1^*)$ on the $r-x_1$ plane by using the data for $P^*(r, x_1^*(t))$ for the 20 discrete values of t from t = 1 to t = 20 in unit increments. The height of highest part of each graph corresponds to $x_1^*(t = 20)$ and is a measure of how high the thermal has risen by t = 20. Note that the highest points reached in the Re = 500 and Re = 1000 cases are significantly higher than in the Re = 2000 and Re = 5000 cases.




FIGURE 6. The vertical and radial displacements, Δx_{1min} and Δr_{min} , of the position of the minimum *P*, for the VT. (*a*) The vertical displacement $\Delta x_{1min}(t)$ versus *t* for various values of *Re*. The dashed line is a least-squares fit of $x_1(t) = \sqrt{t/k}$ to the *Re* = 5000 data over the range $t \in [10, 20]$. (*b*) The vertical displacement at time 20 versus *Re* (black for smooth Gaussian initial condition (IC), red for Gaussian IC with random perturbations, blue squares from two runs with intermediate amplitudes of random perturbations). (*c*) The position Δr_{min} at time 20 versus *Re*.

In order to give a simpler quantitative measure of the rise of the thermal with time, in figure 6(a) we plot the height change $\Delta x_1(t) = x_1^*(t) - x_0$, where $x_0 = 3$ is the initial position of the centre of the blob, versus t. Note that we have added data from simulations at two additional values of *Re*. For the three lower values of *Re* (100, solid cyan squares; 500, open red squares; 750, open blue circles), the curves show the trend that laminar thermals rise more rapidly the higher the value of *Re*. For the four highest values of *Re*, the trend is the opposite – the higher the value of Re the slower the rise of the thermal. To show these opposing trends in a yet simpler form, the total rise by time t = 20 is plotted as a function of Re in figure 6(b). The red data points in the plot are taken from the same data shown in figure 6(b) with the addition of values for two more Re. We see that the red data points rise in height with increasing Re until Re = 500, beyond which they fall. These data suggest a transition to turbulence around Re = 500. However, we must remember that these simulations were started from the Gaussian initial condition with random perturbations. By decreasing the amplitude of the random perturbations, one can delay the onset of turbulence in any given plume, allowing a higher vertical velocity, at least during the early evolution. By adding no random element to the initial condition, we obtain the data shown as black dots in 6(b). For the span of *Re* represented, the black curve is monotonically rising. However, the curvature beyond Re = 500 is negative, and a peak may be expected somewhere beyond the data point at Re = 2000. For the case Re = 750,

we have also shown two blue hollow-square data points that represent simulations for random initial perturbations of incrementally lower amplitude than that for the simulation represented by the red dot. These points suggest that one could draw a series of curves for decreasing amplitude of initial random perturbations that would converge on the black curve. We failed to obtain a data point at Re = 5000 in the unperturbed case because our domain with $L_1 = 24$ proved too limited vertically. Finding the peak of the black curve will involve a new study on a larger domain and with the higher resolution needed to reach higher values of Re. Finally, with regard to figure 6(b), we note that the graph readily yields the mean vertical velocity for the thermal versus Re if one simply divides the Δx_{1min} data by $\Delta t = 20$. Note that the mean velocities so obtained range from approximately 0.7 to 0.9 for the simulations with random perturbations. The magnitudes of these velocities suggest that our reference velocity $U_0 \equiv \sqrt{g\beta T_m R_0}$ was an appropriate choice for this problem.

The lateral spreading of the thermal can be measured by the change in the radial position (r_{min}) of the minimum of *P*. In figure 6(c), we plot $\Delta r_{min} = r_{min}(t = 20) - r_{min}(t = 0)$

versus *Re*. Here again, we see two trends: for the low values of *Re*, Δr_{min} decreases with increasing *Re*; and for the high values of *Re*, Δr_{min} increases with increasing *Re*. By comparing figures 6(c) and 6(b), we see that, as anticipated above in § 3.3, for turbulent thermals, the slowing of the vertical rise of the thermal at high *Re* is correlated with increasing lateral spreading with increasing *Re*.

The trend in laminar thermals for the velocity of the VT to increase with increasing Re was examined in detail in a recent study by Atkinson & Davidson (2019). They note that there is an analytic formula given by Saffman (1970) for the vertical velocity V for a thin-cored ring for small Re:

$$V_{visc} = \frac{\chi}{4\pi R} \left[\ln\left(\frac{8R}{\sqrt{4\nu t}}\right) - 0.558 \right],\tag{3.1}$$

where *R* is the radius of the ring and χ the circulation. The main effect included in this formula compared to the case of an inviscid ring is the viscous increase of the core radius which goes as $\sqrt{4vt}$. For a fixed time, as v decreases with increasing *Re*, *V* increases, and this should hold through the entire laminar regime.

Unfortunately, we know of no such formula showing how the vertical velocity of a turbulent thermal changes with Reynolds number. Scorer (1957), using dimensional analysis independent of Re, developed scaling laws for the change in height and width in time for turbulent VTs. These laws have proven valid in turbulent flow in laboratory experiments. Specifically, he found that the height of the thermal goes as

$$x_1(t) = \sqrt{t/k},\tag{3.2}$$

where k is an experimentally determined constant. Furthermore, the width of the thermal is found to obey $r = x_1(t)/n$, where n is another experimentally determined constant. In the experiments, these formulas only apply in the late stages of the flow, when the thermal is fully turbulent. The origin of time in the formulas then needs to be taken as an adjustable parameter. A fit of (3.2) to our data for $t \in [10, 20]$ using the origin of time and the parameter k as adjustable parameters yields the dashed curve shown in figure 6(a). The fit is reasonable; however, given that the formula and our data represent curves of the same curvature and that there are two adjustable parameters, it not surprising that a good fit can be obtained. A much more thorough study would have to be performed on a larger domain to verify this scaling in the numerical simulations, and to see how it is approached asymptotically with increasing *Re*. It may be that as *Re* increases beyond *Re* = 5000 the values of $x_{1min}(20)$ and $r_{min}(20)$ will asymptote to constants as suggested by the *Re*-independent laws of Scorer (1957).

3.6. Evolution of $\overline{u_1^2}$ and $\overline{\theta^2}$: VT

In this section, we examine the evolution of the kinetic energy components $q_i \equiv \overline{u_1^2}/2$ (no sum) and the temperature variance $\Theta \equiv \overline{\theta^2}/2$ (where the factor of 1/2 is inserted for convenience). The overline represents integration over the entire domain. The evolution equations for q_i are obtained by multiplying (2.3) by u_i and integrating over the entire domain. Similarly, we obtain an equation for Θ by multiplying (2.4) by θ and integrating. Since the buoyancy term appears only in the u_1 momentum equation in (2.3), and this is the driving force for vertical motion, we will concentrate on the evolution of the vertical component of the kinetic energy $q_1 = \overline{u_1^2}/2$ and $\Theta = \overline{\theta^2}/2$. Thus we focus on two equations:

$$\frac{\mathrm{d}q_1}{\mathrm{d}t} = -\frac{\partial u_1^2 u_j}{\partial x_j} - \overline{u_1}\frac{\partial p'}{\partial x_1} + \frac{1}{Re}\overline{u_1}\frac{\partial^2 u_1}{\partial x_j^2} - \overline{u_1\theta} = T_1 + P_1 + D_1 + B_1$$
(3.3)

and

$$\frac{\mathrm{d}\Theta}{\mathrm{d}t} = -\frac{\overline{\partial\theta^2 u_j}}{\partial x_j} - \overline{u_1\theta}\frac{\mathrm{d}\theta_0}{\mathrm{d}x_1} + \frac{1}{RePr}\overline{\theta}\frac{\partial^2\theta}{\partial x_j^2} = T_\theta + S_\theta + D_\theta.$$
(3.4)

Note that the first terms on the right-hand side of each equation, T_1 and T_{θ} , vanish identically since they represent integrals of divergences that vanish due to the boundary conditions that we are applying. Furthermore, if there is no background stratification, θ_0 vanishes identically and, hence, the second term on the right-hand side of the $d\Theta/dt$ equation, S_{θ} , also vanishes. Thus, the Θ equation simply states that the change in time is entirely due to diffusive dissipation represented by the term D_{θ} , which is always negative.

We investigate next the effect of varying Re on the evolution of q_i and Θ in the developing VT. Given the approximate symmetry of the thermal about the vertical x_1 axis, it is not surprising that $q_2 \approx q_3$. Thus, in figure 7(*a*), we examine the evolution of the three quantities: q_1 ; $q_2 + q_3$; and Θ . Over the entire history shown, and for all *Re* reported, the vertical component q_1 is significantly larger than the horizontal components q_2 and q_3 . In the early evolution, at $t \approx 1$, the ratio of the vertical component of the kinetic energy to that of the combined horizontal components is about 4. This factor rises to about 8 at $t \approx 5$ before settling down after $t \approx 15$ to about 2. The highest ratio is during the period when the vorticity is rolling up to create a well-defined vortex ring as evidenced, to a certain extent, by the images of θ in yellow in figure 3. It is also interesting to note that in the later evolution, after $t \approx 10$ for the vertical component and after $t \approx 15$ for the horizontal components, the kinetic energy components are higher the lower the value of Re. This is in accord with our earlier discussion, following Turner (1960), noting that at lower Rethere is less spreading and, hence, higher vertical velocity. Figure 7(a) also shows that Θ decreases monotonically at all *Re*, as must be the case since there is only one source of change for Θ , the dissipative term D_{θ} which is always negative. As with the kinetic energy, it is noteworthy that the Θ curves are lower the higher the value of Re. This is related to the decrease in scale of turbulent fluctuations of θ with increasing Re which leads to a higher rate of dissipation $D_{\theta} = \overline{\theta \nabla^2 \theta} / RePr$. This is also related to the increased entrainment of cooler fluid with increasing Re. This allows for the creation of intense small-scale gradients in θ that are then smoothed by thermal diffusion.

Figure 7(*a*) shows that the evolution of q_i and Θ at Re = 500 is similar to that at Re = 1000, and the behaviour at Re = 2000 is similar to that at Re = 5000. Thus, going forward, we limit our remarks to the two extreme values: Re = 500 and Re = 5000. We first consider the rate of change of Θ , which in this case of no background stratification is given entirely by the term D_{θ} in the transport equation. The evolution of this term is shown in figures 7(*b*) and 7(*c*) for the cases Re = 500 and Re = 5000, respectively. In both cases, the value of D_{θ} is initially extremely negative (not shown) because of the strong dissipation of the initial pointwise randomly generated perturbations, but it rapidly becomes less negative and reaches a local maximum at $t \approx 2$ of approximately the same value in both cases. After this time, the value of D_{θ} begins to become more negative rapidly. This rise in the dissipation rate results when the initial core of high temperature gradient above it. This thin layer bends around the rising core and, during the period




FIGURE 7. For the evolution of the VT: (a) q_1 , circles; $q_2 + q_3$, squares; Θ , triangles; at the four values of *Re* indicated; (*b*,*c*) $d\Theta/dt = D_{\theta}$; (*d*,*e*) $dq_1/dt = B_1 + P_1 + D_1$, black; B_1 , green; P_1 , blue; D_1 , red. Reynolds number Re = (b,d) 500 and (*c*,*e*) 5000.

4 < t < 6, rolls up in conjunction with the formation of the vortex ring. During this event, the dissipation rate $|D_{\theta}|$ reaches a local maximum at $t \approx 5$. The maximum dissipation rate is slightly higher for the Re = 5000 case than for the Re = 500 case. After this time, the vortex ring formation is complete and the dissipation rate falls off at different rates in the two cases. Dissipation rates remain elevated longer in the higher-Re case because of continued presence of small-scale turbulent fluctuations.

The evolution of dq_1/dt and each of the non-zero contributing terms on the right-hand side of (3.3) is rather more complicated than that of the evolution of the rate of dissipation of Θ . The evolution of dq_1/dt is not monotonic. Instead, it exhibits some strong oscillations (black open circles in figure 7d, e). There must be a sequence of events in the evolution of the vortex structure of the thermal that is associated with this oscillation, but we have not been able to discern what that sequence is. The oscillation is particularly puzzling in light of the way the kinetic energy just increases monotonically. The similar behaviour of dq_1/dt at Re = 500 and Re = 5000 implies that the oscillation is due to the physics of the flow and not to a resolution issue. Further detailed study of this early (i.e. before t = 15) phase of the development of the thermal will be needed to understand this oscillation. Of the right-hand-side terms of (3.3), the buoyancy term, B_1 (green dots), is positive during the entire evolution and is the sole production term. In magnitude, it is larger than either the pressure term P_1 (blue dots) or the viscous dissipation D_1 (red dots). The P_1 term accounts for the transfer of energy from vertical to horizontal motion. The observation that $|B_1| > |P_1|$ explains the difference in magnitude of q_1 and $q_2 + q_3$. We also find that $P_2 \approx P_3$ and that both are production terms (i.e. positive) in the budget equation for q_2 and q_3 . The rate of energy dissipation D_1 remains relatively small during the evolution for both values of *Re*. Consistent with our observations from figure 7(a), the term D_1 , as well as D_2 and D_3 (not shown), is larger in magnitude for the higher Reynolds number.

3.7. Vorticity visualization

3.7.1. Vertical thermals

The generation of vorticity by baroclinic torque (see Zhao *et al.* 2013) can be obtained directly from (2.3) by taking the curl. We use cylindrical coordinates (r, ϕ, z) , where *r* is the distance from our x_1 axis and ϕ is the azimuthal angle measured counterclockwise from the *r* axis looking down along the $z = x_1$ axis. The torque can be written as

$$\tau_r = \frac{1}{r} \frac{\partial \theta}{\partial \phi}, \quad \tau_\phi = -\frac{\partial \theta}{\partial r}, \quad \tau_z = 0.$$
(3.5*a*-*c*)

Note that there is no baroclinic torque for the $\omega_z \equiv \omega_1$ component. Generation of that component is produced only by vortex stretching and tilting. For our initial condition, which is primarily a spherical distribution, there is little early production of ω_r , and it remains relatively small throughout the simulation since the thermal remains approximately azimuthally symmetric. The main baroclinic production is given by τ_{ϕ} which drives the creation of ω_{ϕ} .




FIGURE 8. Contour plots of ω_{ϕ} in the $x_3 = 0$ plane for the VT with Re = 500: (a) ω_{ϕ} at t = 15 and (b) ω_{ϕ} at t = 20. Red/blue contours represent positive/negative values. The contour level increment is $\Delta = 0.125$.

We start with a spherical vortex blob of θ . Then the negative radial gradients of θ generate the positive baroclinic torque τ_{ϕ} that generates the vortex ring of positive ω_{ϕ} . The advection by the ring forces the blob into a 'doughnut' shape, as we see in figure 1(*a*), and self-advection propels the ring vertically upward. Figure 8 shows the distribution of ω_{ϕ} in the case Re = 500 at times t = 15 and t = 20. Note that for both times there are regions of negative (blue) ω_{ϕ} . These were created by baroclinic torque just as was the primary vortex ring. Once the distribution of θ has taken on the shape of a doughnut, there is a positive radial gradient of θ on the inner side (i.e. 'hole' side) of the doughnut ring. The positive radial gradient generates negative baroclinic torque and thus negative ω_{ϕ} , as we see just beginning in figure 8(*a*) at t = 15. From t = 15 to t = 20 the patches of negative ω_{ϕ} are further amplified by baroclinic torque and also advected by the primary vortex ring leading to the distribution in figure 8(*b*) at t = 20. A similar thing happens in the upper part of the tail of the thermal as we also see in this figure.




FIGURE 9. Contour plots at t = 15 for the VT with Re = 500 (*a*–*d*) and Re = 5000 (*e*–*h*). The contour plots are made in the x_2-x_3 plane at the height x_1 where the maximum θ is located at that time. Each axis runs from -3 to +3 and is divided into ten uniform intervals. Red/blue contours represent positive/negative values. The ranges of values are: (*a*) $\theta \in [0, 0.31]$; (*b*) $\omega_r \in [-0.60, 0.58]$; (*c*) $\omega_{\phi} \in [-0.3, +5.7]$; (*d*) $\omega_1 \in [-1.37, +1.23]$; (*e*) $\theta \in [-0.05, 0.32]$; (*f*) $\omega_r \in [-33.3, 16.6]$; (*g*) $\omega_{\phi} \in [-30.2, +18.4]$; (*h*) $\omega_1 \in [-34.6, +30.3]$.

Figure 9(*a*–*d*) shows the contours of θ and the vorticity components, in the Re = 500 case, at t = 15 in the horizontal plane at the altitude where θ takes on its maximum value. From the extremal values given in the caption, we see that the magnitude of ω_{ϕ} is much larger than that of the other two components. The original spherical distribution of positive θ generated an annulus of positive ω_{ϕ} , a rising vortex ring that by t = 15 has entrained much of the buoyant fluid. At this stage, the distributions of ω_{ϕ} and θ are strikingly similar. This similarity is also well documented by Atkinson & Davidson (2019). Furthermore, they give a discussion of the generation of vorticity by baroclinic torque, and they describe in detail the early evolution of the laminar thermal as a process comprising three stages: buoyant blob; mushroom-like cap; and buoyant vortex ring. Finally, notice that figures 9(*a*) and 9(*c*) show a mode-2 azimuthal perturbation in both θ and ω_{ϕ} . This is the result of the Widnall instability that we discussed above.

The visualizations at Re = 5000 given in figure 9(e-h) confirm that at this Re we are dealing with a turbulent thermal. On a background of small-scale structures, there are large-scale clumps as in the thermals in figure 1(d) and in the visualizations in the laboratory experiment by Bond & Johari (2010). The baroclinic torque on the small-scale fluctuations of θ in figure 9(e) leads to the positive and negative fluctuations of ω_r in figure 9(f) and ω_{ϕ} in figure 9(g). Although there is no creation of ω_1 by baroclinic torque, the field in figure 9(h) is remarkably similar to that of ω_{ϕ} and ω_r . This isotropy of the vorticity components is a further proof that we are dealing with a turbulent thermal. Contour plots of the three components of velocity (not shown) in the case of Re = 5000 also provide interesting information. The field u_{ϕ} has a distribution very similar to the vorticity components shown here. Component u_1 has high positive values on the vertical axis of the thermal. The contours of u_r are primarily positive, corresponding to the radial spreading of the thermal.

3.7.2. Horizontal thermals

The evolution of the HT differs from that of the VT in some significant ways. In order to make a comparison between the spreading in the vertical and horizontal thermals, we P. Orlandi and G. F. Carnevale




FIGURE 10. Contour plots for the HT for Re = 500: (a) θ ; (b) ω_1 ; (c) θ ; (d) ω_2 ; (e) ω_3 ; (f) $P^*(x_2, t)$. The contour increment in (a-e) is $\Delta = 0.3$ and the time is t = 15. For (f), the increment is $\Delta P^* = 0.025$. The contour plots in (a,b,d,e) are made at the height of the point of maximum θ as indicated by the black dashed line in (c) showing the plane at $x_3 = 0$. (f) $P^*(x_2, t)$ defined in analogy with $P^*(r, t)$ shown in figure 5, with the average here performed in the x_3 direction with only the data for $x_2 > 0$ shown.

create a $P^*(x_2, t)$ in a manner analogous to that used in making $P^*(r, t)$ for the plots in figure 5. In place of the azimuthal average used in defining $P^*(r, t)$, here we have an average in the x_3 direction. Now we can compare figure 10(f) with figure 5(a), for the VT with Re = 500. We see that over the period 1 < t < 20 the HT makes far less upward progress compared to the VT. We also see that the HT spreads radially much more than the VT in that time. The main cause of this difference lies in the way the vertical and horizontal thermals first create vorticity from the original buoyancy distribution.

Due to the different geometries of the vorticity layer that is produced by baroclinic torque from the initial θ distribution, the rolling up of this layer in the spherical initial distribution case results in a vortex ring with a radius that is smaller than the distance between the two counter-rotating vortices produced by the cylindrical distribution. This results in a considerably higher vertical velocity in the ring case than in the dipolar case. We should also note that even if the radius of the ring and the distance between the two counter-rotating vortices in the dipole were the same, the structural difference results in a faster velocity for the vortex ring. The velocities of the dipole of separation 2R and the ring of radius R are

$$V_{dip} = \frac{\Gamma}{4\pi R}$$
 and $V_{ring} = \frac{\Gamma}{4\pi R} \left[\ln \frac{8R}{a} - \frac{1}{4} \right],$

where Γ is the circulation and *a* is the core radius of the ring or the radius of each vortex in the dipole. If we roughly estimate $a \approx R$ and assume the Γ is the same in both geometries, then we would have

$$rac{V_{ring}}{V_{dip}}pprox 2$$

So, we see that the geometry alone can be the cause of significant speed differences. Furthermore, the difference in the vertical velocity is continually enhanced because the HT spreads more rapidly than does the VT (see figure 2).

Consider the initial condition for the HT. The gradient of θ in the x_2 direction is greater than that in the x_3 direction. As a consequence, the baroclinic generation of vorticity is larger in the ω_3 component than in the ω_2 component. Furthermore, as discussed above, there can be no baroclinic generation of ω_1 . In figure 10, we show the contour plots at t = 15 for each component of vorticity. Although there is no baroclinic generation of ω_1 , we see that that component is very similar in amplitude and form to the component ω_2 . That suggests that at this point in the evolution, stretching and tilting are dominant in forming the small-scale structures that we see, although baroclinic production remains active. Looking at the component ω_3 we see the pattern of fluctuations that is typical of the small-scale cooperative instability familiar in contrails following aircraft. The general impression drawn from these visualizations is that this flow is in a transitional rather than a turbulent regime, which is very different from the case depicted in figure 9 of the VT at Re = 5000.

4. Interaction with a thermocline

4.1. Thermocline

In a series of experiments, Richards (1961) explored the effect of a thermocline in changing the evolution of a VT. The experiments involved releasing a mass of dense fluid into a freshwater layer lying over a denser salty layer. A simple rule was developed for determining under what conditions a thermal is strong enough to penetrate through the layer and continue to fall indefinitely, or so weak that it cannot penetrate at all. Here, we examine the interaction of both vertical and horizontal thermals with a thermocline. Our goal is to illustrate the type of vortex structures that are produced by the interaction. We will consider only weak thermals, that is, thermals that do not penetrate the thermocline, since in that case the production of the secondary vortex structures that we want to consider is most pronounced. Our focus is on the Re = 500 case so that the essential vortex dynamics of the interaction will not be obscured by the generation of small scales as is the case at higher Re. The results will provide the kind of information about the vortex dynamics of the interaction that is difficult to obtain from laboratory experiments. For these simulations, the initial conditions are the same as in the previous simulations. The only thing that has changed is that we have placed a thermocline in the path of the thermal.

The thermocline that we use is a transition layer with a hyperbolic tangent profile connecting two uniform layers:

$$\theta_0 = \theta_L + \frac{\Delta\theta}{2} \left(1 + \tanh \frac{x_1 - x_c}{D} \right), \tag{4.1}$$

where $\Delta \theta \equiv \theta_H - \theta_L$. The centre of the thermocline is defined by x_c and the vertical thickness of the thermocline is controlled by D. In the simulations presented below, we set $\Delta \theta = 1.2$, a value sufficiently high to make the temperature in the upper layer hotter than that in the unperturbed blob, thus making penetration into the upper layer minimal. We set the centre of the thermocline at $x_c = 12$ and take take D = 2/3, making the thermocline temperature gradient strongest in the region from $x_1 = 11$ to $x_1 = 13$. With these settings, the gradient $d\theta_0/dx_1$ in the middle of the thermocline is 0.9. Therefore, the maximum of the Brunt–Väisälä frequency $N_{max} = \max \sqrt{d\theta_0/dx_1}$ is approximately 0.95, corresponding to an oscillation period of approximately $T_{min} = 6.6$. In a background stratification of uniform density gradient, this would be the shortest period possible for an internal gravity wave. As previously, the Gaussian blob is initially centred at $x_1 = 3$, putting it at 9 units (that is $9R_0$, dimensionally) below the centre of the thermocline.

4.2. Vertical thermal blocked by a strong thermocline




FIGURE 11. Contours of the total temperature $\theta_T = \theta_0 + \theta$ at t = 15 in the $x_1 - x_2$ plane at $x_3 = 0$. Contour increments are $\Delta = 0.05$.

We begin with the case of the VT. The total temperature $\theta_T \equiv \theta + \theta_0$ at t = 15 is plotted in figure 11 in the case with Re = 500. At this time, the head of the VT is embedded in the thermocline and is strongly distorting it. Along the vertical axis of the thermal, the relatively cooler fluid at the bottom of the thermocline has been pushed upward toward the hotter levels above, creating a cap of high gradient of θ_T . To the right and left of the central vertical axis of the thermal, we see the closed circular contours of θ_T that identify the vortex ring that has driven the thermal into the thermocline. Just to the right and left of this vortex ring, the stratified fluid of the thermocline is being pulled downward and is being wrapped around the vortex ring. The net effect is an arc of high gradient of θ_T on top of and surrounding the vortex ring.




FIGURE 12. The collision of the VT with the thermocline for the case Re = 500. Contours of ω_{ϕ} with increments $\Delta = 0.5$ (red, positive; blue, negative): (a) ω_{ϕ} at t = 15; (b) ω_{ϕ} at t = 16; (c) ω_{ϕ} at t = 17; (d) ω_{ϕ} at t = 20. The horizontal green lines are drawn at $x_1 = 11$ and $x_1 = 13$ to indicate the approximate vertical extent of the thermocline centred at $x_1 = 12$. The grey line indicates the line r = 0 in cylindrical coordinates. It is also the vertical axis of the thermal.

As the thermal continues to impinge on the thermocline, an interesting sequence of vortex dynamics occurs. From t = 15 to t = 20, there is repeated generation of secondary vorticity structures that interact with the original, that is primary, vortex ring and with the other secondary vortex structures in such a way as to break up and disperse the thermal horizontally. This sequence of vortex events is illustrated by the contour plots of ω_{ϕ} shown in figure 12. We have seen in figure 11 that when the thermal encounters the thermocline, the contours of θ_T are bent around the primary vortex ring. At the left and right edges of the primary vortex ring, this produces strong horizontal, in other words radial, gradients

of θ . The strong positive radial gradient $\partial \theta / \partial r$ implies a negative baroclinic torque, which creates the negative (blue) layer of azimuthal vorticity ω_{ϕ} on the outside of the vortex ring, as seen in in figure 12(*a*). In this plot, the circulation is clockwise/counterclockwise around a region of negative (blue) ω_{ϕ} located on the left/right side of the vertical axis of the thermal. Thus, the negative (blue) ω_{ϕ} bent around the vortex ring in figure 12(*a*) opposes upward vertical motion along the vertical axis and in so doing brings the thermal's rise to a halt.

Furthermore, in figure 12(a), we see that the lower part of the region of negative ω_{ϕ} has begun to roll up into a circular vortex structure on both the left and right side of the thermal. These negative (blue) ω_{ϕ} circular regions then begin to interact strongly with the positive (red) vorticity in the tail of the thermal as we see at t = 16 in figure 12(b). By t = 17, the secondary negative vorticity, located below the lower green line in the figure, has essentially separated from the region of negative vorticity lying above the primary (red) vortex ring, and is causing the vorticity in the tail of the thermal to roll up as we see in figure 12(c). This interaction has produced, in the area below the lower green line, two dipole structures, one to the left and one to the right of the central vertical axis of the thermal. At the same time, this figure shows that the remaining part of the negative (blue) ω_{ϕ} has begun to roll up near the primary vortex ring (red), leading to the creation of two dipolar structures just above the lower green line, again one to the left and one to the right of the central vertical axis of the thermal. Such dipolar structures move by self-advection. Consider for example, the rightmost dipolar structure in figure 12(c). The positive/negative ω_{ϕ} in that dipole causes clockwise/counterclockwise motion around itself. Thus the positive part of the dipole propels the negative part to the right and downward and the negative part propels the positive part in that same direction. Hence, this dipolar structure will move off as a whole downward to the right. The result of this self-propagation of the dipolar structures is seen at t = 20 in figure 12(d). The four dipolar structures discussed in relation to figure 12(c) have separated as they moved away from the central vertical axis of the thermal. Each circular vortex structure in each of these dipoles in the full three-dimensional field is just the cross-section of a vortex ring that encircles the central vertical axis of the thermal. As the dipoles move laterally away from the vertical axis of the thermal, the diameter of the rings that make them up increases and the cross-sectional area of those rings decreases to conserve circulation. Thus, the cross-sectional size of the vortices making up the dipoles shrinks, at least until long-term viscous effects eventually dominate. Also, we note that new vortex structures continue

to be generated by baroclinic torque and that the interaction of all the different vortex structures in the field creates strain on each of the structures that tends to shear them out and break them up during the lateral spreading of the thermal. This interaction has similarities with that described by Orlandi & Verzicco (1993) of vortex rings impinging solid (i.e. no-slip) walls, which involves the creation of vorticity patches on a wide range of scales leading to a rapid destruction of the initial ring vortex structure. In that case, the secondary vorticity is not created by baroclinic torque, but rather by the no-slip condition at the wall. This process also has similarities to the vortex dynamics observed in the inertial instability of vortices (see e.g. Kloosterziel, Carnevale & Orlandi 2007).

Another important point to make is that the induced motion created by the dipoles discussed above results in a wave that propagates outward from the vertical axis of the thermal on the isolevels of θ_T in the thermocline. The obvious effect of the four main dipoles seen in figure 12 is to advect fluid downward and laterally away from the vertical axis of the thermal. A more subtle effect is that between these dipoles the induced flow is upward. For example, the space between the two dipoles lying below the green line on the right-hand side of the vertical axis of the thermal is bounded by a positive (red) vortex on the right and a negative (blue) vortex on the left. The circulation around both of these vortices is such as to advect the fluid between them upwards and towards the vertical axis of the thermal. A similar argument can be made for the pair of dipoles to the left of the vertical axis of the thermal and just below the lower green horizontal line: one dipole just to the left of the




FIGURE 13. The collision of the VT with the thermocline for the case Re = 500. Contours of θ with increments $\Delta = 0.025$ (red, positive; blue, negative): (a) θ at t = 15; (b) θ at t = 16; (c) θ at t = 17; (d) θ at t = 20. The horizontal green lines are drawn at $x_1 = 11$ and $x_1 = 13$ to indicate the approximate vertical extent of the thermocline centred at $x_1 = 12$.

vertical axis, the other just to the right. The space between these two dipoles is bounded by a positive vortex on the right and a positive vortex on the left (in other words by the two opposing sides of a secondary positive vortex ring that we see here in cross-section). The induced flow, as with the original primary vortex ring, is upward along the axis of the thermal. The combined action of all these updrafts and downdrafts will create an outwardly propagating wave on the isosurfaces of θ_T in the thermocline. It is interesting from this point of view to see the association of downward-propagating dipoles with the troughs of the wave and the upward-travelling tail ends of the dipoles with the peaks.

The effect of the vortex interactions discussed above on the distribution of θ is illustrated in figure 13. The sequence of times in this figure is the same as in figure 12. In figure 13(*a*), we see the large central dome of negative θ that results from the action of the primary vortex ring pushing fluid up along the r = 0 axis. The layer of negative ω_{ϕ} generated by baroclinic torque that is seen in figure 12(*a*) has a circulation that tends to force flow in the downward direction along the r = 0 axis. This then drives the fluid back down along that axis, and by t = 20 we see that in figure 13(*d*) the sign of θ above the thermal has reversed. We also see in that figure that the four main dipoles discussed in figure 12(*d*) are transporting relatively warm fluid into the lower layer. In the negative (blue) layer of θ just above the lower green line, we see the wave-like effect of the alternating updrafts and downdrafts associated with the dipoles as discussed above.




FIGURE 14. The interaction of a VT with a thermocline for the case Re = 500. Contours of θ (in the x_2 - x_3 plane at $x_1 = 12$) with increments $\Delta \theta = 0.025$ (red, positive; blue, negative): (a) θ at t = 15; (b) θ at t = 17; (c) θ at t = 18; (d) θ at t = 20.

The radial propagation of the wave in the thermocline can be better appreciated in the contour plots of θ plotted in the horizontal plane at $x_1 = 12$, that is, in the (x_2-x_3) plane lying in the centre of the thermocline, as shown in figure 14. The sequence of times

shown is not the same as in figures 12 and 13, but was chosen to give a better idea of the propagation of the wave in the middle of the thermocline. When the head of the thermal has just penetrated into the thermocline, the extent of the perturbation of θ is relatively compact radially (see figure 14*a*), and the pattern is relatively simple mainly showing negative θ in the central region surrounded by positive θ . By time t = 20 the sign of theta in the centre has reversed and the central region is now surrounded, more or less, by two annuli of alternating sign.




FIGURE 15. Waves produced on the thermocline during the collision of the VT in the case without initial random perturbations for (a) Re = 500 and (b) Re = 1000. Values of θ on the line passing through the point ($x_1 = 12, x_3 = 0$) in the x_2 direction for nine different times from t = 14 to t = 30 with $\Delta t = 2$ between each curve. The value of θ is incremented by 0.5 in going from one curve to the next in this sequence of times.

The form and progress of the wave may be more easily assessed quantitatively in a plot of θ on a horizontal line in the middle of the thermocline (i.e. at height $x_1 = 12$). In order to show the propagation of the wave without distortions triggered by an initial random disturbance, the data shown in figure 15 were produced from simulations that used the Gaussian initial condition with no added random perturbations. We show results for both the Re = 500 and the Re = 1000 cases. Considering the Re = 500 case, we see that at t = 14, the perturbation mainly consists of a negative region confined between $x_2 = -2$ and $x_2 = +2$. By t = 30, the wave occupies the entire domain $-6 \le x_2 \le +6$. Note also

that the sign of θ in the central region reverses three times in the interval $14 \le t \le 30$, representing approximately one-and-a-half cycles of oscillation. The sequence is similar for the Re = 1000 case except that there are four reversals in the oscillation of the sign of θ in the central region. The wave periods represented by these two cases are respectively $T_{\Omega} \approx 10.7$ and $T_{\Omega} \approx 8$. Observation of a longer period of oscillation in both cases would be necessary to make these estimates more precise, but this was not possible given the limits imposed by the domain size. Both of these periods are longer than the minimum internal wave period $T_{min} = 6.6$ based on the Brunt–Väisälä frequency $N(x_1)$ in the middle of the thermocline, as discussed in § 4.1.

In an axisymmetric study of VTs, Lane (2008) investigated the collision of a VT with a thermocline. He too observed the oscillation in the sign of the central region and identified the basic mechanism involving generation of opposite signed vorticity by baroclinic torque that we discussed above. His results also show multiple small-scale structures including dipoles that form in the thermocline as the wave propagates away from the thermal. The work presented here goes beyond that by examining the fully three-dimensional case of the impact of the VT with the thermocline and examining in detail the dynamics of the dipoles formed during the collision.

Note that in figure 15 there is much more fine-scale structure on the curves in the Re = 1000 case than in the Re = 500 case. For the case with random initial perturbations added to the Gaussian, there is even more small-scale structure than in the smooth initial condition case, as one would expect. We have run such a case at Re = 1000 and present the results here for the time t = 20 in figure 16. The contour plots in the cross-sections shown in figure 16(a-c) can be compared directly to their counterparts at Re = 500 in figures 12(d), 13(d) and 14(d). Given the complexity of the plots in the Re = 1000 case, one can appreciate how difficult it would be to follow the details of the vortex dynamics and wave generation and propagation at that or higher Re. Thus, most of what we have done in this section has focused on the Re = 500 case.

4.3. Horizontal thermal collides with a strong thermocline




FIGURE 17. The interaction of a HT with a thermocline for the case Re = 500. The thermocline extends approximately from $x_1 = 11$ to $x_1 = 13$. Contours of ω_3 are shown with increments $\Delta \omega_{\phi} = 0.2$ (red, positive; blue, negative): (a) ω_3 , HT without thermocline, t = 20; (b) ω_3 , HT without thermocline, t = 30; (c) ω_3 , HT with thermocline, t = 20; (d) ω_3 , HT with thermocline, t = 30.

In figure 17, we show the evolution of the vorticity field for the case of the HT, with and without the thermocline. The vorticity component ω_3 for the case without a thermocline




FIGURE 16. The VT collides with the thermocline in the case Re = 1000: (a) ω_{ϕ} at t = 20 in the x_2-x_1 plane at $x_3 = 0$ (contour increments are $\Delta = 0.25$); (b) θ at t = 20 in the x_2-x_1 plane at $x_3 = 0$ (contour increments are $\Delta = 0.5$); (c) θ at t = 20 in the x_2-x_3 plane at $x_1 = 12$ (contour increments are $\Delta = 0.025$). Red/blue contours indicate positive/negative values. The horizontal green lines in (a,b) are drawn at $x_1 = 11$ and $x_1 = 13$ to indicate the approximate vertical extent of the thermocline centred at $x_1 = 12$.

at t = 20 is shown in 17(*a*). Interestingly, we see that even in a region with no background stratification, there is the development of thin layers with alternating sign of ω_3 near each of the two primary vortices of the vortex dipole. This is related to a similar effect seen above in the case of the VT and discussed in relation to figure 8, and can similarly be explained here in terms of generation of vorticity by baroclinic torque and subsequent advection of that vorticity. In the initial condition, we began with one horizontal tube of hot fluid. Baroclinic torque, stemming from the horizontal gradient of θ , then created two primary opposite-signed vortex tubes, one on each side (right and left) of the original column of hot fluid. That dipolar vortex structure then divided the original column of

hot fluid into two horizontal columns of hot fluid. To the right and left of each of these daughter columns, vorticity will be produced again via baroclinic torque. On one side of each, the vorticity will be of the same sign as in the core and simply add to it, while on the other it will have the opposite sign. That opposite signed vorticity will be advected around the primary vortex closest to it creating those layers of opposite sign seen in figure 17(a,b).

For the case with thermocline shown in figure 17(c,d), the interaction of the HT with the thermocline appears retarded with respect to that shown for the VT case in figure 12(b,c). This is a result of the relatively slow propagation of the HT and the large separation between the primary vortices by the time they collide with the thermocline. In figure 17(d), at t = 30, the same process appears at work that was already evident at t = 15 in the VT case. Unlike the evolution in the VT case, here the opposite signed vorticity produced above each primary vortex joins with that primary vortex to produce a large-scale dipole that does not break up into smaller dipoles. The pair of dipoles that result here are oriented so as to propagate horizontally away from each other. Note that in this right-handed system, the x_3 axis is into the page, and, therefore, the circulation around positive/negative (i.e. red/blue) ω_3 in the figure is clockwise/counterclockwise. By t = 30, the dipoles are moving away from the thermocline, each following an arc determined by the relative




FIGURE 18. Results at t = 20 and t = 30 from the thermocline penetration experiment for a HT with Re = 500. The plots show both the total temperature $\theta_T = \theta + \theta_0$ and the temperature perturbation θ . Contour increments are $\Delta = 0.01$: red, positive; blue, negative. The fields are shown in the x_1-x_2 plane at $x_3 = 0$: (a) θ_T at t = 20; (b) θ at t = 20; (c) θ_T at t = 30; (d) θ at t = 30.

strength found in the primary and secondary vortices. This scenario is very similar to that in the collision of a dipole with a no-slip wall (see e.g. Orlandi 1990). In that case, the secondary vorticity is created by the roll-up of the viscous boundary layer, in contrast to this case where it is produced by baroclinic torque. Another very analogous case is given in Carnevale, Velasco Fuentes & Orlandi (1997) where we see a dipole collide with a free-slip wall, but with secondary vorticity produced by topographic stretching. Independent of the method of secondary vorticity production, the trajectories of the vortices are very similar in each of these scenarios.

The contour plots of θ_T and θ for the HT collision with the thermocline are shown in figure 18. The plots of θ_T (figure 18*a*,*c*) nicely illustrate the degree to which the thermocline is perturbed in this case. These can be compared with the plot of θ_T in the VT case shown in figure 11. Clearly the penetration is shallower and much delayed in the HT case. We will not go into detail about the way this collision initiates an internal wave on the thermocline as we did in the VT case. We will, however, note that in figure 18(*b*), on the horizontal line at $x_1 = 12$, going from left to right one sees four reversals in the sign of θ . Furthermore, the sign of θ at $x_2 = 0$ on this line reverses by t = 30 as seen in figure 18(*d*).

4.4. Evolution of q_i and Θ with thermocline: VT and HT

In the presence of stratification, in the Boussinesq approximation, the potential energy of the flow is given by

$$PE = \frac{1}{2} \int \frac{\theta^2}{N^2} \, \mathrm{d}x_1 \, \mathrm{d}x_2 \, \mathrm{d}x_3. \tag{4.2}$$

The inviscid conservation kinetic energy $q_1 + q_2 + q_3$ plus this potential energy can be confirmed using (2.3), (2.4) and (2.5). Although the variance Θ is not equivalent to potential energy, it behaves somewhat analogously because its sources B_1 and S_{θ} in (3.3) and (3.4) are similar to those that drive changes in the potential energy.

Figure 19(a) shows the evolution of the kinetic energy components q_1 and $q_2 + q_3$, and Θ (green curves) for the VT encountering the thermocline. These can be compared to the corresponding curves from the unstratified case (red curves). In the early development of the thermal, before it encounters the thermocline, roughly before $t \approx 8$, the behaviour of q_i and Θ is very similar to that in the simulation without the thermocline. As the vortex ring encounters the thermocline, the thermocline is pushed up increasing Θ . The thermal responds by slowing. The simultaneous increase of kinetic energy (particularly the q_1 component) and decrease of Θ is clear for the period 9 < t < 14. After $t \approx 10$, there is an oscillation in the green curves in figure 19(a). This oscillation is more clearly evident in the black curves in figure 19(*c*,*e*). The period of the oscillation is $\Delta t \approx 7$. This is consistent with internal waves since it is longer than the minimum period $T_{min} = 6.6$ for internal waves on our thermocline, as we noted in § 4.1. This oscillation seems distinct from that which is evident before $t \approx 10$ on say the P_1 (blue) curve in figure 19(e). That earlier oscillation has a period of $\Delta t \approx 4$ which is similar to what we saw in the early phase of the evolution of the thermal in the unstratified case (see figure 7*d*). If our estimate for the minimum period for an internal wave based on the maximum value of N in the thermocline is valid, this shorter-period oscillation before $t \approx 10$ is unrelated to internal wave activity.

In figure 19(c), the evolution is dominated by the variation of the curves after time t = 10. This contrasts with the behaviour in the unstratified flow (see the corresponding figure 7b) where the evolution before t = 10 dominated. But note that the amplitude of the variations in the unstratified case were more than 30 times smaller than in this case with thermocline. The early variations before t = 10 are not appreciable on the scale of figure 19(c). In this figure, the large and rapid increase in $S_{\theta} \equiv -\overline{u_1 \theta} \, d\theta_0 / dx_1$, starting around t = 10, corresponds to the rise of Θ seen in figure 19(a). The subsequent plunge of S_{θ} to very negative values makes it much more important than the dissipation D_{θ} in bringing Θ rapidly down again.

For the HT case shown in figure 19(*b*), we ran the simulation to t = 45, much longer than in the VT case, because the HT rises more slowly, as already discussed. Note that the scale of the vertical axis in 19(*b*) is about a factor of 10 larger than in 19(*a*). This is due to the increase in energy of the HT with its extension in the x_3 direction. So, here we focus only on the relative changes. Note that Θ does not have a rapid period of growth in this case as opposed to the VT case. This is because the HT does not penetrate as far into the thermocline as the VT and thus does not push the isopycnals as far up.

Next consider figure 19(d) showing the production terms for Θ in the HT case. Note that the vertical scale of figure 19(d) is smaller than that of figure 19(c), corresponding to the shallowness of the penetration of the HT into the thermocline compared to the VT case. After $t \approx 10$, the relative balance between dissipation D_{θ} (red curve) and S_{θ} (green curve) results in the total $d\Theta/dt$ (black curve) remaining relatively small and the size of Θ after $t \approx 10$ remaining relatively constant (see figure 19b). Finally, note that the period




FIGURE 19. Evolution of q_1 , $q_2 + q_3$ and Θ and their source terms for Re = 500: (a) Vertical thermals: top two curves, q_1 ; middle two curves, $q_2 + q_3$; bottom two curves, Θ (green, with thermocline; red, no thermocline). (b) Horizontal thermals: top two curves, q_1 ; middle two curves, $q_2 + q_3$; bottom two curves, Θ (green, with thermocline; red, no thermocline). (c) Vertical thermal with thermocline: $d\Theta/dt = S_{\theta} + D_{\theta}$, black; S_{θ} , green; D_{θ} , red. (d) Horizontal thermal with thermocline: $d\Theta/dt = S_{\theta} + D_{\theta}$, black; S_{θ} , green; D_{θ} , red. (e) Vertical thermal with thermocline: $d\Theta/dt = S_{\theta} + D_{\theta}$, black; S_{θ} , green; D_{θ} , red. (f) Horizontal thermal with thermocline: $dq_1/dt = B_1 + P_1 + D_1$, black; B_1 , green; P_1 blue; D_1 , red.

of oscillation in S_{θ} is $\Delta t \approx 15$ which is about double that in the VT case. It is not clear to us why there is this difference in period. It may be related to the size and shape of the thermal when it hits the thermocline since that would affect the wavelengths excited. For horizontally propagating internal waves on a uniform background gradient of temperature (i.e. a background of uniform N), the frequency would be N, independent of wavelength. We are not aware of any analytical studies of wave propagation on a hyperbolic tangent thermocline, so we can only speculate at this point that the frequency difference is an effect of the different wavelengths and/or symmetry of the waves.

The budgets for q_1 in figure 19(e,f) are more complex than their counterparts for the evolution of Θ . It seems the generation term P_1 (blue) is forced into an oscillation 180° out of phase with B_1 (green). The oscillations of B_1 during the strong interaction of the VT after $t \approx 10$ with a period longer than T_{min} are consistent with internal waves. Since we have seen that oscillations in the kinetic energy production terms can occur even in the case with no thermocline, even while the kinetic energy is monotonically increasing (see figure 7), we can only say here that the oscillations in the case with thermocline are consistent with internal waves and with the evidence of waves that we presented above in the form of contour plots and graphs of vorticity and θ within the thermocline. Note also that the strongly negative P_1 (blue) in figure 19(f) at $t \approx 15$ finally overcomes the positive production B_1 (green) to force the decay of q_1 from its peak in figure 19(b) in the stratified case (green line) compared to the neutral environment case (red line). However, the continued decay of q_1 after $t \approx 23$, after which $P_1 \approx 0$, is due to B_1 turning negative as well as the effect of the uniformly negative D_1 (red).

Internal wave radiation away from the site of the collision of the thermal with the thermocline on an infinite domain would show up as a loss of energy from the local interaction volume. We could not, however, quantify this kind of loss of energy because this would require developing a numerical scheme with some sort of *ad hoc* radiation condition or sponge layer at the boundaries of the domain. This is left for possible future exploration.

5. Conclusion

We have presented results from three-dimensional simulations of the evolution of vertical and horizontal thermals. We have demonstrated that in the parameter range from Re = 500 to Re = 5000, the structure of the well-developed VT goes from nearly laminar to turbulent.

We have shown that the height of the VT at a given time decreases with increasing Re for sufficiently large Re. This is just the opposite tendency that has been observed and proven analytically for the laminar thermal (Atkinson & Davidson 2019). We have shown the transition of these trends from the laminar to the turbulent in a graph of the total height travelled in a given time versus Re. We found that the point of transition depends on the level of random perturbation or 'noise' present in the initial condition of the thermal, the transition Re increasing with decreasing initial noise.

We have made a detailed comparison between the evolution of horizontal and vertical thermals, albeit at a relatively low Re, but one high enough to allow us to discuss some of the important instabilities that become much more pronounced for higher Re. It is especially noteworthy that even at low Re, we clearly see the short-wave instability that is so important in the evolution of contrails.

In our investigation of the vortex dynamics involved in the interaction of a thermal with a thermocline, we have examined the evolution of the vortex structures involved in the dispersal of thermals too weak to penetrate through the thermocline. We have offered an explanation of how these structures are formed by the action of baroclinic torque. In the VT case, we have shown how some of these structures combine to form relatively small compact vortex dipoles (in a cross-sectional view) that, self-propelled, move laterally away

from the head of the thermal. The subsequent outward motion of these dipoles and the resultant stretching of vortex sheets connecting them result in the horizontal shearing out of the head of the blocked thermal. We examined the internal wave on the isopycnals in the thermocline that results from the impact of the thermal. We have seen that the dipoles created during the interaction of thermal and thermocline are related to the formation and propagation of the wave, with downward/upward moving dipoles being found in the troughs/peaks of the wave. We have also shown, in the case of a HT that becomes blocked on the lower side of a thermocline, that the vortex dynamics of the interaction looks very much like that of the collision of a vortex dipole with a no-slip wall.
