THE COMPLETE CARIBBEANA 1900-1975: A BIBLIOGRAPHIC GUIDE TO THE SCHOLARLY LITERATURE

The **Complete Caribbeana** is a four-volume bibliography containing over 17,000 articles, books, reports and doctoral dissertations published in the twentieth century. The geographical areas covered include Surinam, French Guiana, Guyana, Belize, Bermuda, the Bahamas, and all nations, associated states, and colonies of the Greater and Lesser Antilles, with the exception of Haiti and the Spanish-speaking territories.

The organization of the bibliography is topical; titles appear in more than one subject category when appropriate. In addition to complete bibliographic information, each entry contains a geographic designation and a code indicating the library in which the cited material can be found. Citations of material in foreign languages include an English translation of the title. Two indices are provided—an author index and a geographical index. This bibliography supersedes Professor Comitas' one volume **Caribbeana 1900-1965: A Topical Bibliography**.

MIGRATION AND ADAPTATION

Tzintzuntzan Peasants in Mexico City

by **ROBERT V. KEMPER**, *Southern Methodist University*

A new study presenting a description and analysis of rural migrants and their adaptation to life in a rapidly growing metropolitan setting, this volume deals with a microcosm of Mexican urbanization: emigration from the traditional peasant village of Tzintzuntzan, Michoacan to Mexico City. Professor Kemper reports on the background of the migrants as well as on their cultural and social adjustments to an urban environment. A model of rural-urban migration applicable to similar populations in other developing nations is also presented and will be of interest to anthropologists and urban specialists involved in a variety of disciplines.
