The vanishing cycles of curves in toric surfaces I

Rémi Crétois and Lionel Lang

ABSTRACT

This article is the first in a series of two in which we study the vanishing cycles of curves in toric surfaces. We give a list of possible obstructions to contract vanishing cycles within a given complete linear system. Using tropical means, we show that any non-separating simple closed curve is a vanishing cycle whenever none of the listed obstructions appears.

1. Introduction

Along a degeneration of a smooth algebraic curve C to a nodal curve, there is a simple closed curve in C that gets contracted to the nodal point. This simple closed curve, well-defined up to isotopy, is called the vanishing cycle of the degeneration.

If the question of contracting simple closed curves abstractly in $\overline{\mathcal{M}}_g$ leaves no mystery, the embedded case is still open. In particular, we may ask what are the possible vanishing cycles of a curve C embedded in a toric surface X , where the underlying degenerations are constrained in a fixed complete linear system $|\mathcal{L}|$ on X . As simply as it is stated, this question, suggested by Donaldson [Don00], admits no definitive answer. Another approach is to study the monodromy map from the fundamental group of the complement of the discriminant $\mathcal{D} \subset |\mathcal{L}|$ to the mapping class group $\text{MCG}(C)$. The study of such fundamental groups was suggested by Dolgachev and Libgober [DL81] and is still an active field of investigation (see, for example, [Lön09]). From a wider perspective, the description of the monodromy map gives an insight into the universal map $|\mathcal{L}| \setminus \mathcal{D} \rightarrow \mathcal{M}_g$ which is far from being understood (see e.g. [CV09]).

We know from [Waj77] that, for a smooth plane curve C of genus g , we can contract $2g$ simple closed curves whose complement in C is a disc. It leads in particular to the topological

classification of smooth projective surfaces in $\mathbb{C}P^3$ given in [MM76]. In [Bea86], Beauville determines the image of the algebraic monodromy map for hypersurfaces of degree d in $\mathbb{C}P^m$, for any m and d .

In this paper, we focus on the case of curves but investigate any complete linear system $|\mathcal{L}|$ on any smooth toric surface X . We point out the obstructions to contracting cycles in the curve C . They mainly arise from the roots of the adjoint line bundle $K_X \otimes \mathcal{L}$. Square roots of $K_X \otimes \mathcal{L}$ were already considered in [Bea86]. The obstructions provided by higher-order roots of $K_X \otimes \mathcal{L}$ were studied in [ES91] and [Sip82] but were somehow forgotten in the common literature until recently. In particular, they do not show up in the work of Beauville [Bea86] as the obstructions they provide are undetectable at the homological level. It might also happen that all the curves in $|\mathcal{L}|$ are hyperelliptic. In such a case, the monodromy map has to preserve the hyperelliptic involution.

We show that there are no other obstructions than the ones mentioned above.

THEOREM 1. *Let X be a smooth complete toric surface, \mathcal{L} an ample line bundle on X and $C \in |\mathcal{L}|$ a generic smooth curve. Then, the monodromy map*

$$\mu : \pi_1(|\mathcal{L}| \setminus \mathcal{D}) \rightarrow \text{MCG}(C)$$

is surjective if and only if C is not hyperelliptic and if the adjoint line bundle of \mathcal{L} admits no root. In this case, any non-separating simple closed curve in C is a vanishing cycle.

Let us mention, on the one hand, a very recent independent work by Salter [Sal16], in which he proves this result in the particular case of $\mathbb{C}P^2$ and, on the other hand, a work by Bolognesi and Lönne [BL16] in which they prove this result in the case of ample linear systems of trisections on Hirzebruch surfaces.

As suggested by Beauville [Bea86], some of the latter obstructions persist in homology. In the following statement, $\text{Sp}(H_1(C, \mathbb{Z}))$ denotes the group of automorphisms preserving the intersection form.

THEOREM 2. *Let X be a smooth complete toric surface, \mathcal{L} an ample line bundle on X and $C \in |\mathcal{L}|$ a generic smooth curve. Then the algebraic monodromy map*

$$[\mu] : \pi_1(|\mathcal{L}| \setminus \mathcal{D}) \rightarrow \text{Sp}(H_1(C, \mathbb{Z}))$$

is surjective if and only if C is not hyperelliptic and if the adjoint line bundle of \mathcal{L} admits no root of even order. In this case, any non-separating simple closed curve in C is homologous to a vanishing cycle.

We introduce new techniques to determine the image of the monodromy map μ . We first use the intensively studied simple Harnack curves (see [Mik00, KO06]), for which all possible degenerations are known. From them, we then construct loops in $|\mathcal{L}| \setminus \mathcal{D}$ with explicit monodromy in $\text{MCG}(C)$ using tropical methods. With this aim, we consider partial phase-tropical compactifications of \mathcal{M}_g . According to [Lan15b], we have a proper understanding of the closure of $|\mathcal{L}| \setminus \mathcal{D}$ in this compactification in terms of Fenchel–Nielsen coordinates. Using these coordinates, we construct loops with prescribed monodromy in the closure. We then push these loops back to $|\mathcal{L}| \setminus \mathcal{D}$ with the help of Mikhalkin’s approximation theorem, see Theorem 5. The efficiency of such a technique suggests that the discriminant nicely intersects the boundary of a globally well-defined phase-tropical compactification of \mathcal{M}_g . It also has the advantage of being

explicit in the sense that we can actually draw the cycles that we can contract on our reference curve C .

In [CL17], we will use this technique further to determine the image of the (algebraic) monodromy in the hyperelliptic and spin cases. Motivated by these results and the constructions given in § 7.5, we give a conjecture about the image of μ in the general case (see Conjecture 1). In [Sal16], Salter proves this conjecture for degree 5 curves in $\mathbb{C}P^2$. Note that during a review of the present paper, Salter answered Donaldson’s question in the present context by proving Conjecture 1 in almost full generality, see [Sal17]. By introducing elegant techniques in mapping class group theory, he showed that the constructions of the present paper suffice to generate the whole group $\text{im}(\mu)$. Coming back to the broader question asked in [Don00], we believe that the tropical approach could be carried to the case of smooth surfaces in toric 3-folds. Another interesting and fundamental variation of the problem is the study of the contraction of cycles along degenerations of real curves.

This paper is organized as follows. In § 2, we introduce the obstructions and the main results more precisely. In § 3, we recall some basic facts about toric surfaces and how to detect the obstructions on a Newton polygon corresponding to the linear system. In § 4, we generalize some results of Kenyon and Okounkov [KO06] in order to produce our first vanishing cycles (see Theorem 3). Moreover, we provide a trivialization of the universal curve over the space of simple Harnack curves (see Proposition 4.6). It allows us to describe the vanishing cycles in a combinatorial fashion on the Newton polygon (see Corollary 4.7). In § 5, we use a 1-parameter version of Mikhalkin’s approximation theorem (see Theorem 5) to produce elements of $\text{im}(\mu)$ given as some particular weighted graphs in the Newton polygon. In § 6, we play with this combinatorics to prepare the proofs of Theorems 1 and 2, which we give in § 7. At the end of the paper, we motivate Conjecture 1 with some additional constructions.

2. Setting and statements

2.1 Setting

Let X be a smooth complete toric surface. Take an ample line bundle \mathcal{L} on X and denote by $|\mathcal{L}| = \mathbb{P}(H^0(X, \mathcal{L}))$ the complete linear system associated with it.

DEFINITION 2.1. The discriminant of the linear system $|\mathcal{L}|$ is the subset $\mathcal{D} \subset |\mathcal{L}|$ consisting of all the singular curves in $|\mathcal{L}|$.

Notice that since X is toric, \mathcal{L} is in fact very ample (see [Oda88, Corollary 2.15]) and the embedding of X in the dual $|\mathcal{L}|^*$ of the linear system identifies \mathcal{D} with the dual variety of X . In particular, we have the following classical facts.

PROPOSITION 2.2 [DIK00, § 6.5.1]. *If \mathcal{L} is an ample line bundle on a smooth complete toric surface X , then the discriminant \mathcal{D} is an irreducible subvariety of $|\mathcal{L}|$ of codimension at least 1. It is of codimension 1 if and only if there exists a curve in \mathcal{D} whose only singularity is a nodal point. In this case, the smooth set of \mathcal{D} is exactly the set of such curves.*

From now on, we will assume that the discriminant \mathcal{D} is a hypersurface in $|\mathcal{L}|$. Let $C' \in \mathcal{D}$ be a curve whose only singularity is a node, which we denote $p \in C' \subset X$. Then, from [ACG11, Proposition 2.1] we deduce that there exist a neighborhood $U \subset X$ of p and a neighborhood $B \subset |\mathcal{L}|$ of C' such that the restriction of the universal curve

$$\{(x, C) \in U \times B \mid x \in C\} \rightarrow B$$

is isomorphic to

$$\{(z, w, t_1, \dots, t_{\dim(|\mathcal{L}|)}) \in \mathbb{C}^2 \times \mathbb{C}^{\dim(|\mathcal{L}|)} \mid z^2 + w^2 = t_1\} \rightarrow \mathbb{C}^{\dim(|\mathcal{L}|)} \tag{1}$$

in a neighborhood of $(0, \dots, 0)$. The restriction of the previous map to the locus where $t_1 \neq 0$ and $z^2/t_1, w^2/t_1 \geq 0$ is fibered in circles whose radius goes to 0 as t_1 goes to 0.

Now take $C_0 \in |\mathcal{L}|$ a smooth curve and $\gamma : [0, 1] \rightarrow |\mathcal{L}|$ a smooth path, such that $\gamma(0) = C_0$ and $\gamma^{-1}(\mathcal{D}) = \{1\}$, with $\gamma(1) = C'$. We can find $\epsilon > 0$ such that $\gamma([1 - \epsilon, 1])$ is included in B . From Ehresmann’s theorem [Voi07a, Theorem 9.3], the universal curve over $|\mathcal{L}| \setminus \mathcal{D}$ is a smooth locally trivial fibration. In particular, we can trivialize its pullback to $[0, 1 - \epsilon]$ via γ . Using this trivialization and the local form of the universal curve over B , the circles obtained in the local form (1) of the universal curve induce a smooth simple closed curve δ on C_0 . The isotopy class of this curve does not depend on the choices made (see [ACG11, § 10.9]).

DEFINITION 2.3. We call the isotopy class of δ in C_0 a vanishing cycle of C_0 in the linear system $|\mathcal{L}|$.

The present paper is motivated by a question of Donaldson [Don00, Question 1], which we formulate as follows.

Question 1. Which isotopy classes of smooth simple closed curves on $C_0 \in |\mathcal{L}|$ are vanishing cycles in $|\mathcal{L}|$?

Starting from a vanishing cycle δ on C_0 , one can construct another one using the geometric monodromy map, which is defined as follows. Taking a path $\gamma : [0, 1] \rightarrow |\mathcal{L}| \setminus \mathcal{D}$ from C_0 to itself, the pullback of the universal curve over γ is trivializable and a choice of trivialization induces an orientation preserving diffeomorphism ϕ of C_0 . In fact, the class of ϕ in the mapping class group $\text{MCG}(C_0)$ of C_0 only depends on the homotopy class of γ . Thus, we obtain the geometric monodromy morphism

$$\mu : \pi_1(|\mathcal{L}| \setminus \mathcal{D}, C_0) \rightarrow \text{MCG}(C_0).$$

If δ is a vanishing cycle on C_0 , it follows from the definitions that for any element $\phi \in \text{im}(\mu)$, $\phi(\delta)$ is also a vanishing cycle. Moreover, the irreducibility of \mathcal{D} implies the following.

LEMMA 2.4 [Voi07b, Proposition 3.23]. *If δ is a vanishing cycle of C_0 in $|\mathcal{L}|$, then all the other vanishing cycles are obtained from δ under the action of the image of the geometric monodromy map. In particular, if δ and δ' are two vanishing cycles of C_0 in $|\mathcal{L}|$, then the pairs (C_0, δ) and (C_0, δ') are homeomorphic.*

For an ample line bundle \mathcal{L} , there always exists a non-separating vanishing cycle on C_0 as soon as the genus of C_0 is at least 1 (see Theorem 3). By non-separating we mean that the complement of the vanishing cycle in C_0 is connected. It then follows from Lemma 2.4 that all the other vanishing cycles have the same property. If \mathcal{I} denotes the set of isotopy classes of non-separating simple closed curves on C_0 , Question 1 now becomes: are all the elements of \mathcal{I} vanishing cycles?

In the converse spirit to Lemma 2.4, we can construct elements of the monodromy from vanishing cycles.

PROPOSITION 2.5 [ACG11, § 10.9]. *If a simple closed curve $\delta \in \mathcal{I}$ is a vanishing cycle in $|\mathcal{L}|$, then the Dehn twist τ_δ along δ is in the image of μ .*

The construction of an element $\ell \in \pi_1(|\mathcal{L}|\setminus\mathcal{D}, C_0)$ such that $\mu(\ell) = \tau_\delta$ is rather explicit. Since $\delta \in \mathcal{I}$ is a vanishing cycle, we can find a path $\gamma : [0, 1] \rightarrow |\mathcal{L}|$ joining C_0 to \mathcal{D} and defining δ . Then the loop ℓ is obtained from γ by replacing the end of γ itself with the boundary of a small disk transverse to \mathcal{D} , with appropriate orientation.

We do not know if the converse to Proposition 2.5 is true in general. However, Lemma 2.4 shows that if the geometric monodromy is surjective then all the elements of \mathcal{I} are vanishing cycles. Conversely, if all the elements of \mathcal{I} are vanishing cycles, the geometric monodromy is surjective since $\text{MCG}(C_0)$ is generated by the Dehn twists around the elements of \mathcal{I} , see, for example, [Hum79]. This suggests the following analogue to Question 1, which we will study in the rest of the paper.

Question 2. When is the geometric monodromy map μ surjective? More generally, describe the subgroup $\text{im}(\mu)$.

2.2 Roots of the canonical bundle and monodromy

In some cases, the smooth curves in $|\mathcal{L}|$ will inherit some geometric structure from the ambient toric surface. As a partial answer to Question 2, we will see how this structure might prevent the map μ from being surjective. To make this more precise, we introduce subgroups of the mapping class group which will come into play.

Let $\pi : \mathcal{C} \rightarrow B$ be a holomorphic family of compact Riemann surfaces of genus $g > 1$ and $n > 0$ be an integer that divides $2g - 2$. An n th root of the relative canonical bundle $K_{\text{rel}}(\mathcal{C})$ of \mathcal{C} is a holomorphic line bundle \mathcal{S} on \mathcal{C} , such that $\mathcal{S}^{\otimes n} = K_{\text{rel}}(\mathcal{C})$. Denote by $R_n(\mathcal{C})$ the set of n th roots of $K_{\text{rel}}(\mathcal{C})$. If the base B is a point, $R_n(\mathcal{C})$ is finite of order n^{2g} .

Choose a base point $b_0 \in B$, and let $C_0 = \pi^{-1}(b_0)$. On the one hand, there is a restriction map from $R_n(\mathcal{C})$ to $R_n(C_0)$; on the other hand, there is a monodromy morphism $\mu_{\mathcal{C}} : \pi_1(B, b_0) \rightarrow \text{MCG}(C_0)$, defined as in § 2.1. Recall from [Sip82, Corollary p. 73] that the group $\text{MCG}(C_0)$ acts on $R_n(C_0)$. Moreover, we have the following result.

PROPOSITION 2.6 [ES91, Theorem 2]. *If $\mathcal{S} \in R_n(\mathcal{C})$, then all the elements in $\text{im}(\mu_{\mathcal{C}})$ preserve $\mathcal{S}|_{C_0} \in R_n(C_0)$.*

If $S \in R_n(C_0)$, denote by $\text{MCG}(C_0, S)$ the subgroup of $\text{MCG}(C_0)$ that preserves S . It is a subgroup of finite index which is proper in general (see [Sip82]).

Coming back to our problem, we obtain the following.

PROPOSITION 2.7. *Let $|\mathcal{L}|$ be an ample complete linear system on X , such that its generic element is a curve of genus at least 2. Suppose that the adjoint line bundle $K_X \otimes \mathcal{L}$ admits a root of order $n \geq 2$, i.e. a line bundle \mathcal{S} over X such that $\mathcal{S}^{\otimes n} = K_X \otimes \mathcal{L}$. Then the restriction of \mathcal{S} to C_0 is a root of order n of K_{C_0} and the image of μ is a subgroup of $\text{MCG}(C_0, \mathcal{S}|_{C_0})$.*

Proof. The fact that the restriction of \mathcal{S} to C_0 is a root of order n of C_0 comes from the adjunction formula (see [GH94])

$$(K_X)|_{C_0} = K_{C_0} \otimes \mathcal{L}^*_{|C_0}.$$

To prove the rest of the proposition, we show that this formula is true in families. To that end, choose a hyperplane H in $|\mathcal{L}|$ that does not contain C_0 . Let

$$\mathcal{C} = \{(x, C) \in X \times |\mathcal{L}|\setminus(\mathcal{D} \cup H) \mid x \in C\}$$

be the universal curve with projection $\pi : \mathcal{C} \rightarrow |\mathcal{L}| \setminus (\mathcal{D} \cup H)$ and evaluation map $\text{ev} : \mathcal{C} \rightarrow X$. Then the pullback of $K_X \otimes \mathcal{L}$ to \mathcal{C} by ev is isomorphic to the relative canonical bundle of \mathcal{C} . Indeed, denote by $T_{\text{rel}}\mathcal{C}$ the kernel of $d\pi$. By definition, $K_{\text{rel}}(\mathcal{C})$ is the dual of $T_{\text{rel}}\mathcal{C}$. Moreover, since all the curves in $|\mathcal{L}| \setminus \mathcal{D}$ are smooth, the differential of the evaluation map induces an injective morphism $T_{\text{rel}}\mathcal{C} \rightarrow \text{ev}^*TX$. Conversely, since we removed H from $|\mathcal{L}|$, we can choose a section s of the pullback of \mathcal{L} over $X \times |\mathcal{L}| \setminus (\mathcal{D} \cup H)$ that vanishes along \mathcal{C} . Its derivative is well-defined along \mathcal{C} and induces a morphism $\text{ev}^*TX \rightarrow \text{ev}^*\mathcal{L}$, which is surjective since the curves in $|\mathcal{L}| \setminus \mathcal{D}$ are transversally cut. It follows also that we have an exact sequence

$$0 \rightarrow T_{\text{rel}}\mathcal{C} \rightarrow \text{ev}^*TX \rightarrow \text{ev}^*\mathcal{L} \rightarrow 0.$$

Thus $\text{ev}^*K_X \otimes \text{ev}^*\mathcal{L} = K_{\text{rel}}(\mathcal{C})$. In particular, $\text{ev}^*\mathcal{S}^{\otimes n} = K_{\text{rel}}(\mathcal{C})$, and $\text{ev}^*\mathcal{S}$ is an element of $R_n(\mathcal{C})$. The result follows from Proposition 2.6 and the fact that the morphism $\pi_1(|\mathcal{L}| \setminus (\mathcal{D} \cup H), C_0) \rightarrow \pi_1(|\mathcal{L}| \setminus \mathcal{D}, C_0)$ is surjective. □

Earle and Sipe showed in [ES91, Corollary 5.3] that, for any Riemann surface of genus $g > 2$, there exists an element of its mapping class group that does not preserve any n th root of its canonical bundle for all $n > 2$ dividing $2g - 2$. In particular, Proposition 2.7 gives the following.

COROLLARY 2.8. *Let X be a smooth and complete toric surface and let \mathcal{L} be an ample line bundle on X . Assume that the curves in $|\mathcal{L}|$ are of arithmetic genus at least 3. Fix a smooth curve C_0 in $|\mathcal{L}|$.*

If $K_X \otimes \mathcal{L}$ admits an n th root with $n > 2$, the geometric monodromy μ is not surjective. In particular, there exists a non-separating simple closed curve on C_0 that is not a vanishing cycle.

Remark 2.9. Since the Picard group of X is free [Ful93, proposition p. 63], the n th root of $K_X \otimes \mathcal{L}$ is unique when it exists.

2.3 Main results

In the following theorems, X is a smooth and complete toric surface and \mathcal{L} is an ample line bundle on X . We assume that the curves in $|\mathcal{L}|$ are of arithmetic genus at least 1. This implies that the adjoint line bundle $K_X \otimes \mathcal{L}$ of \mathcal{L} has an empty base locus (see Proposition 3.3). Finally, we denote by d the dimension of the image of the map $X \rightarrow |K_X \otimes \mathcal{L}|^*$ and we fix a smooth curve C_0 in $|\mathcal{L}|$.

THEOREM 1. *The monodromy map μ is surjective if and only if one of the following is satisfied:*

- (i) $d = 0$;
- (ii) $d = 2$ and $K_X \otimes \mathcal{L}$ admits no root of order greater or equal to 2.

The case $d = 1$ corresponds to the hyperelliptic case and will be treated in the follow-up paper [CL17]. In the case $d = 2$, the parity of the largest order n of a root \mathcal{S} of $K_X \otimes \mathcal{L}$ plays an important role.

When n is even, the restriction of $\mathcal{S}^{\otimes n/2}$ to C_0 is a spin structure on C_0 . We also treat this case in [CL17]. Let us simply say that the non-surjectivity of the monodromy already appears through the algebraic monodromy map

$$[\mu] : \pi_1(|\mathcal{L}| \setminus \mathcal{D}, C_0) \rightarrow \text{Sp}(H_1(C_0, \mathbb{Z})),$$

obtained by composing μ with the natural map $\text{MCG}(C_0) \rightarrow \text{Sp}(H_1(C_0, \mathbb{Z}))$, where $\text{Sp}(H_1(C_0, \mathbb{Z}))$ is the group of automorphisms of $H_1(C_0, \mathbb{Z})$ that preserve the intersection form.

When n is odd, the obstruction described in Corollary 2.8 is not detected by the algebraic monodromy. More precisely, we have the following.

THEOREM 2. *The algebraic monodromy map $[\mu]$ is surjective if and only one of the following is satisfied:*

- (i) μ is surjective;
- (ii) $d = 2$ and $K_X \otimes \mathcal{L}$ admits no root of order 2.

In the general case, we conjecture the following.

CONJECTURE 1. Assume that $d = 2$. Let n be the largest order of a root \mathcal{S} of $K_X \otimes \mathcal{L}$. The image of μ is exactly $\text{MCG}(C_0, \mathcal{S}|_{C_0})$.

We motivate this conjecture in this paper (see § 7.5) and the follow-up paper [CL17]. We give the proofs of Theorems 1 and 2 in §§ 6.3 and 7, where we treat the cases $d = 0$ and $d = 2$ separately.

Remark 2.10. (i) The amplitude and genus requirements in Theorems 1 and 2 guarantee that the discriminant \mathcal{D} is of codimension 1 in $|\mathcal{L}|$ and that the vanishing cycles are non-separating (see Theorem 3).

(ii) Question 1 can also be stated in a symplectic setting. That is, if one allows the almost-complex structure on X to vary along a degeneration of C_0 , can one obtain more vanishing cycles than in the algebraic case? Does the obstruction coming from the root of $K_X \otimes \mathcal{L}$ survive in this setting?

To prove Theorems 1 and 2, we use techniques from tropical geometry, namely a version of Mikhalkin’s approximation theorem (Theorem 5). It allows the construction of explicit 1-parameter families of curves in $|\mathcal{L}| \setminus \mathcal{D}$ whose images by μ are rather simple and explicit elements of $\text{MCG}(C_0)$. If no root of $K_X \otimes \mathcal{L}$ appears, we show that we can recover Humphries’ generating set for $\text{MCG}(C_0)$, see § 7.3. If no even root of $K_X \otimes \mathcal{L}$ appears, we recover the image of Humphries’ generating set in $\text{Sp}(H_1(C_0, \mathbb{Z}))$, see § 7.4.

3. Toric surfaces, line bundles, and polygons

We recall some facts about toric surfaces (for more details, see, for example, [Ful93] or [GKZ08]). Let X be a smooth complete toric surface associated with the fan $\Sigma \subset \mathbb{Z}^2 \otimes \mathbb{R}$. Denote by $\Sigma(1)$ the set of one-dimensional cones in Σ . For each element $\epsilon \in \Sigma(1)$, let u_ϵ be the primitive integer vector in ϵ and $D_\epsilon \subset X$ the associated toric divisor.

Take a line bundle $\mathcal{L} = \mathcal{O}_X(\sum_{\epsilon \in \Sigma(1)} a_\epsilon D_\epsilon)$ on X and define

$$\Delta_{\mathcal{L}} = \{v \in \mathbb{R}^2 \mid \epsilon \in \Sigma(1), \langle v, u_\epsilon \rangle \geq -a_\epsilon\}.$$

Notice that $\Delta_{\mathcal{L}}$ is, in fact, only well-defined up to translation by an integer vector.

If \mathcal{L} is nef, $\Delta_{\mathcal{L}}$ is a convex lattice polygon (in this paper, lattice polygons are bounded by convention) and Σ is a refinement of its normal fan. More precisely, $\Delta_{\mathcal{L}}$ has one edge for each $\epsilon \in \Sigma(1)$ and the integer length l_ϵ of this edge is equal to the intersection product $(\sum_{\epsilon' \in \Sigma(1)} a_{\epsilon'} D_{\epsilon'}) \bullet D_\epsilon$, which can be 0. In particular, we have the following proposition.

PROPOSITION 3.1. *Let \mathcal{L} be a nef line bundle on a smooth complete toric surface X with fan Σ . Let n be the largest order of a root of \mathcal{L} . Then*

$$n = \gcd(\{l_\epsilon \mid \epsilon \in \Sigma(1)\}).$$

Proof. Let $m = \gcd(\{l_\epsilon \mid \epsilon \in \Sigma(1)\})$ and let \mathcal{S} be a root of order n of \mathcal{L} . Then, for any $\epsilon \in \Sigma(1)$,

$$l_\epsilon = \mathcal{L} \bullet D_\epsilon = n(\mathcal{S} \bullet D_\epsilon).$$

Thus n divides m .

Conversely, let U be the matrix whose rows are given by the vectors u_ϵ . Up to translation, we can assume that 0 is a vertex of $\Delta_{\mathcal{L}}$. In particular, $(1/m)\Delta_{\mathcal{L}}$ is still a convex lattice polygon. Moreover, if $\Delta_{\mathcal{L}}$ is given by the system $Uv \geq -a$, then $(1/m)\Delta_{\mathcal{L}}$ is given by $Uv \geq -(a/m)$. In particular, m divides all the coordinates of a . Thus, we can write

$$\mathcal{L} = \sum_{\epsilon \in \Sigma(1)} a_\epsilon D_\epsilon = m \sum_{\epsilon \in \Sigma(1)} \frac{a_\epsilon}{m} D_\epsilon,$$

and \mathcal{L} has a root of order m . Thus m divides n . □

DEFINITION 3.2. A convex lattice polygon Δ is even (respectively odd, respectively prime) if the integer $\gcd(\{l_\epsilon \mid \epsilon \text{ edge of } \Delta\})$ is even (respectively odd, respectively equal to 1).

A nef line bundle \mathcal{L} on a smooth complete toric surface X is even (respectively odd, respectively prime) if the polygon $\Delta_{\mathcal{L}}$ is even (respectively odd, respectively prime).

If \mathcal{L} is ample, the normal fan of $\Delta_{\mathcal{L}}$ is Σ . Moreover, since X is smooth, the polygon $\Delta_{\mathcal{L}}$ is also smooth, i.e. any pair of primitive integer vectors directing two consecutive edges of $\Delta_{\mathcal{L}}$ generates the lattice. Conversely, a smooth convex lattice polygon Δ of dimension 2 defines a smooth complete toric surface X as follows: label the elements of $\Delta \cap \mathbb{Z}^2 = \{(a_1, b_1), \dots, (a_m, b_m)\}$ and consider the monomial embedding $(\mathbb{C}^*)^2 \rightarrow \mathbb{C}P^m$ given by

$$(z, w) \mapsto [z^{a_1}w^{b_1}, \dots, z^{a_m}w^{b_m}].$$

Then X is defined as the closure of $(\mathbb{C}^*)^2$ in $\mathbb{C}P^m$. In particular, it always comes with (z, w) -coordinates and the associated complex conjugation. The line bundle \mathcal{L} on X given by the inclusion in $\mathbb{C}P^m$ is such that $\Delta = \Delta_{\mathcal{L}}$. If Δ' is obtained from Δ by an invertible affine transformation $A : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ preserving the lattice, then A induces an isomorphism between the two toric surfaces obtained from Δ and Δ' , which pulls back \mathcal{L}' to \mathcal{L} . Indeed, the lattice $\mathbb{Z}^2 \subset \mathbb{R}^2$ is naturally isomorphic to the space of characters on $(\mathbb{C}^*)^2$ via the (z, w) -coordinates. The map $A^\vee : (\mathbb{C}^*)^2 \rightarrow (\mathbb{C}^*)^2$ dual to A induces the desired isomorphism of toric surfaces.

When $\text{int}(\Delta) \cap \mathbb{Z}^2$ is non-empty, we can consider the adjoint polygon Δ_a of Δ defined as the convex hull of the interior lattice points of Δ . The number of lattice points of Δ_a is equal to the arithmetic genus of the curves in $|\mathcal{L}|$, which we denote $g_{\mathcal{L}}$, see [Kho78]. Denote also by $b_{\mathcal{L}}$ the number of lattice points on $\partial\Delta$. The integer $b_{\mathcal{L}}$ is then equal to the intersection multiplicity of the curves in $|\mathcal{L}|$ with the divisor $(\sum_{\epsilon \in \Sigma(1)} D_\epsilon)$.

PROPOSITION 3.3. *Let X be a smooth complete toric surface with fan Σ and let \mathcal{L} be an ample line bundle on X such that $g_{\mathcal{L}} \geq 1$.*

- (i) *The adjoint line bundle $K_X \otimes \mathcal{L}$ is nef with empty base locus and $\Delta_{K_X \otimes \mathcal{L}} = \Delta_a$. In particular, for each $\epsilon \in \Sigma(1)$, the associated edge of Δ_a has length $l_\epsilon - D_\epsilon^2 - 2$ ([Koe91, Lemma 2.3.1 and Proposition 2.4.2], [Oda88, Theorem 2.7]).*

- (ii) Let $\phi_{K_X \otimes \mathcal{L}} : X \rightarrow |K_X \otimes \mathcal{L}|^*$ be the natural map. We have $\dim(\text{im}(\phi_{K_X \otimes \mathcal{L}})) = \dim(\Delta_a)$.
- (iii) If $\dim(\Delta_a) = 2$, then Δ_a is smooth [Oga07, Lemma 5]. □

If Δ is a smooth convex lattice polygon, we call its extremal points vertices.

4. Simple Harnack curves

Let $\Delta \subset \mathbb{Z}^2 \otimes \mathbb{R}$ be a smooth two-dimensional convex lattice polygon, X the associated toric surface, and \mathcal{L} the line bundle on X given by Δ . Recall that X comes with an open dense torus $(\mathbb{C}^*)^2 \subset X$ with coordinates (z, w) . These coordinates induce a complex conjugation on X . A curve $C \in |\mathcal{L}|$ is real if it is invariant by complex conjugation. Define the amoeba map $\mathcal{A} : (\mathbb{C}^*)^2 \rightarrow \mathbb{R}^2$ by

$$\mathcal{A}(z, w) = (\log |z|, \log |w|).$$

For any algebraic curve $C \subset X$, denote $C^\circ := C \cap (\mathbb{C}^*)^2$ and $\mathbb{R}C^\circ := C \cap (\mathbb{R}^*)^2$.

DEFINITION 4.1. A real curve $C \in |\mathcal{L}|$ is a (possibly singular) simple Harnack curve if $C \setminus C^\circ$ is a finite set and if the amoeba map $\mathcal{A} : C^\circ \rightarrow \mathbb{R}^2$ is at most 2-to-1.

Remark 4.2. The original definition of simple Harnack curves can be found in [Mik00]. The equivalence to the definition given here is proven in [MR01, Theorem 1]. We seize the occasion to slightly clarify [MR01, Theorem 1]. For the latter theorem to be true, one has to stress in [MR01, Definition 2] that the intersection $\alpha_k \cap l_k$ consists of d_k points, counted with multiplicities. Whether Mikhalkin and Rullgård [MR01] meant Definition 2 this way or not, it is, in any case, a minor issue.

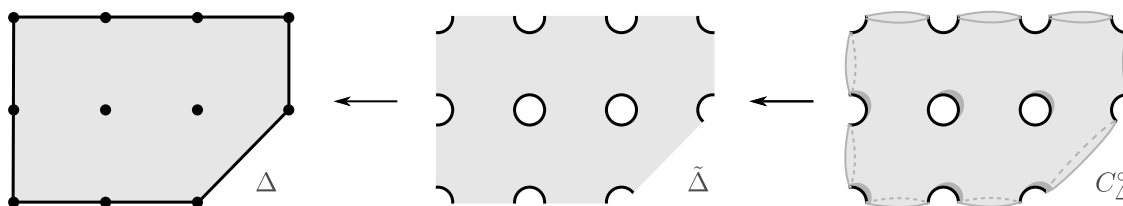


FIGURE 1. Construction of C°_Δ from Δ .

From the present perspective, simple Harnack curves have two remarkable properties. First, the topological type of $(\mathbb{R}X, \mathbb{R}C, \bigcup_\epsilon \mathbb{R}D_\epsilon)$ is unique, see [Mik00]. Second, the space of simple Harnack curves admits a very simple set of coordinates, see [KO06] and [Ola17]. In particular, all the possible deformations of simple Harnack curves to singular curves are known. The topology of $\mathbb{R}C \subset \mathbb{R}X$ can be recovered from Definition 4.1. The real part $\mathbb{R}C$ consists of $g_{\mathcal{L}} + 1$ ovals. One of these ovals intersects all the toric divisors D_ϵ in the maximal number of points (with multiplicities) in the cyclical order induced by the fan Σ . The remaining $g_{\mathcal{L}}$ ovals are mutually non-nested. The amoeba of C° is a closed domain of \mathbb{R}^2 bounded by $\mathcal{A}(\mathbb{R}C^\circ)$. In particular, it has $g_{\mathcal{L}}$ holes and one tentacle going off to infinity for any intersection point of $\mathbb{R}C$ with $X \setminus (\mathbb{C}^*)^2$. These properties are illustrated, for instance, in [Lan15a, Figures 1 and 2]. Next, we use these properties to construct a rigid and combinatorial model for simple Harnack curves, see Proposition 4.6 and Figure 1. The latter model will be very helpful in keeping track of vanishing cycles or monodromy along 1-parameter families of curves.

For a simple Harnack curve C , the amoeba map \mathcal{A} is 1-to-1 on $\mathbb{R}C^\circ$ and $\mathcal{A}(C^\circ)$ determines C up to sign. We get rid of this sign ambiguity as follows. Choose a vertex $v \in \Delta$ with adjacent edges ϵ_1 and ϵ_2 . By [MR01, Definition 2], there is a unique connected arc $\alpha \subset \mathbb{R}C^\circ$ joining ϵ_1 to ϵ_2 . We restrict ourselves to the set of smooth simple Harnack curves for which α sits in the $(+, +)$ -quadrant of \mathbb{R}^2 . For technical reasons, we also assume that C intersects the divisor $X \setminus (\mathbb{C}^*)^2$ transversally, implying that C° is a compact Riemann surface with $b_{\mathcal{L}}$ points removed. The latter is a Zariski-open condition in the linear system $|\mathcal{L}|$, see, for example, [Vir84, §1.1]. We denote by $\mathcal{H}_\Delta \subset |\mathcal{L}|$ the set of such simple Harnack curves. In the following, we refer to the $g_{\mathcal{L}}$ ovals of $\mathbb{R}C$ contained in $(\mathbb{C}^*)^2$ as the A -cycles of C .

THEOREM 3. Any A -cycle of a curve $C_0 \in \mathcal{H}_\Delta$ is a vanishing cycle in the linear system $|\mathcal{L}|$.

THEOREM 4. The set \mathcal{H}_Δ is connected.

These theorems are given in [KO06] for the case $X = \mathbb{C}P^2$. The proofs we provide here rely mainly on [KO06]. We only provide the extra arguments that we require. Before doing so, we recall one of the main ingredients. We identify $H^0(X, \mathcal{L})$ with the space of Laurent polynomials with support inside $\Delta \cap \mathbb{Z}^2$. For any $f \in H^0(X, \mathcal{L})$ and $C := \overline{f^{-1}(0)} \subset X$, the Ronkin function $N_f : \mathbb{R}^2 \rightarrow \mathbb{R}$ given by

$$N_f(x, y) = \frac{1}{(2i\pi)^2} \iint_{\substack{|z|=e^x \\ |w|=e^y}} \log |f(z, w)| \frac{dz dw}{zw}$$

is convex, piecewise linear with integer slope on every connected component of $\mathbb{R}^2 \setminus \mathcal{A}(C^\circ)$. It induces the order map

$$\begin{aligned} \pi_0(\mathbb{R}^2 \setminus \mathcal{A}(C^\circ)) &\rightarrow \Delta \cap \mathbb{Z}^2 \\ U &\mapsto \text{grad } N_f(U). \end{aligned}$$

For a curve $C \in \mathcal{H}_\Delta$, the latter map is a bijection, mapping any compact connected component of $\mathbb{R}^2 \setminus \mathcal{A}(C^\circ)$ to $\Delta_a \cap \mathbb{Z}^2$. Note that for two polynomials defining the same fixed curve C , the associated Ronkin functions differ only by an additive constant. It follows that the map $(\text{grad } N_f) \circ \mathcal{A} : C^\circ \rightarrow \mathbb{R}^2$ does not depend on the choice of f . We refer to [FPT00] and [PR04] for more details.

The proof of Theorem 3 relies on the fact that [KO06, Proposition 6] extends to the present case. To show this, we need an explicit description of the space of holomorphic differentials on a curve $C \in \mathcal{H}_\Delta$.

LEMMA 4.3. Let $C \in \mathcal{H}_\Delta$ and $f \in H^0(X, \mathcal{L}_\Delta)$, such that $C = \overline{\{f = 0\}}$. The space of holomorphic differentials on C is isomorphic to the space of sections of \mathcal{L}_{Δ_a} via the map

$$h(z, w) \mapsto \frac{h(z, w)}{\partial_w f(z, w) zw} dz.$$

Proof. The space of sections of \mathcal{L}_{Δ_a} has the expected dimension $g_{\mathcal{L}}$ and two such meromorphic differentials are linearly independent for different h . It remains to show that they are in fact holomorphic. We proceed in two steps.

Assume first that $\Delta \subset \mathbb{N}^2$ has a vertex at the origin with adjacent edges given by the coordinates axes. Then, the plane \mathbb{C}^2 given by the coordinates (z, w) provides a chart of X_Δ at this vertex. In such a case, $h(z, w)/zw$ is a polynomial and the poles of $1/\partial_w f(z, w)$ are

compensated by the vanishing of dz on $\mathbb{C}^2 \cap C$. The latter fact follows from a straightforward computation, using a local parametrization of C . It implies that any differential

$$\Omega = \frac{h(z, w)}{\partial_w f(z, w) zw} dz$$

is holomorphic on $\mathbb{C}^2 \cap C$.

We now show that one can apply the following argument at any vertex of Δ , to conclude the proof. It relies on the following claim: for any lattice-preserving transformation $A : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ sending Δ to some Δ' and dual map $A^\vee : (\mathbb{C}^*)^2 \rightarrow (\mathbb{C}^*)^2$, then

$$A_*^\vee \Omega = \frac{h'(s, t)}{\partial_t f'(s, t) st} ds,$$

where $h' := A_* h \in \mathcal{L}_{\Delta'_a}$, $f' := A_* f \in \mathcal{L}_{\Delta'}$, and $(s, t) := A^\vee(z, w)$. Any such map A can be decomposed into an integer translation and an $Sl_2(\mathbb{Z})$ -linear map. If A is a translation by some vector $(a, b) \in \mathbb{Z}^2$, the map A^\vee is the identity. We have $h' = z^a w^b h$, $f' = z^a w^b f$. On the curve C , we have $\partial_w f'(z, w) = z^a w^b \partial_w f(z, w)$ as $f|_C = 0$. It follows that

$$\frac{h'(z, w)}{\partial_w f'(z, w) zw} dz = \Omega.$$

If $A(n, m) = (dn - bm, -cn + am)$, then $A^\vee(z, w) = (z^a w^b, z^c w^d)$ and, by definition, $h(z, w) = h'(s, t)$. Set the logarithmic coordinates $(\mathbf{z}, \mathbf{w}) = (\log(z), \log(w))$ and $(\mathbf{s}, \mathbf{t}) = (\log(s), \log(t))$ and define $\mathbf{f}(\mathbf{z}, \mathbf{w}) := f(z, w)$ and $\mathbf{f}'(\mathbf{z}, \mathbf{w}) := f'(z, w)$. Observing that $\mathbf{f}'(\mathbf{s}, \mathbf{t}) = \mathbf{f}(d\mathbf{s} - b\mathbf{t}, -c\mathbf{s} + a\mathbf{t})$ and that

$$\frac{d\mathbf{z}}{\partial_{\mathbf{w}} \mathbf{f}(\mathbf{z}, \mathbf{w})} = -\frac{d\mathbf{w}}{\partial_{\mathbf{z}} \mathbf{f}(\mathbf{z}, \mathbf{w})}$$

on $\{\mathbf{f} = 0\}$, we compute

$$\frac{ds}{\partial_t f'(s, t) st} = \frac{ds}{\partial_{\mathbf{t}} \mathbf{f}'(\mathbf{s}, \mathbf{t})} = \frac{a d\mathbf{z} + b d\mathbf{w}}{-b \partial_{\mathbf{z}} \mathbf{f}(\mathbf{z}, \mathbf{w}) + a \partial_{\mathbf{w}} \mathbf{f}(\mathbf{z}, \mathbf{w})} = \frac{d\mathbf{z}}{\partial_{\mathbf{w}} \mathbf{f}(\mathbf{z}, \mathbf{w})} = \frac{dz}{\partial_w f(z, w) zw}. \quad \square$$

Proof of Theorem 3. To begin with, we briefly describe the setting of [KO06, Propositions 6 and 10]. Consider the space H of simple Harnack curves in $|\mathcal{L}|$ with fixed intersection points with $X \setminus (\mathbb{C}^*)^2$. Note that H is closed and has dimension $g_{\mathcal{L}}$, and the only singular curves in H have isolated real double points (see [MR01]).

Consider then the continuous and proper map $\text{Area} : H \rightarrow \mathbb{R}_{\geq 0}^{g_{\mathcal{L}}}$ that associates with any curve C the area of the holes of $\mathcal{A}(C^\circ)$. We show next that the map Area is a local diffeomorphism. In particular, it is a covering map. Now, for any curve $C \in H$, denote $\text{Area}(C) =: (a_1, a_2, \dots, a_{g_{\mathcal{L}}})$ and $T_j := \{(a_1, \dots, ta_j, \dots, a_{g_{\mathcal{L}}}) \mid t \in [0, 1]\}$, for $1 \leq j \leq g_{\mathcal{L}}$. As the map Area is a covering map, we can lift the segment T_j to a path in $|\mathcal{L}|$ starting at C . By construction, this path ends at a curve whose only singularity is a node and the corresponding vanishing cycle is the j th A -cycle of C .

Let us now show that Area is a local diffeomorphism. With this aim, we show that [KO06, Proposition 6] holds true in the present case. Namely, fixing a simple Harnack curve $C \in H$ defined by a polynomial f , we check that the intercepts of the $g_{\mathcal{L}}$ affine linear functions supporting N_f on the compact connected component of $\mathbb{R}^2 \setminus \mathcal{A}(C^\circ)$ provide local coordinates on H near C .

We reproduce the computation of [KO06]: from Lemma 4.3, we know that for a defining polynomial $f \in H^0(X, \mathcal{L})$ of C , any holomorphic differential on C has the form

$$\Omega = \frac{h(z, w)}{\partial_w f(z, w) zw} dz,$$

where $h \in H^0(X, \mathcal{L}_{\Delta_a})$. Taking f to be a real polynomial, the tangent space of H at C is identified with the space of real polynomials h in $H^0(X, \mathcal{L}_{\Delta_a})$. For any points (x, y) contained in a compact component of $\mathbb{R}^2 \setminus \mathcal{A}(C^\circ)$, we can compute the variation of N_f as in [KO06, Proposition 6]

$$\begin{aligned} \left. \frac{d}{dt} N_{f+th}(x, y) \right|_{t=0} &= \Re \frac{1}{(2i\pi)^2} \iint_{\substack{|z|=e^x \\ |w|=e^y}} \frac{h(z, w)}{f(z, w)} \frac{dz dw}{zw} \\ &= \Re \frac{1}{2i\pi} \int_{|z|=e^x} \sum_{\substack{f(z,w)=0 \\ |w|<e^y}} \frac{h(z, w)}{\partial_w f(z, w)} \frac{dz}{zw} = \frac{1}{2i\pi} \int_{\beta} \frac{h(z, w)}{\partial_w f(z, w)} \frac{dz}{zw}, \end{aligned}$$

where β is the B -cycle $\{|z| = e^x, |w| < e^y\} \cap C$. The latter is anti-invariant by complex conjugation, justifying that we can omit \Re in the last equality. Hence, the differential of the map giving the intercepts in terms of the coefficients of f is the period matrix of C , which is invertible.

Now the variational principle of Proposition 8 and the discussion opening [KO06, § 4.5] hold true in the present case as no argument depends on Δ . It implies that the map giving the areas of the holes of $\mathcal{A}(C^\circ)$ in terms of the intercepts is a local diffeomorphism. We conclude that the map Area is a local diffeomorphism. \square

Proof of Theorem 4. The strategy of the proof is as follows: we first show that any two curves $C_0, C_1 \in \mathcal{H}_\Delta$ can be continuously degenerated to rational simple Harnack curves C_0^* and C_1^* . Then we show that the space of rational simple Harnack curves is path connected, and construct a path inside the latter space joining C_0^* to C_1^* . Finally, we show that the resulting path joining C_0 to C_1 can be deformed in \mathcal{H}_Δ .

First, we use the same argument as in the proof of Theorem 3 involving [KO06, Proposition 10]. If $(a_{j,1}, a_{j,2}, \dots, a_{j,g_\mathcal{L}})$ is the vector of the area of the holes of $\mathcal{A}(C_j^\circ)$, $j = 0, 1$, we can construct two continuous paths of simple Harnack curves $\{C_{j,s} | s \in [0, 1]\}$ such that $C_{j,1} = C_j$ and the area of the holes of $\mathcal{A}(C_{j,s}^\circ)$ is $s \cdot (a_{j,1}, \dots, a_{j,g_\mathcal{L}})$. Notice that $C_{j,s} \in \mathcal{H}_\Delta$ for $s > 0$. The curves $C_{j,0}$ are the curves C_j^* announced already.

The space of rational Harnack curves admits a parametrization similar to that given in [KO06, § 4.1]. Label the edges of Δ counterclockwise as $\epsilon_1, \dots, \epsilon_n$, with respective primitive integer normal vectors $v_1 = (a_1, b_1), \dots, v_n = (a_n, b_n)$ pointing outwards, and finally $l_j := l_{\epsilon_j}$. Real rational curves with Newton polygon Δ can always be parametrized by

$$t \in \mathbb{C}P^1 \mapsto \left(\alpha \prod_{j=1}^n \prod_{k=1}^{l_j} (t - c_{jk})^{a_j}, \beta \prod_{j=1}^n \prod_{k=1}^{l_j} (t - c_{jk})^{b_j} \right) \in X \tag{2}$$

with $\alpha, \beta \in \mathbb{R}^*$; the c_{jk} are either real or appear in complex conjugated pairs. Such a representation is unique up to the action of $\text{PGL}_2(\mathbb{R})$ on the parameter t . The same arguments as in [KO06, Proposition 4] apply so that the curve (2) is a rational simple Harnack curve if and only if all the c_{jk} are real and

$$c_{11} \leq \dots \leq c_{1l_1} < c_{21} \leq \dots \leq c_{2l_2} < \dots < c_{n1} \leq \dots \leq c_{nl_n}. \tag{3}$$

For a curve in $\partial\mathcal{H}_\Delta$, the signs of α and β are determined by the sign convention made on \mathcal{H}_Δ . The space of parameters α, β , and c_{jk} satisfying (3) is connected. This implies that the space of rational simple Harnack curves in $\partial\mathcal{H}_\Delta$ is connected. Hence, one can construct a continuous path $\{C_t^* \mid t \in [0, 1]\}$ in this space joining C_0^* to C_1^* .

The deformations of C_t^* towards \mathcal{H}_Δ with fixed points on $X \setminus (\mathbb{C}^*)^2$ are given by real polynomials $h \in H^0(X, \mathcal{L}_{\Delta_a})$ having prescribed signs at the nodes of C_t^* , once we choose a continuous path of defining real polynomials f_t for C_t^* . Indeed, h and f_t need to have opposite signs around each node for an oval to appear. This sign distribution does not depend on t , as the topological pair $((\mathbb{R}^*)^2, \mathbb{R}(C_t^*)^\circ)$ does not depend on t either. The vanishing of the polynomials of $\mathbb{R}H^0(X, \mathcal{L}_{\Delta_a})$ at each of the nodes of C_t^* imposes independent conditions, cutting $\mathbb{R}H^0(X, \mathcal{L}_{\Delta_a})$ into 2^{g_Δ} orthant. Only the orthant corresponding to the sign prescription above leads to deformations into \mathcal{H}_Δ . It induces a continuous family of orthant in t , inside of which $\{C_t^*\}_t$ can be continuously deformed to a path in \mathcal{H}_Δ with endpoints on $\{C_{0,s}\}_s$ and $\{C_{1,s}\}_s$. The result follows. \square

Remark 4.4. In his recent work [Ola17], Olarte generalized the parametrization of the space of simple Harnack curves given in [KO06] to any Newton polygon. In particular, Olarte shows that the space \mathcal{H}_Δ is contractible, generalizing Theorem 4.

We now show that $\mathbf{H}_\Delta := \{(z, w), C \in (\mathbb{C}^*)^2 \times \mathcal{H}_\Delta, \mid (z, w) \in C\}$ is a trivial fibration over \mathcal{H}_Δ . For this purpose, we will again make use of the Ronkin function. It is shown in [PR04] that, for $C \in |\mathcal{L}|$ and f a defining polynomial, the map $(\text{grad } N_f) \circ \mathcal{A} : C^\circ \rightarrow \mathbb{R}^2$ takes values in Δ . In the Harnack case, we have the following stronger statement.

LEMMA 4.5. *For a polynomial f defining a curve $C \in \mathcal{H}_\Delta$, the map $(\text{grad } N_f) : \text{int}(\mathcal{A}(C^\circ)) \rightarrow \Delta$ is a diffeomorphism onto $\text{int}(\Delta \setminus \mathbb{Z}^2)$.*

Proof. This lemma follows from [Kri13, Lemma 4.4]. We choose to give an alternative proof here.

First, it is shown in [PR04, Theorem 7] that the Hessian of N_f is symmetric positive definite on $\text{int}(\mathcal{A}(C^\circ))$, implying both that $\text{grad } N_f$ is a local diffeomorphism and that N_f is strictly convex on $\text{int}(\mathcal{A}(C^\circ))$. Let us show that $\text{grad } N_f$ is injective on $\text{int}(\mathcal{A}(C^\circ))$. Suppose there are two points $p, q \in \mathbb{R}^2$ such that $\text{grad } N_f(p) = \text{grad } N_f(q)$. By the convexity of N_f , it implies that N_f is affine linear on the segment joining p to q . By the strict convexity of N_f on $\text{int}(\mathcal{A}(C^\circ))$, it follows that both p and q sit outside $\text{int}(\mathcal{A}(C^\circ))$. This proves injectivity.

Now, it is shown in [PR04, Theorem 4] that $\overline{\text{im}(\text{grad } N_f)} = \Delta$. Suppose there is a point $p \in \text{int}(\Delta \setminus \mathbb{Z}^2)$ not in $\text{im}(\text{grad } N_f)$ and consider a sequence $\{p_n\}_{n \in \mathbb{N}} \subset \text{im}(\text{grad } N_f)$ converging to p . All the limit points of $\{(\text{grad } N_f)^{-1}(p_n)\}_{n \in \mathbb{N}}$ are either in $\partial\mathcal{A}(C^\circ)$ or escape to infinity along the tentacles of $\mathcal{A}(C^\circ)$. This implies that p_n converges either to $\Delta \cap \mathbb{Z}^2$ or to $\partial\Delta$. This leads to a contradiction. The surjectivity follows. \square

We now show that this map provides a trivialization of the fibration $\mathbf{H}_\Delta \rightarrow \mathcal{H}_\Delta$ via the following construction. First, consider the real oriented blow-up of \mathbb{R}^2 at \mathbb{Z}^2 . This operation replaces the neighborhood of any lattice point p with $\{x \in \mathbb{R}^2 \mid \|x\| \geq \varepsilon\}$ for an arbitrarily small $\varepsilon > 0$. Define $\tilde{\Delta}$ to be the closure of $\text{int}(\Delta) \setminus \mathbb{Z}^2$ inside the latter blow-up of \mathbb{R}^2 minus the closure of $\partial\Delta \setminus \mathbb{Z}^2$. Now, consider a copy $\tilde{\Delta}'$ of $\tilde{\Delta}$ given with opposite orientation and define

$$C_\Delta^\circ := \tilde{\Delta}' \cup \tilde{\Delta} / \sim,$$

where \sim is the identification of the boundary of $\tilde{\Delta}'$ to that of $\tilde{\Delta}$. It follows that C_Δ° is a compact oriented surface of genus $g_{\mathcal{L}}$ with $b_{\mathcal{L}}$ points removed. The construction of C_Δ° is illustrated in Figure 1. Denote by $\text{pr} : C_\Delta^\circ \rightarrow \tilde{\Delta}$ the 2-to-1 projection and by $\text{conj} : C_\Delta^\circ \rightarrow C_\Delta^\circ$ the associated deck transformation. By Lemma 4.5, we can define an orientation-preserving and equivariant map $R_C : C^\circ \setminus \mathbb{R}C^\circ \rightarrow C_\Delta^\circ$ such that $\text{pr} \circ R_C = (\text{grad } N_f) \circ \mathcal{A}$. The map R_C is unique.

PROPOSITION 4.6. *The map R_C extends to a diffeomorphism $R_C : C^\circ \rightarrow C_\Delta^\circ$. Moreover, the map $R := (R_C, \text{id}) : \mathbf{H}_\Delta \rightarrow C_\Delta^\circ \times \mathcal{H}_\Delta$ is a trivialization of the fibration $\mathbf{H}_\Delta \rightarrow \mathcal{H}_\Delta$.*

Before getting into the proof, recall that the logarithmic Gauss map $\gamma : C^\circ \rightarrow \mathbb{C}P^1$ is the composition of any branch of the complex logarithm with the standard Gauss map. In coordinates $(z, w) \in (\mathbb{C}^*)^2$,

$$\gamma(z, w) = [z\partial_z f(z, w) : w\partial_w f(z, w)],$$

where f is a defining polynomial for C .

Proof. For the first part of the statement, we show that R_C extends to a diffeomorphism on one half of the curve C° and use the equivariance to conclude.

Consider the affine chart $[u : v] \rightarrow u/v$ of $\mathbb{C}P^1$ and define the half C^+ of C° to be the closure of $\{q \in C^\circ \mid \Im(\gamma(q)) \geq 0\}$. Notice that it induces an orientation on $\mathbb{R}C^\circ$ and a lift $\gamma^+ : \mathbb{R}C^\circ \rightarrow S^1$ of γ . By the computation of the Hessian of N_f in [PR04, (19)], we deduce that the restriction to C^+ of $(\text{grad } N_f) \circ \mathcal{A}$ is a lift of the argument map $\text{Arg} : C^\circ \rightarrow (S^1)^2$ to its universal covering \mathbb{R}^2 after a rotation of $\pi/2$. Now let $p \in \mathbb{R}C^\circ$. Up to permutation of the coordinates and sign change, we can assume that $\gamma(p) = [\alpha : 1]$ and that p sits in the positive quadrant. We prove next that the restriction of Arg to a neighborhood of p in C^+ lifts to the real oriented blow-up of $(S^1)^2$ at $(0, 0)$.

By [Mik00, Corollary 6], the logarithmic Gauss map γ has no critical point on $\mathbb{R}C^\circ$. Then γ is 1-to-1 around p and can be used as a local coordinate for C around p . The local parametrization $\text{Log} \circ \gamma^{-1} : t := u/v \mapsto (\mathbf{z}(t), \mathbf{w}(t))$ of $\text{Log}(C)$ around $\text{Log}(p)$ satisfies

$$-\mathbf{w}'(t)/\mathbf{z}'(t) = t,$$

where the left-hand side is the map γ seen via the affine chart of $\mathbb{C}P^1$ chosen above. It follows that

$$\mathbf{z}(t) = a_{\mathbf{z}} + \sum_{j \geq 1} a_j t^j \quad \text{and} \quad \mathbf{w}(t) = a_{\mathbf{w}} - \sum_{j \geq 1} \frac{j}{j+1} a_j t^{j+1},$$

where $a_{\mathbf{z}}, a_{\mathbf{w}}, a_j \in \mathbb{R}$. Recall that Arg is the projection on $i\mathbb{R}^2$ in logarithmic coordinates. Hence, in the coordinate t , we have

$$\text{Arg}(t) = (\Im(\mathbf{z}(t)), \Im(\mathbf{w}(t))) = \left(\sum_{j \geq 1} a_j \Im(t^j), -\sum_{j \geq 1} \frac{j}{j+1} a_j \Im(t^{j+1}) \right).$$

Now, let us denote $t = \alpha + i\beta$. A direct computation shows that

$$\lim_{\beta \rightarrow 0} \alpha \frac{\Im(t^j)}{\beta} = \lim_{\beta \rightarrow 0} \frac{j}{j+1} \frac{\Im(t^{j+1})}{\beta} = j\alpha^j,$$

providing the following explicit formula

$$\lim_{\beta \rightarrow 0^+} \frac{\text{Arg}(t)}{\|\text{Arg}(t)\|} = \frac{\mathbf{z}'(\alpha)}{|\mathbf{z}'(\alpha)|} \frac{(1, -\alpha)}{\|(1, -\alpha)\|}$$

for the extension of Arg to the real oriented blow-up at $(0, 0)$. The same computation shows that $\partial_\beta \text{Arg}(\alpha) = \mathbf{z}'(\alpha)(1, -\alpha)$.

Applying a rotation of $\pi/2$, we deduce that R_C extends to C^+ and that its restriction to $\mathbb{R}C^\circ$ is given by γ^+ . Together with Lemma 4.5, It implies that R_C is differentiable and then induces a diffeomorphism from C^+ to $\tilde{\Delta}$. From the equality $\partial_\beta \text{Arg}(\alpha) = \mathbf{z}'(\alpha)(1, -\alpha)$, we deduce, moreover, that the partial derivative $\partial_\beta R_C$ at any point of $\mathbb{R}C^\circ$ is normal to $\partial\tilde{\Delta}$. Hence, it extends to an equivariant diffeomorphism on the whole C° .

From the computation led above and Lemma 4.5, we deduce that the map $R := (R_C, \text{id}) : \mathbf{H}_\Delta \rightarrow C_\Delta^\circ \times \mathcal{H}_\Delta$ is a differentiable map, and therefore a trivialization of the fibration $\mathbf{H}_\Delta \rightarrow \mathcal{H}_\Delta$. Indeed, R_C is given by the lift of the argument map to its universal covering on $C^\circ \setminus \mathbb{R}C^\circ$ and extended by the logarithmic Gauss map on $\mathbb{R}C^\circ$. Both maps depend analytically on the coefficients of the defining polynomial of $C \in \mathcal{H}_\Delta$. \square

We define a primitive integer segment to be a segment in Δ that joins two integer points and is of integer length 1. For a primitive integer segment $\sigma \subset \Delta$, denote by $\tilde{\sigma}$ its lift in $\tilde{\Delta}$. It follows from Proposition 4.6 that for any primitive integer segment $\sigma \subset \Delta$, $(\text{pr} \circ R_C)^{-1}(\tilde{\sigma}) \subset C$ is a loop invariant by complex conjugation. Similarly, denote by $\tilde{v} \subset \tilde{\Delta}$ the boundary circle projecting down to $v \in \Delta_a \cap \mathbb{Z}^2$. Then $(\text{pr} \circ R_C)^{-1}(\tilde{v}) \subset \mathbb{R}C$ is one of the A-cycles of C .

COROLLARY 4.7. *Let $C_0, C_1 \in \mathcal{H}_\Delta$ and $\varphi : C_0 \rightarrow C_1$ be the diffeomorphism induced by the trivialization R . Also, let $\sigma \subset \Delta$ be a primitive integer segment and $v \in \Delta_a \cap \mathbb{Z}^2$. Then, the pullback by φ of the Dehn twist along the loop $(\text{pr} \circ R_{C_1})^{-1}(\tilde{\sigma})$ (respectively $(\text{pr} \circ R_{C_1})^{-1}(\tilde{v})$) in C_1 is the Dehn twist along the loop $(\text{pr} \circ R_{C_0})^{-1}(\tilde{\sigma})$ (respectively $(\text{pr} \circ R_{C_0})^{-1}(\tilde{v})$) in C_0 .*

DEFINITION 4.8. For any primitive integer segment $\sigma \subset \Delta$ and any curve $C \in \mathcal{H}_\Delta$, define the loop $\delta_\sigma := (\text{pr} \circ R_C)^{-1}(\tilde{\sigma}) \subset C$ and $\tau_\sigma \in \text{MCG}(C)$ to be the Dehn twist along δ_σ .

For any $v \in \Delta_a \cap \mathbb{Z}^2$, define the A-cycle $\delta_v := (\text{pr} \circ R_C)^{-1}(\tilde{v}) \subset \mathbb{R}C$ and $\tau_v \in \text{MCG}(C)$ to be the Dehn twist along δ_v .

Remark 4.9. The loops δ_v and δ_σ intersect if and only if v is an end point of σ . In this case, δ_v intersects δ_σ transversally at one point.

5. Tropical curves

In this section, we recall some definitions for tropical and phase-tropical curves, following [IMS09] and [Lan15b]. For the sake of pragmatism and simplicity, some definitions are given in a restrictive context. The expert reader should not be disturbed. The main goal of this section is the statement and proof of Theorem 5, as a corollary of Mikhalkin’s approximation theorem, see [Lan15b, Theorem 5]. Namely, we construct explicit elements in the image of the monodromy map μ by approximating well-chosen loops in the relevant moduli space of phase-tropical curves.

A tropical polynomial in two variables x and y is a function

$$f(x, y) = \max_{(\alpha, \beta) \in A} (c_{\alpha, \beta} x^\alpha y^\beta) = \max_{(\alpha, \beta) \in A} (c_{\alpha, \beta} + x\alpha + y\beta), \tag{4}$$

where $A \subset \mathbb{N}^2$ is a finite set and $c_{\alpha, \beta} \in \mathbb{R}$.

DEFINITION 5.1. The tropical zero set of a tropical polynomial $f(x, y)$ is defined by

$$\Gamma_f := \{(x, y) \in \mathbb{R}^2 \mid f \text{ is not smooth at } (x, y)\}$$

A subset $\Gamma \subset \mathbb{R}^2$ is a tropical curve if $\Gamma = \Gamma_f$ for some tropical polynomial f . We denote by $E(\Gamma)$ the set of its bounded edges and by $V(\Gamma)$ the set of its vertices.

It follows from the definition that a tropical curve $\Gamma \subset \mathbb{R}^2$ is a piecewise-linear graph with rational slopes. The Newton polygon of a tropical polynomial f is defined as the convex hull of its support A . The Newton polygon of a tropical curve is only defined up to translation as the multiplication of tropical polynomial by a tropical monomial does not affect its zero set. Tropical curves are intimately related to subdivision on their Newton polygon. For a finite set $A \subset \Delta \cap \mathbb{N}^2$, denote by Δ the lattice polygon $\Delta := \text{conv}(A)$. For any function $h : A \rightarrow \mathbb{R}$, define

$$\Delta_h := \text{conv}\{((\alpha, \beta), t) \in \mathbb{R}^3 \mid (\alpha, \beta) \in A, t \geq h(\alpha, \beta)\},$$

i.e. Δ_h is the convex hull of the epigraph of h . The bounded faces of Δ_h define a piecewise-linear convex function $\nu_h : \Delta \rightarrow \mathbb{R}$. Finally, define S_h to be the subdivision $\Delta = \Delta_1 \cup \Delta_2 \cup \dots \cup \Delta_N$ given by the domains of linearity Δ_i of ν_h . The subdivision S_h is a union of 0-, 1- and 2-cells. For practical matters, we will often consider S_h as a graph. The set of its vertices is $V(S_h) = \bigcup_i (\partial\Delta_i \cap \mathbb{N}^2)$ and the set of its edges $E(S_h)$ is the union over i of all the primitive integer segments contained in $\partial\Delta_i$.

DEFINITION 5.2. A convex subdivision S of Δ is a graph $S = S_h$ for some function $h : A \rightarrow \mathbb{R}$. The subdivision S is unimodular if any connected component of $\Delta \setminus S$ has Euclidean area $1/2$.

Notice that by Pick’s formula, a subdivision is unimodular if it decomposes Δ into triangles, whose vertices generate the lattice \mathbb{Z}^2 . Now any tropical polynomial f as in (4) can be considered as the function $(\alpha, \beta) \mapsto c_{\alpha, \beta}$ on A , and hence induces a convex subdivision S_f on its Newton polygon Δ . We have the following duality, see [IMS09].

PROPOSITION 5.3. Let $f(x, y)$ be a tropical polynomial. The subdivision (\mathbb{R}^2, Γ_f) is dual to the subdivision (Δ, S_f) in the following sense.

(a) i -cells of (\mathbb{R}^2, Γ_f) are in 1-to-1 correspondence with $(2 - i)$ -cells of (Δ, S_f) , and the linear spans of corresponding cells are orthogonal to each other.

(b) The latter correspondence reverses the incidence relations.

For any edge $e \in E(\Gamma_f)$, denote its dual edge by $e^\vee \in E(S_f)$. Define the order of any connected component of $\mathbb{R}^2 \setminus \Gamma_f$ to be its corresponding lattice point in Δ .

Remark 5.4. A unimodular convex subdivision S of Δ induces a pair of pants decomposition of any curve $C \in \mathcal{H}_\Delta$ by considering the union of the loops δ_σ for all $\sigma \in E(S)$, see Definition 4.8.

DEFINITION 5.5. A tropical curve $\Gamma_f \subset \mathbb{R}^2$ is smooth if its dual subdivision S_f is unimodular.

In particular, a smooth tropical curve has only 3-valent vertices. Now, we introduce some material in order to define smooth phase-tropical curves. Consider the family of diffeomorphism on $(\mathbb{C}^*)^2$ given by

$$H_t(z, w) = \left(|z|^{1/\log(t)} \frac{z}{|z|}, |w|^{1/\log(t)} \frac{w}{|w|} \right).$$

Define the phase-tropical line $L \subset (\mathbb{C}^*)^2$ as the Hausdorff limit of $H_t(\{1 + z + w = 0\}) \subset (\mathbb{C}^*)^2$ when t tends to $+\infty$. If we denote by $\Lambda := \Gamma_{\ast 1+x+y}$ the tropical line centered at the origin, L is a topological pair of pants such that $\mathcal{A}(L) = \Lambda$. The tropical line Λ consists of 3 infinite rays merging at the origin. The preimages by \mathcal{A} in L of the 3 open rays of Λ are the cylinders

$$\{z = 1, |w| < 1\}, \quad \{w = 1, |z| < 1\} \quad \text{and} \quad \{z = w, |z| > 1\}.$$

These cylinders are glued to the coamoeba $\text{Arg}(\{1 + z + w = 0\})$ over the vertex of Λ .

A toric transformation $A : (\mathbb{C}^*)^2 \rightarrow (\mathbb{C}^*)^2$ is a diffeomorphism of the form

$$(z, w) \mapsto (b_1 z^{a_{11}} w^{a_{12}}, b_2 z^{a_{21}} w^{a_{22}}),$$

where $(b_1, b_2) \in (\mathbb{C}^*)^2$ and $(a_{ij})_{i,j} \in \text{Sl}_2(\mathbb{Z})$. The composition of A with the projection \mathcal{A} (respectively Arg) is an affine linear transformation on \mathbb{R}^2 (respectively on $(S^1)^2$) that we still denote by A . Notice that the group of toric transformations fixing L is generated by $(z, w) \mapsto (w, z)$ and $(z, w) \mapsto (w, (zw)^{-1})$. It descends to the group of symmetries of Λ via \mathcal{A} .

DEFINITION 5.6. A smooth phase-tropical curve $V \subset (\mathbb{C}^*)^2$ is a topological surface such that:

- (i) its amoeba $\mathcal{A}(V)$ is a smooth tropical curve $\Gamma \subset \mathbb{R}^2$;
- (ii) for any open set $U \subset \mathbb{R}^2$ such that $U \cap \Gamma$ is connected and contains exactly one vertex v of Γ , there exists a toric transformation A such that $V \cap \mathcal{A}^{-1}(U) = A(L) \cap \mathcal{A}^{-1}(U)$.

We will say that the map A is a chart of V at the vertex v .

Remark 5.7. It follows from the definition that the topology of V is determined by its underlying tropical curve $\mathcal{A}(V)$. V is an oriented genus g surface with b punctures, where g and b are, respectively, the genus and the number of infinite rays of $\mathcal{A}(V)$.

Smooth phase-tropical curves enjoy a description very similar to the one of Riemann surfaces in terms of Fenchel–Nielsen coordinates, see [Lan15b]. Let V be a smooth phase-tropical curve and $\Gamma := \mathcal{A}(V)$. Up to toric translation, the phase-tropical curve V can be encoded by the pair (Γ, Θ) where $\Theta : E(\Gamma) \rightarrow S^1$ is defined in the following way. For any $e \in E(\Gamma)$ bounded by $v_1, v_2 \in V(\Gamma)$, consider any two charts $A_1, A_2 : (\mathbb{C}^*)^2 \rightarrow (\mathbb{C}^*)^2$ at v_1 and v_2 overlapping on e such that A_1 and A_2 map e on the same edge of Λ and exactly one of the $A_i : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ is orientation-preserving. Without restriction, we can assume that the cylinder of V over the edge e is mapped to the cylinder $\{w = 1, \varepsilon < |z| < 1\}$ by both A_1 and A_2 . The induced automorphism $A_2 \circ A_1^{-1}$ on the latter cylinder is given in coordinates by $z \mapsto \vartheta/z$ for a unique $\vartheta \in \mathbb{C}^*$. We can check that the quantity $\arg(\vartheta) \in S^1$ is an intrinsic datum of V , see [Lan15b, Proposition 2.36].

DEFINITION 5.8. For a phase-tropical curve $V \subset (\mathbb{C}^*)^2$ and $\Gamma := \mathcal{A}(V)$, the associated twist function $\Theta : E(\Gamma) \rightarrow S^1$ is defined by

$$\Theta(e) := \arg(\vartheta)$$

for any $e \in E(\Gamma)$ and $\vartheta \in \mathbb{C}^*$, as constructed above.

Remark 5.9. If any smooth phase-tropical curve $V \subset (\mathbb{C}^*)^2$ can be described by a pair (Γ, Θ) , there are conditions on the twist function Θ for the pair (Γ, Θ) to correspond to a phase-tropical curve in $(\mathbb{C}^*)^2$. These conditions are given in [Lan15b, (5)]. Notice also that any tropical curve Γ induces a length function l on $E(\Gamma)$. The Fenchel–Nielsen coordinates of a phase-tropical curve (Γ, Θ) consist of the pair (l, Θ) , see [Lan15b].

Phase-tropical Harnack curves are the phase-tropical counterpart of the simple Harnack curves that we reviewed in the previous section.

DEFINITION 5.10. A phase-tropical Harnack curve is a smooth phase-tropical curve $V \subset (\mathbb{C}^*)^2$ invariant by complex conjugation and with associated twist function $\Theta \equiv 1$.

It follows from the definition that, for a given smooth tropical curve Γ , there are exactly four phase-tropical Harnack curves $V \subset (\mathbb{C}^*)^2$ such that $\mathcal{A}(v) = \Gamma$ and that they are all obtained from each other by sign changes of the coordinates. The map \mathcal{A} is 2-to-1 from the real part $\mathbb{R}V$ onto Γ . In particular, the topological type of $(\mathbb{R}X, \mathbb{R}V)$ can be recovered from Γ . If Δ is the Newton polygon of Γ , it follows from [Lan15a, Theorem 2] that the approximation of Γ in \mathcal{L}_Δ is a simple Harnack curve whose amoeba can be made arbitrarily close to Γ .

We now introduce some necessary terminology for the statement of Theorem 5.

DEFINITION 5.11. A weighted graph of Δ is a pair (G, m) , where G is a graph whose edges are primitive integer segments contained in Δ and $m : E(G) \rightarrow \mathbb{Z}$. A weighted graph (G, m) is balanced if, for any vertex $v \in V(G) \cap \text{int}(\Delta)$,

$$\sum_{\vec{e} \in E(G,v)} m(e) \cdot \vec{e} = 0, \tag{5}$$

where $E(G, v) \subset E(G)$ is the set of edges adjacent to v oriented outwards. A weighted graph (G, m) is admissible if it is balanced and if it is a subgraph of a unimodular convex subdivision of Δ .

DEFINITION 5.12. For a weighted graph $\mathcal{G} := (G, m)$ of Δ , and any curve $C_0 \in \mathcal{H}_\Delta$, define

$$\tau_{\mathcal{G}} := \prod_{\sigma \in E(G)} \tau_{\sigma}^{m(\sigma)} \in \text{MCG}(C_0),$$

where τ_{σ} is given in Definition 4.8.

THEOREM 5. For any curve $C_0 \in \mathcal{H}_\Delta$ and any admissible graph $\mathcal{G} = (G, m)$ of Δ , we have

$$\tau_{\mathcal{G}} \in \text{im}(\mu).$$

Proof. Let S be a unimodular convex subdivision containing G and $\Gamma \subset \mathbb{R}^2$ be a tropical curve of dual subdivision S . Among the four phase-tropical Harnack curves supported on Γ , consider the one, V , that is coherent with the sign convention made for \mathcal{H}_Δ .

The admissible graph $\mathcal{G} = (G, m)$ induces the following family $\{V_t := (\Gamma, \Theta_t) \mid 0 \leq t \leq 2\pi\}$ of phase-tropical curves: for any $\epsilon \in E(\Gamma)$ such that $\epsilon^\vee \in E(G)$, define $\Theta_t(\epsilon) = e^{it \cdot m(\epsilon^\vee)}$ and $\Theta_t(\epsilon) = 1$ otherwise. One easily checks that Θ_t satisfies (5) in [Lan15b] for any parameter t , so that it actually defines a loop of smooth phase-tropical curves in $(\mathbb{C}^*)^2$ based at $V_0 = V_{2\pi} = V$.

We now want to use Mikhalkin’s approximation theorem in families (see [Lan15b, Theorem 5]). For this, we briefly reproduce a construction that can be found in [Lan15b, § 4.2]. Consider the Teichmüller space $\mathcal{T}(C)$ pointed at a fixed curve $C \in \mathcal{H}_\Delta$. The pair of pants decomposition of C given by $\{\delta_\sigma \mid \sigma \in E(S)\}$ induces Fenchel–Nielsen coordinates on $\mathcal{T}(C)$, see, for example, [Bus10, ch. 6, § 3]. The partial quotient $\mathcal{T}(C) \rightarrow (\mathbb{C}^*)^{E(\Gamma)} \rightarrow \mathcal{M}_{g_{\mathcal{L}}, b_{\mathcal{L}}}$ by the group generated by the set of Dehn twists $\{\tau_\sigma \mid \sigma \in E(S)\}$ inherits Fenchel–Nielsen coordinates

$\mathbb{R}_{>0}^{E(\Gamma)} \times (S^1)^{E(\Gamma)} \simeq (\mathbb{C}^*)^{E(\Gamma)}$. In particular, the latter quotient parametrizes actual genus $g_{\mathcal{L}}$ Riemann surfaces with $b_{\mathcal{L}}$ punctures, see, for example, [Bus10, ch. 3, § 6]. Using these coordinates, we consider the partial compactification F of $(\mathbb{C}^*)^{E(\Gamma)}$ obtained by considering the real oriented blow-up of its $\mathbb{R}_{>0}$ -factor at the origin. Namely, we replace $\mathbb{R}_{>0}^{E(\Gamma)}$ with $\{l \in \mathbb{R}_{>0}^{E(\Gamma)} \mid \|l\| \geq \varepsilon\}$. We then identify the boundary points of the blow-up with phase-tropical curves of coordinates (l, Θ) up to positive rescaling of l , see Remark 5.9. Hence, the 1-parameter family $\{V_t\}_{0 \leq t \leq 2\pi}$ induces a loop in ∂F .

By [Lan15b, Proposition 4.9], there exists a smooth analytic subset $U \subset \mathbb{R}_{>0}^{E(\Gamma)} \times \{\Theta_t\}_{0 \leq t \leq 2\pi}$ of real codimension $g_{\mathcal{L}}$, such that $\bar{U} \subset F$ intersects transversally ∂F along a smooth locus containing $\{V_t\}_{0 \leq t \leq 2\pi}$. This implies that one can find a loop $\{(l_t, \Theta_t)\}_{0 \leq t \leq 2\pi} \subset U$ isotopic to $\{V_t\}_{0 \leq t \leq 2\pi}$ in \bar{U} . By [Lan15b, Proposition 4.9] again, the set U comes with a smooth map $s : U \rightarrow |\mathcal{L}|$, such that the Riemann surface parametrized by $u \in U$ is isomorphic to $s(u) \in |\mathcal{L}|$. Define $C_t^{\mathbb{T}} := s(l_t, \Theta_t)$. According to [Lan15a, Theorem 2], the loop $\{(l_t, \Theta_t)\}_{0 \leq t \leq 2\pi}$ can be chosen so that $C_0^{\mathbb{T}} = C_{2\pi}^{\mathbb{T}} \in \mathcal{H}_{\Delta}$. Moreover, it follows from the construction of the map s that the pair of pants decomposition of $C_0^{\mathbb{T}}$ induced by s is the decomposition given by $\{\delta_{\sigma} \mid \sigma \in E(S)\}$. Together with the definition of Θ_t , it implies that the monodromy induced by the closed path $\{C_t^{\mathbb{T}}\}_{0 \leq t \leq 2\pi}$ is

$$\prod_{\sigma \in E(G)} \tau_{\sigma}^{m(\sigma)} = \tau_G \in \text{MCG}(C_0^{\mathbb{T}}).$$

Now, by the connectedness of \mathcal{H}_{Δ} , see Theorem 4, we can conjugate the closed path $\{C_t^{\mathbb{T}}\}_{0 \leq t \leq 2\pi}$ by a continuous path in \mathcal{H}_{Δ} joining C_0 to $C_0^{\mathbb{T}}$ in order to get a loop ℓ based at C_0 . By Corollary 4.7, we deduce that $\mu(\ell) = \tau_G \in \text{MCG}(C_0)$. □

6. Combinatorial tools

6.1 Unimodular convex subdivisions

To apply Theorem 5, we need to be able to construct unimodular convex subdivisions of a polygon. We give an extension lemma and a refinement lemma, which will be our main construction tools.

LEMMA 6.1. *Let $\Delta' \subset \Delta$ be two convex lattice polygons and take a convex subdivision S' of Δ' . There exists a convex subdivision of Δ that extends S' .*

Proof. By assumption, we can associate a piecewise-linear convex function $\nu : \Delta' \rightarrow \mathbb{R}$ with the subdivision S' . We may also assume that ν only takes positive values. Denote by K the set of vertices of Δ that are not in Δ' . For each $h \in \mathbb{R}$, consider the convex hull of the union of the epigraph of ν and of the rays $K \times [h, +\infty]$; this convex set is the epigraph of a piecewise-linear function $\nu_h : \Delta \rightarrow \mathbb{R}$. By definition, the function ν_h is convex so it defines a convex subdivision of Δ . To prove the statement, we show that we can choose h such that the subdivision S_{ν_h} of Δ associated with ν_h coincides with the subdivision S' on Δ' .

First, we note that there exists a value $h_0 \in \mathbb{R}$ such that for any $h \geq h_0$, the subdivisions S_{ν_h} and S' coincide on the interior of Δ' . Indeed, we can take h_0 such that for any $h \geq h_0$, the set $K \times \{h\} \subset \Delta \times \mathbb{R}$ is above all the supporting hyperplanes of the epigraph of ν ; in other words, the epigraphs of the functions ν and ν_h coincide over Δ' .

However, we still need to ensure that we can choose $h \geq h_0$ such that the boundary of Δ' is supported on S_{ν_h} . To this end, we check that if we take h to be large enough, the piecewise affine linear function ν_h has to break on each edge of the boundary of Δ' in Δ .

More precisely, for each pair of lattice points v, w that are consecutive on the boundary of Δ' and not both in the boundary of Δ , consider the points $P_{\pm\varepsilon} = (v + w)/2 \pm \varepsilon n$, where n is the exterior normal unit vector to Δ' on the segment $[v, w]$. Since S_{ν_h} and S' coincide on the interior of Δ' , the only possible segment of S_{ν_h} passing through the point $(v + w)/2$ is $[v, w]$. Thus, we can take an $\varepsilon_0 > 0$, such that, for any $0 < \varepsilon \leq \varepsilon_0$ and for any $h \geq h_0$, the segment $[P_{-\varepsilon}, P_{\varepsilon}]$ intersects the subdivision S_{ν_h} at most once. This intersection is non-empty exactly when the segment $[v, w]$ is in S_{ν_h} . Since Δ' has only a finite number of lattice points, we can repeat the same construction for all such pairs of points v and w to obtain a finite set of points $P_{\pm\varepsilon}^i, i \in I$, such that, for all $i \in I$ and $h \geq h_0$, the segment $[P_{-\varepsilon}^i, P_{\varepsilon}^i]$ intersects the subdivision S_{ν_h} at most once.

The restriction of ν over the segment $[P_{-\varepsilon}^i, P_{\varepsilon}^i] \cap \Delta'$ coincides with ν so it is affine linear of slope α_i , independent of h . We need to find $h \geq h_0$ such that ν is not affine linear along the whole segment $[P_{-\varepsilon}^i, P_{\varepsilon}^i]$.

For any $i \in I$ and any $h \geq h_0$, the point $(P_{\varepsilon}^i, \nu_h(P_{\varepsilon}^i)) \in \Delta \times \mathbb{R}$ is a convex combination $\sum_{A \in \Delta' \cap \mathbb{Z}^2} \lambda_A(A, \nu(A)) + \sum_{B \in K} \mu_B(B, h)$. The coefficients $\lambda_A \in [0, 1]$ and $\mu_B \in [0, 1]$ are not uniquely defined. However, since the points P_{ε}^i are outside Δ' , there exists a $\mu_0 > 0$ such that, for any such convex combination giving some point P_{ε}^i , there exists $B \in K$ with $\mu_B \geq \mu_0$. Take

$$h = \max\left(h_0, \frac{\max(\nu) + 2\varepsilon \max_{i \in I}(\alpha_i)}{\mu_0} + 1\right).$$

Then, since ν takes only positive values, for any $i \in I$,

$$\begin{aligned} \nu_h(P_{\varepsilon}^i) &= \sum_{A \in \Delta' \cap \mathbb{Z}^2} \lambda_A \nu(A) + \sum_{B \in K} \mu_B h \\ &\geq \mu_0 h \\ &\geq \max(\nu) + 2\varepsilon \max(\alpha_i) + \mu_0. \end{aligned}$$

If the function ν_h were to be affine linear along any of the segments $[P_{-\varepsilon}^i, P_{\varepsilon}^i]$, we would have

$$\begin{aligned} \nu_h(P_{\varepsilon}^i) &= \nu(P_{-\varepsilon}^i) + 2\varepsilon \alpha_i \\ &\leq \max(\nu) + 2\varepsilon \max(\alpha_i) \\ &< \max(\nu) + 2\varepsilon \max(\alpha_i) + \mu_0. \end{aligned}$$

Thus, the function ν_h is not affine linear along any of the segments $[P_{-\varepsilon}^i, P_{\varepsilon}^i]$. The subdivision S_{ν_h} has to contain all the segments of the boundary of Δ' and coincides with S' on the interior of Δ' . It is the extension of S' that we wanted. □

LEMMA 6.2 [HPPS14, Lemma 2.1]. *Let S be a convex subdivision of a convex lattice polygon Δ . There exists a refinement of S , which is a unimodular convex subdivision of Δ .*

6.2 Constructing Dehn twists

We give some applications of Theorem 5 that will be useful in the rest of the paper. In particular, the following constructions are enough to treat the case $d < 2$. Let Δ be a smooth convex lattice polygon and (X, \mathcal{L}) the associated polarized toric surface. Fix a curve $C_0 \in \mathcal{H}_{\Delta}$.

LEMMA 6.3. *Let $\mathcal{G} = (G, m)$ be a weighted graph of Δ such that $\tau_{\mathcal{G}} \in \text{im}(\mu)$ (respectively $[\tau_{\mathcal{G}}] \in \text{im}([\mu])$). Assume that \mathcal{G} has a vertex $v \in V(G) \cap \text{int}(\Delta)$ of valency 1 and let $\sigma \in E(G)$ be the edge ending at v . Denote by \mathcal{G}' the weighted graph obtained from \mathcal{G} by removing σ . If $m(\sigma) = \pm 1$ then $\tau_{\sigma} \in \text{im}(\mu)$ and $\tau_{\mathcal{G}'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma}] \in \text{im}([\mu])$ and $[\tau_{\mathcal{G}'}] \in \text{im}([\mu])$).*

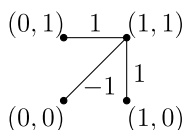


FIGURE 2. Weighted graph \mathcal{G} .

Proof. Assume first that $m(\sigma) = 1$. We know from Theorem 3 that τ_v is in $\text{im}(\mu)$. Since δ_v and δ_σ intersect transversely in only one point, $\tau_v\tau_\sigma(\delta_v)$ is isotopic to δ_σ . Moreover τ_v and τ_σ commute with $\tau_{\mathcal{G}'}$. Thus we obtain

$$(\tau_v\tau_{\mathcal{G}})\tau_v(\tau_v\tau_{\mathcal{G}})^{-1} = (\tau_v\tau_\sigma\tau_{\mathcal{G}'})\tau_v(\tau_v\tau_\sigma\tau_{\mathcal{G}'})^{-1} = (\tau_v\tau_\sigma)\tau_v(\tau_v\tau_\sigma)^{-1} = \tau_\sigma \in \text{im}(\mu).$$

The case when $m(\sigma) = -1$ follows immediately.

Since the map $\text{MCG}(C_0) \rightarrow \text{Sp}(H_1(C_0, \mathbb{Z}))$ is a morphism, the homological statement follows from the previous argument. \square

Notation 1. In the rest of the paper, we will draw weighted graphs using two different line styles: the dashed lines will be for segments for which we know that the associated Dehn twist is in the image of the monodromy and the plain lines will be for the other segments.

Let us introduce a type of primitive integer segment that will appear often in the rest of the paper.

DEFINITION 6.4. A primitive integer segment $\sigma \subset \Delta$ is a bridge if it joins a lattice point of $\partial\Delta$ to a lattice point of $\partial\Delta_a$ and does not intersect $\text{int}(\Delta_a)$.

LEMMA 6.5. Let v be a lattice point on $\partial\Delta_a$ and σ' be a bridge ending at v . Assume that $(\tau_{\sigma'})^m \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}]^m \in \text{im}([\mu])$) for some integer $m \in \mathbb{Z}$. Then we have $(\tau_\sigma)^m \in \text{im}(\mu)$ (respectively $[\tau_\sigma]^m \in \text{im}([\mu])$) for any bridge σ ending at v .

Proof. This follows from the fact that, for any two bridges σ and σ' ending at the same point of Δ_a , the loops δ_σ and $\delta_{\sigma'}$ are isotopic in C_0 . \square

PROPOSITION 6.6. Let $\kappa \in \Delta_a$ be a vertex. If σ is a bridge ending at κ , then τ_σ is in $\text{im}(\mu)$.

Proof. Using an invertible affine transformation that preserves the lattice, we may assume that κ is the point $(1, 1)$, that the origin is a vertex of Δ and that the two edges of Δ meeting at this point are directed by $(1, 0)$ and $(0, 1)$.

Using Lemma 6.5, we may assume that σ is the segment joining $(0, 0)$ to $(1, 1)$. Denote by σ_1 and σ_2 the segments joining $(1, 1)$ to $(1, 0)$ and $(0, 1)$, respectively. Define the weighted graph $\mathcal{G} = (G, m)$ given by Figure 2.

It satisfies the balancing condition at the point $(1, 1)$. To prove that it is admissible, we only need to find a unimodular convex subdivision of Δ supporting G . To that end, take the subdivision of the square consisting of G and the segments joining $(0, 0)$ to $(1, 0)$ and $(0, 0)$ to $(0, 1)$. It is convex as it can be obtained from the function taking value 0 on $(0, 0)$ and $(1, 1)$ and 1 on $(0, 1)$ and $(1, 0)$. Using Lemmas 6.1 and 6.2, we obtain a unimodular convex subdivision of Δ that contains G .

Thus \mathcal{G} is an admissible graph of Δ . We apply Theorem 5 to deduce that $\tau_{\mathcal{G}}$ is in $\text{im}(\mu)$. However, the loops δ_σ , δ_{σ_1} , and δ_{σ_2} are all isotopic. It follows that $\tau_{\mathcal{G}} = \tau_\sigma$ and the statement is proved. \square

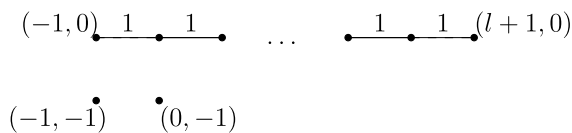


FIGURE 3. Weighted graph \mathcal{G} .

PROPOSITION 6.7. *Let σ be a primitive integer vector lying on an edge of Δ_a . The Dehn twist τ_σ is in $\text{im}(\mu)$.*

Proof. By Proposition 3.3, we may use an invertible affine transformation of \mathbb{R}^2 , preserving the lattice such that Δ has a vertex at $(-1, -1)$ with adjacent edges going through $(-1, 0)$ and $(0, -1)$ and such that the edge of Δ_a containing σ is the segment joining $(0, 0)$ to $(l, 0)$ for some $l \geq 1$. Notice that the points $(-1, 0)$ and $(l + 1, 0)$ are on the boundary of Δ . For i from 0 to $l + 1$, denote by σ_i the segment joining $(i - 1, 0)$ to $(i, 0)$.

We know from Proposition 6.6 that τ_{σ_0} and $\tau_{\sigma_{l+1}}$ are in $\text{im}(\mu)$. Define the weighted graph $\mathcal{G} = (G, m)$ given by Figure 3.

This graph is balanced at all the vertices in Δ_a . Conversely, we can take a convex function on Δ that is affine linear on each component of $\Delta \setminus G$. The associated convex subdivision contains G . Using Lemma 6.2, it follows that \mathcal{G} is an admissible graph.

From Theorem 5, we deduce that $\tau_{\mathcal{G}} = \prod \tau_{\sigma_i} \in \text{im}(\mu)$. We now apply Lemma 6.3 several times; this shows that $\tau_{\sigma_i} \in \text{im}(\mu)$ for all i between 1 and l . □

6.3 The elliptic case

Proof of Theorem 1, case $d = 0$. Let X be a smooth and complete toric surface and let \mathcal{L} be an ample line bundle on X with $d = 0$. Denote by Δ the associated lattice polygon and fix a curve $C_0 \in \mathcal{H}_\Delta$. By assumption, the polygon Δ has only one interior lattice point κ . Take σ to be one of the bridges ending at κ . We know from Proposition 6.6 and Theorem 3 that both τ_κ and τ_σ are in $\text{im}(\mu)$. Since C_0 is of genus 1, the group $\text{MCG}(C_0)$ is generated by τ_κ and τ_σ . Thus, $\text{im}(\mu) = \text{MCG}(C_0)$. □

7. Proof of Theorems 1 and 2

In the rest of the paper, X is a smooth and complete toric surface equipped with an ample line bundle \mathcal{L} . The associated polygon is denoted by Δ and its interior polygon by Δ_a . Since we already took care of the elliptic case in § 6.3, we assume that $\dim(\Delta_a) = 2$ and fix a curve $C_0 \in \mathcal{H}_\Delta$.

7.1 Normalizations

We first give a description of Δ near a vertex of Δ_a .

DEFINITION 7.1. If κ is a vertex of Δ_a , a normalization of Δ at κ is an invertible affine transformation $A : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ preserving the lattice and mapping κ to $(0, 0)$ and its adjacent edges in Δ_a to the edges directed by $(1, 0)$ and $(0, 1)$.

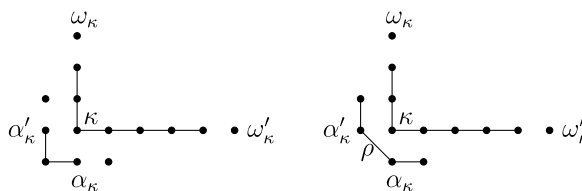


FIGURE 4. The polygon Δ near κ .

We will usually abuse notation and keep calling Δ the image of Δ under a normalization. It follows from Proposition 3.3 that after a normalization at κ , there are two possibilities for the polygon Δ near κ , as depicted in Figure 4.

Indeed, since the normal fan of Δ is a refinement of that of Δ_a , there is an edge of Δ supported on the line $y = -1$ and one supported on the line $x = -1$. The two cases are as follows.

- (i) Those two edges meet; then we have the left case of Figure 4.
- (ii) There is at least one other edge between those two. Let us call it ρ . Since ρ has no corresponding edge in Δ_a , we have $l_\rho - D_\rho^2 - 2 = 0$. Since $\dim(\Delta_a) = 2$, this can only happen if $l_\rho = 1$ and $D_\rho^2 = -1$ (see [Koe91], Lemma 2.3.1). The assumption that Δ_a has dimension 2 also ensures that there cannot be two consecutive edges satisfying those two equalities. Geometrically, the primitive integer vector supporting ρ has to be the sum of the two primitive integer vectors supporting its adjacent edges (see [Ful93, §2.5]). We obtain the right case of Figure 4.

After a normalization of Δ at κ , it follows from this discussion that the points $\alpha_\kappa = (0, -1)$ and $\alpha'_\kappa = (-1, 0)$ always belong to $\partial\Delta$. Moreover, if the edge of Δ_a directed by $(0, 1)$ (respectively by $(1, 0)$) is of length l (respectively of length l'), then the point $\omega_\kappa = (0, l + 1)$ (respectively $\omega'_\kappa = (l' + 1, 0)$) belongs to $\partial\Delta$.

7.2 Constructions

Let us start with some technical definitions. Fix a vertex κ of Δ_a and choose a boundary lattice point κ' of Δ_a such that κ and κ' are consecutive on $\partial\Delta_a$ (the orientation does not matter). Denote by ϵ the edge of Δ_a containing κ' . Choose a bridge σ' , which joins κ' to any boundary lattice point of Δ . We aim to prove the following.

LEMMA 7.2. *Assume that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$). Then for any bridge $\sigma \subset \Delta$, we have $\tau_\sigma \in \text{im}(\mu)$ (respectively $[\tau_\sigma] \in \text{im}([\mu])$).*

Remark 7.3. In the rest of §7, we will make constant use of admissible graphs in the proofs of the various statements. Most of the time, we will only show that the weighted graph $\mathcal{G} = (G, m)$ under consideration is balanced and leave the proof of the admissibility for the reader. Note that we only need to exhibit a convex subdivision supporting the graph G and obtain a unimodular one by Lemma 6.2.

Proof of Lemma 7.2. Consider the normalization of Δ at κ mapping κ' to $(0, 1)$. The edge ϵ is then vertical.

We claim the following: if $\tau_{\sigma'} \in \text{im}(\mu)$ and κ'' is a lattice point on the edge of Δ_a adjacent to ϵ and containing κ , then there is a bridge σ ending at κ'' such that $\tau_\sigma \in \text{im}(\mu)$.

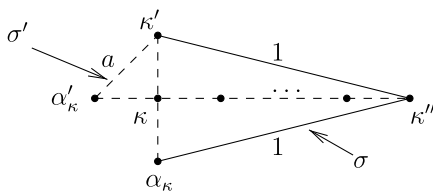


FIGURE 5. Admissible graph \mathcal{G} .

By Lemma 6.5, we can assume, without loss of generality, that σ' joins κ' to $\alpha'_\kappa = (-1, 0)$. By Proposition 6.6, there is nothing to prove if κ'' is a vertex of Δ_a . Therefore, we can assume that $\kappa'' = (a, 0)$ is not a vertex. Now consider the admissible graph \mathcal{G} of Figure 5, where the

horizontal edges have weight $-2a$ and the vertical edges have weight $-a - 1$. By Theorem 5, we have $\tau_{\mathcal{G}} \in \text{im}(\mu)$. By Proposition 7.6 applied to \mathcal{G} and the assumption $\tau_{\sigma'} \in \text{im}(\mu)$, Lemma 6.3 allows us to chase any primitive integer segment of \mathcal{G} except σ and conclude that $\tau_{\sigma} \in \text{im}(\mu)$. This proves the claim.

By applying this claim and Lemma 6.5 to any κ'' , we show that $\tau_{\sigma} \in \text{im}(\mu)$ for any bridge ending on the edge of Δ_a adjacent to ϵ and containing κ . By induction on the edges of Δ_a , it follows that $\tau_{\sigma} \in \text{im}(\mu)$ for any bridge of Δ .

The homological statement follows from the previous arguments and the fact that Lemma 6.3 and Proposition 6.6 hold in homology. \square

Remark 7.4. If Δ_a has a side of integer length 1, it follows from Lemma 7.2 and Proposition 6.6 that $\tau_{\sigma} \in \text{im}(\mu)$ for any bridge $\sigma \subset \Delta$.

In the rest of this section, we explain how to construct a Dehn twist around a loop corresponding to a primitive integer segment σ joining any two points of Δ (see Proposition 7.6). To that end, we will construct an admissible graph containing σ with multiplicity 1 and such that the Dehn twists corresponding to the edges of the graph adjacent to σ are in $\text{im}(\mu)$. We will construct this graph by parts.

Let us choose again a vertex κ of Δ_a and a boundary lattice point κ' of Δ_a such that κ and κ' are consecutive on $\partial\Delta_a$. Take a point $v \in \text{int}(\Delta_a) \cap \mathbb{Z}^2$ and choose two integers m_1 and m_2 . We construct two weighted graphs $\mathcal{G}_{\kappa, \kappa', v}^{m_1, m_2} = (G_{\kappa, \kappa', v}, m_{\kappa, \kappa', v}^{m_1, m_2})$ and $\mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2} = (G_{\kappa', \kappa, v}, m_{\kappa', \kappa, v}^{m_1, m_2})$ associated with these data as follows.

First, consider once again the normalization of Δ at κ mapping κ' to $(0, 1)$. Let us also recall from § 7.1 that the points $\alpha_{\kappa} = (0, -1)$ and $\alpha'_{\kappa} = (-1, 0)$ are boundary points of Δ . The set of edges of $G_{\kappa, \kappa', v}$ is the union of two subsets, as well as that of $G_{\kappa', \kappa, v}$.

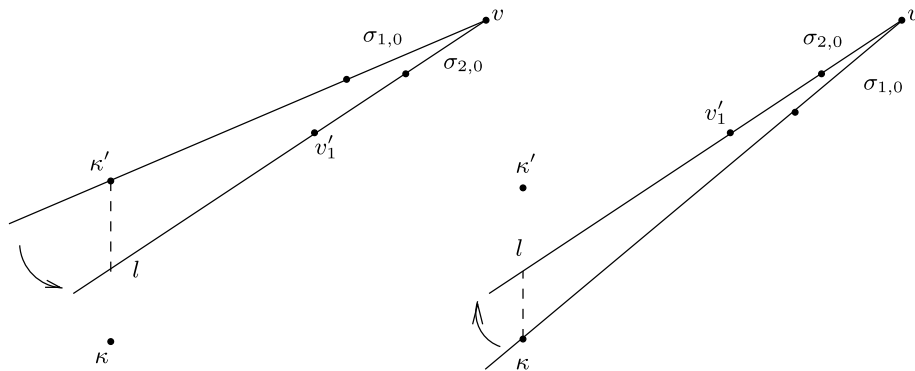


FIGURE 6. Sketch of the construction of v'_1 for the graphs $G_{\kappa, \kappa', v}$ (on the left) and $G_{\kappa', \kappa, v}$ (on the right). There is no lattice point inside the triangles.

The first subset is constructed by induction. We start with $G_{\kappa, \kappa', v}$. Take $v'_0 = v$ and define v'_1 as follows. We call $\sigma_{1,0}$ the primitive integer segment starting at v'_0 and directing $[v'_0, \kappa']$. Consider the ray starting at v'_0 and directed by $\sigma_{1,0}$ and make it rotate counterclockwise around v'_0 until it hits a lattice point in $\text{conv}(v'_0, \kappa', \kappa)$. Denote by l this new ray and by $\sigma_{2,0}$ the primitive integer segment directing it (see Figure 6, on the left).

Take v'_1 to be the lattice point in $l \cap \text{conv}(v'_0, \kappa', \kappa)$ that is farthest away from v'_0 . Take all the primitive integer segments on the segment $[v'_0, \kappa']$ with weight $m_{1,0} = m_1$ and all the primitive integer segments on the segment $[v'_0, v'_1]$ with weight $m_{2,0} = m_2$ to be edges of $G_{\kappa, \kappa', v}$.

Suppose we have constructed v'_0, \dots, v'_k for some $k \geq 1$ and that the edges on $[v'_{k-1}, \kappa']$ are weighted with $m_{1,k-1}$ and that those on $[v'_{k-1}, v'_k]$ have weight $m_{2,k-1}$. If $v'_k = \kappa$, we are done. If not, replacing v'_0 with v'_k in the previous case, we construct $v'_{k+1} \in \text{conv}(v'_k, \kappa', \kappa)$ and the primitive integer segments $\sigma_{1,k}$ on $[v'_k, \kappa']$ and $\sigma_{2,k}$ on $[v'_k, v'_{k+1}]$. By construction, $\sigma_{1,k}$ and $\sigma_{2,k}$

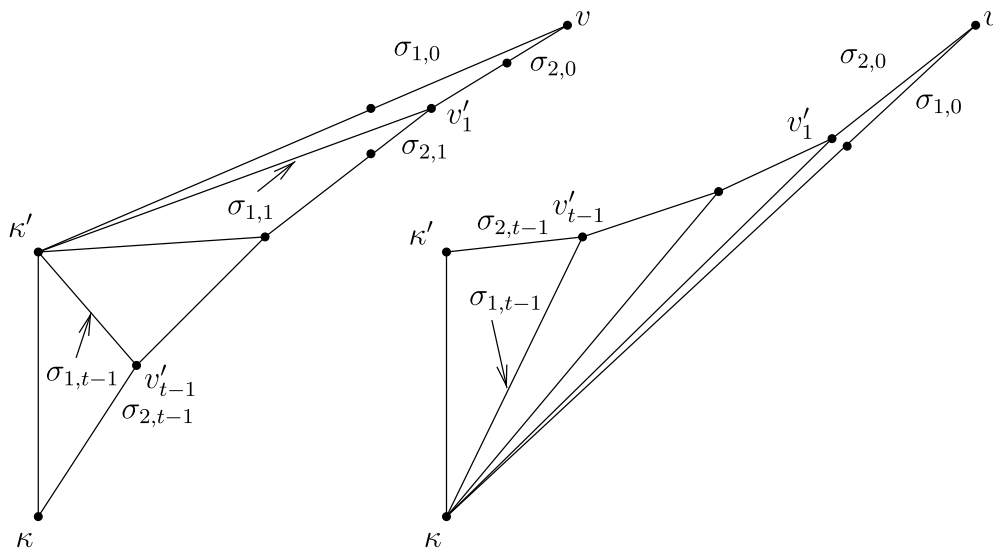


FIGURE 7. Rough sketch of the graphs $G_{\kappa, \kappa', v}$ (on the left) and $G_{\kappa', \kappa, v}$ (on the right). There is no lattice point in any of the small triangles.

generate the lattice. Thus we can find integers $m_{1,k}$ and $m_{2,k}$ such that

$$m_{2,k-1}\sigma_{2,k-1} + m_{1,k}\sigma_{1,k} + m_{2,k}\sigma_{2,k} = 0.$$

Here we identify the segments with the vectors of \mathbb{Z}^2 they induce once we orient them going out of v'_k . We take all the primitive integer segments on the segments $[v'_k, \kappa']$ and $[v'_k, v'_{k+1}]$, weighted by $m_{1,k}$ and $m_{2,k}$, respectively, to be edges of $G_{\kappa, \kappa', v}$.

After a finite number of steps $t \geq 1$, we obtain $v'_t = \kappa$. The graph we obtain looks like the left graph in Figure 7.

The construction for $G_{\kappa', \kappa, v}$ is the same, except we exchange the roles of κ and κ' ; that is, we use the ray starting at v and going through κ to sweep-out the triangle v, κ, κ' , and we stop when we encounter κ' (see Figures 6 and 7). We use the same notations for both graphs.

The second set of edges for both graphs consists of the four segments ρ_1, \dots, ρ_4 joining, respectively, κ' to $\alpha'_{\kappa} = (-1, 0)$ and κ to κ' , α'_{κ} and $\alpha_{\kappa} = (0, -1)$. The first two generate the lattice.

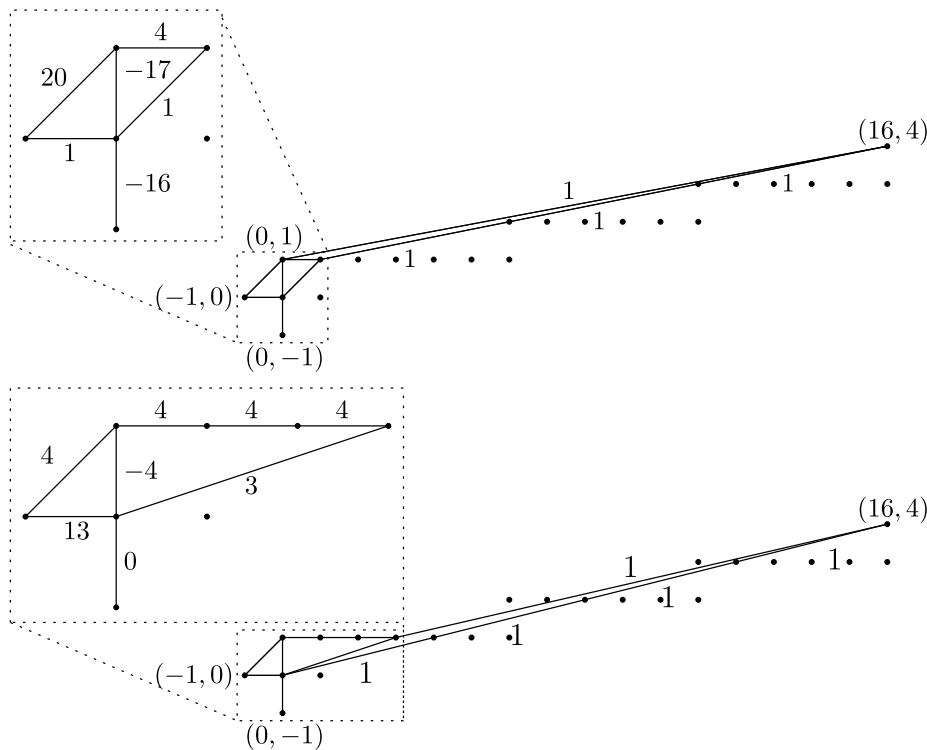


FIGURE 8. Weighted graphs $\mathcal{G}_{(0,0),(0,1),(16,4)}^{(1,1)}$ (top) and $\mathcal{G}_{(0,1),(0,0),(16,4)}^{(1,1)}$ (bottom).

Thus we can find two integers a_1 and a_2 such that $m_{1,0}\sigma_{1,0} + \dots + m_{1,n-1}\sigma_{1,n-1} + a_1\rho_1 + a_2\rho_2 = 0$ (where the segments are oriented going out of κ'). We set $m_{\kappa,\kappa',v}^{m_1,m_2}(\rho_1) = a_1$ and $m_{\kappa,\kappa',v}^{m_1,m_2}(\rho_2) = a_2$. The segments ρ_3 and ρ_4 also generate the lattice. Hence, we can find two integers a_3 and a_4 such that $m_{2,n-1}\sigma_{2,n-1} + a_2\rho_2 + a_3\rho_3 + a_4\rho_4 = 0$ (where the segments are oriented going out of κ). We set $m_{\kappa,\kappa',v}^{m_1,m_2}(\rho_3) = a_3$ and $m_{\kappa,\kappa',v}^{m_1,m_2}(\rho_4) = a_4$.

Notice that, by construction, the graphs $G_{\kappa,\kappa',v}$ and $G_{\kappa',\kappa,v}$ do not depend on m_1 and m_2 and that the weighted graph $\mathcal{G}_{\kappa,\kappa',v}^{m_1,k,m_2,k}$ (respectively $\mathcal{G}_{\kappa',\kappa,v}^{m_1,k,m_2,k}$) is a subgraph of $\mathcal{G}_{\kappa,\kappa',v}^{m_1,m_2}$ (respectively $\mathcal{G}_{\kappa',\kappa,v}^{m_1,m_2}$) for any $0 \leq k < t - 1$, although the weights on the segments ρ_1, \dots, ρ_4 may differ from one to the other.

We give a complete example, taking $v = (16, 4)$ and weights $m_1 = m_2 = 1$, in Figure 8.

LEMMA 7.5. *The weighted graphs $\mathcal{G}_{\kappa,\kappa',v}^{m_1,m_2}$ and $\mathcal{G}_{\kappa',\kappa,v}^{m_1,m_2}$ satisfy the following properties:*

- (i) *the edges $\sigma_1 = \sigma_{1,0}$ and $\sigma_2 = \sigma_{2,0}$ generate the lattice;*
- (ii) *the weight function $m_{\kappa,\kappa',v}^{m_1,m_2}$ (respectively $m_{\kappa',\kappa,v}^{m_1,m_2}$) satisfies the balancing condition (5) at every element of $V(G_{\kappa,\kappa',v}) \cap \text{int}\Delta$ (respectively $V(G_{\kappa',\kappa,v}) \cap \text{int}\Delta$) except at v .*

Assume, moreover, that there is a bridge σ' ending at κ' , such that $\tau_{\sigma'}$ is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma'}]$ is in $\text{im}([\mu])$). Then τ_{σ_1} and τ_{σ_2} are in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_1}]$ and $[\tau_{\sigma_2}]$ are in $\text{im}([\mu])$).

Proof. The two properties of $\mathcal{G}_{\kappa,\kappa',v}^{m_1,m_2}$ and $\mathcal{G}_{\kappa',\kappa,v}^{m_1,m_2}$ follow from the construction.

For the second part of the lemma, we start with the weighted graph $\mathcal{G}_{\kappa,\kappa',v}^{m_1,m_2}$ and show how to adapt the proof for the other one.

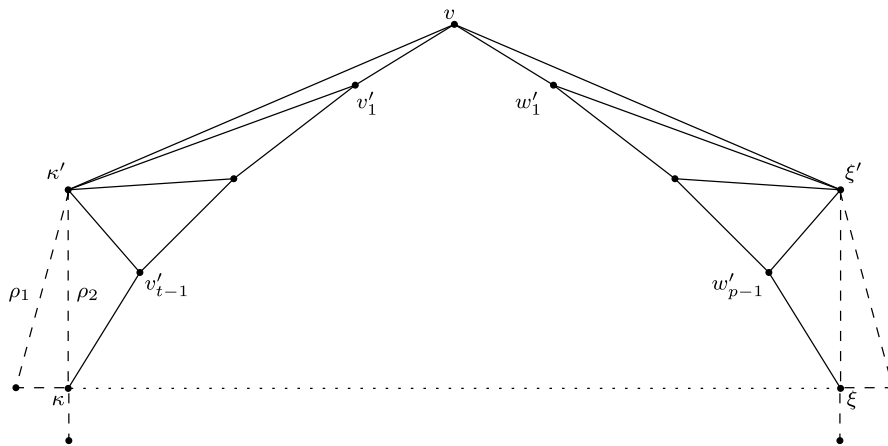


FIGURE 9. Rough sketch of the graph G (with $s = 0$). There is no lattice point in the small triangles. The dashed lines indicate the edges of G for which we know that the associated Dehn twist is in the image of the monodromy.

The strategy is to include the graph $G_{\kappa, \kappa', v}$ in another one, called G , which will be supported by a unimodular convex subdivision of Δ . Moreover, we will be able to put two weight functions on G , such that σ_1 appears with weight 1 for one and σ_2 appears with weight 1 for the other and such that both functions satisfy the balancing condition at every interior vertex of G . To conclude, we apply Theorem 5 and Lemma 6.3.

Let us give the details of the proof. Denote by ξ the vertex of Δ_a next to κ such that κ' is not on $[\xi, \kappa]$ and take ξ' to be the boundary point of Δ_a next to ξ and outside $[\xi, \kappa]$. In the coordinates chosen previously, the point ξ is of the form $(l, 0)$ and ξ' is given by $(l + s, 1)$, for some integers l and s . The points $(l - s, -1)$ and $(l + 1, 0)$ are boundary lattice points of Δ . Define the graph G as the union of $G_{\kappa, \kappa', v}$ and $G_{\xi, \xi', v}$ (see Figure 9).

Let us show that G is supported by a unimodular convex subdivision of Δ . First, we construct the subdivision on the pentagon Q with vertices $\kappa', \kappa, \xi, \xi', v$, which is convex. To this end, let us call w'_i the counterparts of the points v'_i used in the construction of $G_{\xi, \xi', v}$. Define also the function h taking value 0 on the points $v, \kappa, v'_1, \dots, v'_{t-1}, \xi, w'_1, \dots, w'_{p-1}$ and 1 on κ' and ξ' . The subdivision S_h is a convex subdivision of Q (see Definition 5.2). Moreover, if we call $\nu_h : Q \rightarrow \mathbb{R}$ the associated convex function, then ν_h is affine linear along $[\kappa', v]$. Moreover, the subdivision associated with ν contains the part of the graph $G_{\kappa, \kappa', v}$ in Q since the angles $v'_{i-1}v'_iv'_{i+1}$ facing κ' are all greater than π for $i = 1, \dots, t - 1$. By similar arguments, this subdivision also contains the part of the graph $G_{\xi, \xi', v}$ in Q .

Extend the convex subdivision obtained on Q to the polygon $\text{conv}(Q, (0, -1), (l - s, -1))$ using Lemma 6.1. Since the edges $[\kappa, (0, -1)]$ and $[\xi, (l - s, -1)]$ are on the boundary of the polygon, the graph G is still supported by the extended subdivision.

Extend the subdivision once again to the convex polygon $\text{conv}(v, \kappa', (-1, 0), (0, -1), (l - s, -1), (l + 1, 0), \xi')$. The subdivision that we obtain does not necessarily support the graph G , the only possibly missing edges being $[(-1, 0), \kappa]$, $[(-1, 0), \kappa']$, $[(l + 1, 0), \xi]$ and $[(l + 1, 0), \xi']$. However, once we refine it using Lemma 6.2, the unimodular convex subdivision of $\text{conv}(v, \kappa', (-1, 0), (0, -1), (l - s, -1), (l + 1, 0), \xi')$ necessarily contains the whole graph G . Extending this last subdivision to the whole Δ and refining it, we conclude that G is supported by a unimodular convex subdivision of Δ .

Now, let us assume that there is a bridge σ' ending at κ' such that $\tau_{\sigma'}$ is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma'}]$ is in $\text{im}([\mu])$). Using Lemma 6.5, we know that τ_{ρ_1} is in $\text{im}(\mu)$ (respectively $[\tau_{\rho_1}]$ is in $\text{im}([\mu])$).

We first show that τ_{σ_1} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_1}]$ is in $\text{im}([\mu])$). Let us call η_1 and η_2 the two edges of $G_{\xi, \xi', v}$ going out of v . Since η_1 and η_2 generate the lattice, take m_1 and m_2 such that $\sigma_1 + m_1\eta_1 + m_2\eta_2 = 0$ (the vectors being oriented going out of v). Let $m : E(G) \rightarrow \mathbb{Z}$ be the sum of $m_{\kappa, \kappa', v}^{1,0}$ and $m_{\xi, \xi', v}^{m_1, m_2}$ (both extended by 0 where they are not defined) and define the weighted graph $\mathcal{G} = (G, m)$. It is admissible, so from Theorem 5 we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$. From Proposition 6.7, we have $\tau_{\rho_2} \in \text{im}(\mu)$. By assumption, we also know that $\tau_{\rho_1} \in \text{im}(\mu)$ (respectively $[\tau_{\rho_1}] \in \text{im}([\mu])$). Applying Lemma 6.3 repeatedly, we obtain that τ_{σ_1} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_1}]$ is in $\text{im}([\mu])$).

We now show that τ_{σ_2} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_2}]$ is in $\text{im}([\mu])$). We proceed by induction on the number t of steps required to construct $G_{\kappa, \kappa', v}$. Let us first assume that $t = 1$. Take m_1 and m_2 such that $\sigma_2 + m_1\eta_1 + m_2\eta_2 = 0$ (the vectors being oriented going out of v). Let $m : E(G) \rightarrow \mathbb{Z}$ be the sum of $m_{\kappa, \kappa', v}^{0,1}$ and $m_{\xi, \xi', v}^{m_1, m_2}$ and define the weighted graph $\mathcal{G} = (G, m)$. It is admissible, so from Theorem 5 we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$. From Proposition 6.6, we have $\tau_{\rho_3}, \tau_{\rho_4} \in \text{im}(\mu)$. Applying Lemma 6.3 repeatedly, we obtain that τ_{σ_2} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_2}]$ is in $\text{im}([\mu])$).

Assume that $t > 1$ and that the result is true for $t - 1$. Once again, take m_1 and m_2 such that $\sigma_2 + m_1\eta_1 + m_2\eta_2 = 0$ (the vectors being oriented going out of v). Let $m : E(G) \rightarrow \mathbb{Z}$ be the sum of $m_{\kappa, \kappa', v}^{0,1}$ and $m_{\xi, \xi', v}^{m_1, m_2}$ and define the weighted graph $\mathcal{G} = (G, m)$. It is admissible, so from Theorem 5 we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$. Since the graph G_{κ, κ', v_1} is constructed in $t - 1$ steps, we use the induction hypothesis and the first part of the lemma to deduce that $\tau_{\sigma_{1,1}}, \tau_{\sigma_{2,1}} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma_{1,1}}], [\tau_{\sigma_{2,1}}] \in \text{im}([\mu])$). Applying Lemma 6.3, we obtain that τ_{σ_2} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_2}]$ is in $\text{im}([\mu])$). We conclude by induction on t that τ_{σ_2} is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_2}]$ is in $\text{im}([\mu])$).

The case of the graph $\mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2}$ is very similar. The graph G differs a little to ensure that it is supported by a convex subdivision. Indeed, there are two cases.

- (i) The first one is if κ' is not itself a vertex of Δ_a . Then we denote by ξ the vertex of Δ_a next to κ such that κ' is on $[\xi, \kappa]$ and take ξ' to be the boundary point of Δ_a next to ξ and outside $[\xi, \kappa]$. In the coordinates chosen previously, the point ξ is of the form $(0, l)$ and ξ' is given by $(1, l + s)$ for some integers l and s . The points $(-1, l - s)$ and $(0, l + 1)$ are boundary lattice points of Δ .
- (ii) In the second case, the point κ' is a vertex of Δ_a and we take $\xi \neq \kappa$ the vertex of Δ_a next to κ' and ξ' the boundary point of Δ_a next to ξ and not in $[\xi, \kappa']$.

In both cases, the graph G is the union of $G_{\kappa', \kappa, v}$ and $G_{\xi, \xi', v}$. The rest of the proof follows along the same lines as for $\mathcal{G}_{\kappa, \kappa', v}^{m_1, m_2}$ so we omit it. □

We can now use the graphs we constructed to show the following proposition, which provides us with a lot of Dehn twists in the image of the monodromy.

PROPOSITION 7.6. *Let σ' be a bridge ending at κ' . Assume that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$). Then for any primitive integer segment σ joining two points of $\Delta \cap \mathbb{Z}^2$ not both on the boundary of Δ , we have $\tau_{\sigma} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma}] \in \text{im}([\mu])$).*

Proof. Let us first note that, using Lemma 7.2, we may move the vertex κ without changing the assumptions of the proposition.

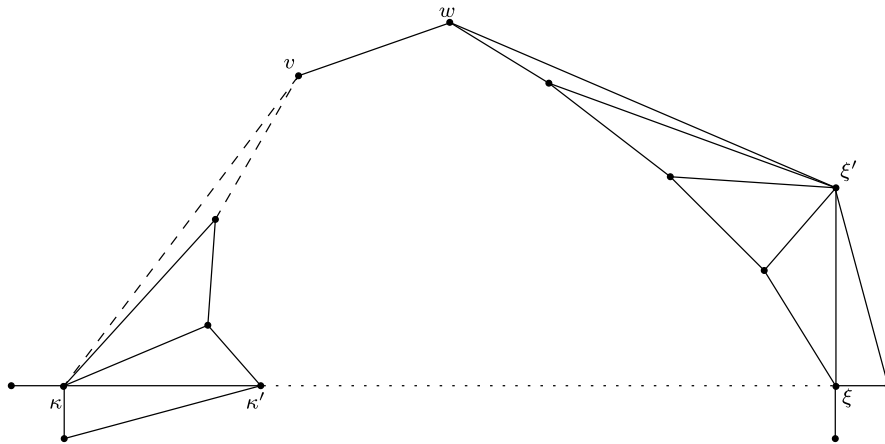


FIGURE 10. Rough sketch of the graph G . There is no lattice point in the small triangles. Dashed lines indicate the edges of G for which we know that the associated Dehn twist is in the image of the monodromy.

Take any primitive integer segment σ in Δ . The idea of the proof is to construct an admissible graph containing σ with weight 1 using the graphs introduced in the beginning of the section and then to apply Lemmas 7.5 and 6.3 to conclude.

Let v and w in $\Delta \cap \mathbb{Z}^2$ be the two ends of σ . We distinguish between four cases: when v and w are both in the interior of Δ_a , when exactly one of them is on the boundary of Δ_a , when both of them are on the boundary of Δ_a , and when one of them is on the boundary of Δ .

Let us first assume that both v and w are in $\text{int}(\Delta_a) \cap \mathbb{Z}^2$. Up to renaming v and w , we may choose two consecutive vertices κ and ξ of Δ_a and boundary points, κ' on $[\kappa, \xi]$ next to κ and ξ' next to ξ outside of $[\kappa, \xi]$, such that the pentagon κ, v, w, ξ', ξ is convex with its vertices arranged in this order. It can happen that $\kappa' = \xi$. Consider the graph G to be the reunion of the graphs $G_{\kappa', \kappa, v}$ and $G_{\xi, \xi', w}$ and the segment σ (see Figure 10). It can be shown, as in the proof of Lemma 7.5, that G is supported by a unimodular convex subdivision.

We now define the weight function on G . Let σ_1 and σ_2 (respectively η_1 and η_2) be the primitive integer segments in $G_{\kappa', \kappa, v}$ (respectively in $G_{\xi, \xi', w}$) going out of v (respectively out of w). Since σ_1 and σ_2 generate the lattice, choose m_1 and m_2 such that $\sigma + m_1\sigma_1 + m_2\sigma_2 = 0$ (where the orientations go out of v). In the same manner, choose m'_1 and m'_2 such that $\sigma + m'_1\eta_1 + m'_2\eta_2 = 0$ (where the orientations go out of w). Let $m : E(G) \rightarrow \mathbb{Z}$ be the function given by $m_{\kappa', \kappa, v}^{m_1, m_2}$ (respectively $m_{\xi, \xi', w}^{m'_1, m'_2}$) on $G_{\kappa', \kappa, v}$ (respectively $G_{\xi, \xi', w}$) and equal to 1 on σ . Define the weighted graph $\mathcal{G} = (G, m)$. It is admissible, so, from Theorem 5, we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$.

By assumption, we have that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$). We know from Lemma 7.5 that $\tau_{\sigma_1}, \tau_{\sigma_2} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma_1}], [\tau_{\sigma_2}] \in \text{im}([\mu])$). Using Lemma 6.3 once, we obtain that $\tau_{\sigma} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma}] \in \text{im}([\mu])$).

For the last three cases, we only construct the graph G and leave the end of the proof to the reader as it follows, word for word, that of the first case.

Let us now assume that exactly one of the two ends of σ , say v , is on the boundary of Δ_a . In this case, take three consecutive vertices ζ, κ and ξ of Δ_a and the boundary point ξ' of Δ_a next to ξ outside of $[\kappa, \xi]$, such that v is on $[\zeta, \kappa]$ and the pentagon κ, v, w, ξ', ξ is convex with its vertices arranged in this order. It can happen that $v = \kappa$. Consider the graph G to be the reunion of the graph $G_{\xi, \xi', w}$, the segment from v to $\partial\Delta$ going through κ , any bridge ending at

v and the segment σ . Once again, it can be shown that G is supported by a unimodular convex subdivision.

Just like in the first case, we may define a balanced weight function on G such that σ has weight 1: we only replace σ_1 by the bridge ending at v and σ_2 by the primitive integer of the ray starting at v .

Assume now that both v and w are on the boundary of Δ_a . By Proposition 6.7, we can assume that they are not on the same edge of Δ_a . Take $\kappa \neq v, w$ and $\xi \neq v, w$ to be the ends of the edges of Δ_a containing, respectively, v and w and such that κ and ξ are on the same side of the line joining v and w . It can happen that $\kappa = \xi$. Take the graph G to be the reunion of the segment from v to $\partial\Delta$ going through κ and any bridge ending at v , the segment from w to $\partial\Delta$ going through ξ and any bridge ending at w , and the segment σ . This graph is still supported by a unimodular convex subdivision.

To define the weight function on G , we proceed as in the second case but we replace η_1 with the bridge ending at w and η_2 with the primitive integer of the ray starting at w .

Finally assume that one of the two ends of σ , say v is on the boundary of Δ . If w is in $\text{int}(\Delta_a)$, take a vertex ξ of Δ_a and a boundary point ξ' next to ξ such that the line generated by σ and the graph $G_{\xi, \xi', w}$ intersect only at w . Define G to be the reunion of $G_{\xi, \xi', w}$ and σ . If w is on the boundary of Δ_a , we may assume that σ is not a bridge and take ξ to be one of the end of the edge of Δ_a containing w . Define G to be the reunion of the segment from w to $\partial\Delta$ going through ξ and any bridge ending at w and the segment σ . In those two cases, the graph G is supported by a unimodular convex subdivision and one can define a balanced weight function such that σ has weight 1.

Once again, the proof of the homological statement is the same as this one, so we omit it. \square

7.3 $K_X \otimes \mathcal{L}$ prime

In this section, we prove the second case of Theorem 1, that is when $d = 2$ and $n = 1$. One of the cornerstones of the proof is the following.

PROPOSITION 7.7. *Let $s := \gcd(\{l_\epsilon \mid \epsilon \text{ edge of } \Delta_a\})$. Then for any bridge $\sigma \subset \Delta$, we have $(\tau_\sigma)^s \in \text{im}(\mu)$.*

To prove this statement, we will need the following lemmas.

LEMMA 7.8. *Let κ be a vertex of Δ_a and $\epsilon_1, \epsilon_2 \subset \Delta_a$ be the edges adjacent to κ . Take $\sigma \subset \Delta$ to be a bridge ending at the point of ϵ_1 at integer distance m of κ and $\sigma' \subset \Delta$ to be a bridge ending at the point of ϵ_2 at integer distance l of κ , for some $m, l \geq 1$.*

Assume that $\tau_\sigma \in \text{im}(\mu)$. Then we have $(\tau_{\sigma'})^{m/(m \wedge l)} \in \text{im}(\mu)$.

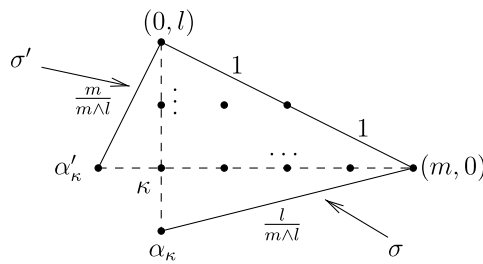


FIGURE 11. Admissible graph \mathcal{G} .

Proof. Using a normalization of Δ at κ if necessary, we can assume that $\kappa = (0, 0)$, that ϵ_1 is supported by the horizontal axis and that σ ends at $(m, 0)$. By Lemma 6.5, we can assume, without loss of generality, that σ starts at $(-1, 0)$. Consider the admissible graph \mathcal{G} of Figure 11, where the vertical edges have weight $-(l(m/(m \wedge l)) + l/(m \wedge l))$ and the horizontal edges have weight $-(m(l/(m \wedge l)) + m/(m \wedge l))$.

As $\tau_\sigma \in \text{im}(\mu)$, so is $(\tau_\sigma)^{l/(m \wedge l)}$. By Theorem 5, we have $\tau_{\mathcal{G}} \in \text{im}(\mu)$. Now using Proposition 6.7 and Lemma 6.3, we can chase any primitive integer segment of $\tau_{\mathcal{G}} \circ (\tau_\sigma)^{-l/(m \wedge l)} \in \text{im}(\mu)$ except σ' and deduce that $(\tau_{\sigma'})^{m/(m \wedge l)} \in \text{im}(\mu)$. \square

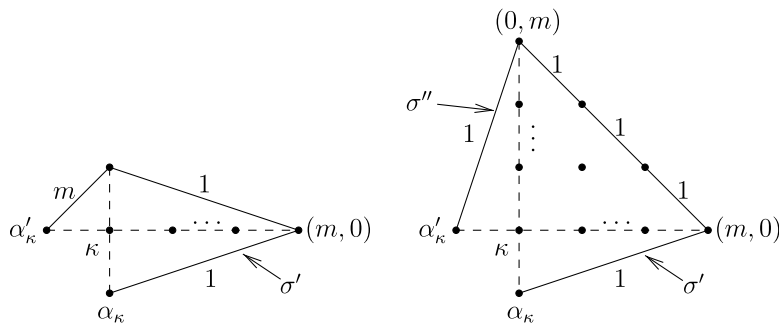


FIGURE 12. Admissible graphs \mathcal{G} (left) and \mathcal{G}' (right).

LEMMA 7.9. Let κ be a vertex of Δ_a and denote by ϵ_1 and ϵ_2 the two edges of Δ_a adjacent to κ . Also, let $\sigma \subset \Delta$ be a bridge ending at the point next to κ on ϵ_1 . For any positive integer $m \leq \min\{l_{\epsilon_1}, l_{\epsilon_2}\}$ and any bridge $\sigma' \subset \Delta$ ending on ϵ_2 , then $(\tau_{\sigma'})^m \in \text{im}(\mu)$ if $(\tau_{\sigma})^m \in \text{im}(\mu)$.

Proof. Using a normalization of Δ at κ if necessary, we can assume that $\kappa = (0, 0)$ and that ϵ_1 is supported by the vertical axis. By Lemma 6.5, we can assume, without loss of generality, that σ joins $(-1, 0)$ to $(0, 1)$. Consider the admissible graphs \mathcal{G} and \mathcal{G}' of Figure 12, where the vertical edges have weight $-m - 1$ and the horizontal edges have weight $-2m$ for \mathcal{G} and $-m - 1$ for \mathcal{G}' . By Theorem 5, we have $\tau_{\mathcal{G}}, \tau_{\mathcal{G}'} \in \text{im}(\mu)$. Using Proposition 6.7 and Lemma 6.3, we can chase any primitive integer segment of $\tau_{\mathcal{G}} \circ (\tau_{\sigma})^{-1} \in \text{im}(\mu)$ except σ' and deduce that $\tau_{\sigma'} \in \text{im}(\mu)$. Using, again, Proposition 6.7 and Lemma 6.3, we can chase any primitive integer segment of $\tau_{\mathcal{G}'} \circ (\tau_{\sigma'})^{-1} \in \text{im}(\mu)$ except σ'' and deduce that $\tau_{\sigma''} \in \text{im}(\mu)$. To conclude, we can apply Lemma 7.8 to the vertex κ and the primitive integer segment σ'' . \square

Proof of Proposition 7.7. Let ϵ_1 and ϵ_2 be two consecutive edges of Δ_a intersecting at the vertex κ . We first claim that, for any bridge σ ending on $\epsilon_1 \cup \epsilon_2$, we have $(\tau_{\sigma})^{l_{\epsilon_1} \wedge l_{\epsilon_2}} \in \text{im}(\mu)$. Without loss of generality, we may assume that $l_{\epsilon_1} \geq l_{\epsilon_2}$ and consider the normalization of Δ at κ such that ϵ_1 is horizontal. Let ξ be the other end of ϵ_2 .

Since ξ is a vertex, we know from Proposition 6.6 that if σ' is a bridge ending at ξ then $\tau_{\sigma'} \in \text{im}(\mu)$. Using Lemma 7.8 and then Lemma 7.9, we deduce that for any bridge σ ending on $\epsilon_1 \cup \epsilon_2$, we have $(\tau_{\sigma})^{l_{\epsilon_2}} \in \text{im}(\mu)$.

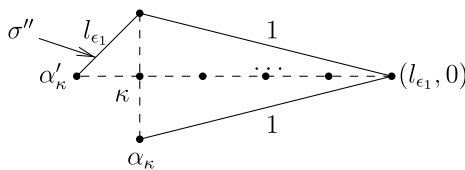


FIGURE 13. Admissible graph \mathcal{G}'' .

Now consider the weighted graph \mathcal{G}'' given in Figure 13 where the horizontal edges have weight $-2l_{\epsilon_1}$ and the vertical edges have weight -2 .

This graph is admissible, so by Theorem 5, we know that $\tau_{\mathcal{G}''} \in \text{im}(\mu)$. Using Propositions 6.6 and 6.7, as well as Lemma 6.3, we obtain that $(\tau_{\sigma''})^{l_{\epsilon_1}} \in \text{im}(\mu)$ and thus $(\tau_{\sigma''})^{l_{\epsilon_1} \wedge l_{\epsilon_2}} \in \text{im}(\mu)$.

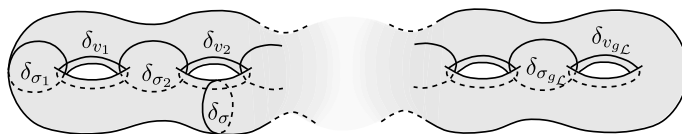


FIGURE 14. Loops $\delta_{\sigma_1}, \dots, \delta_{\sigma_{g_{\mathcal{L}}}}$ and δ_{σ} in C_0 .

Applying Lemma 7.9 twice, we deduce that, for any bridge σ ending on $\epsilon_1 \cup \epsilon_2$, we have that $(\tau_{\sigma})^{l_{\epsilon_1} \wedge l_{\epsilon_2}} \in \text{im}(\mu)$; this proves the claim.

Using this claim and Lemma 7.9, we show by induction that, for any k consecutive edges $\epsilon_1, \dots, \epsilon_k$ of Δ_a , we have $(\tau_{\sigma})^{l_{\epsilon_1} \wedge \dots \wedge l_{\epsilon_k}} \in \text{im}(\mu)$ for all bridges σ ending on $\epsilon_1 \cup \dots \cup \epsilon_k$. The result follows. \square

The proof of the case $d = 2$ in Theorem 1 involves finding a family of Dehn twists in the image of the monodromy, which generates the mapping class group. This family will appear as a ‘snake’ in Δ .

DEFINITION 7.10. A snake in the polygon Δ is a family of primitive integer segments $\sigma_1 = [v_0, v_1], \sigma_2 = [v_1, v_2], \dots, \sigma_{g_{\mathcal{L}}} = [v_{g_{\mathcal{L}}-1}, v_{g_{\mathcal{L}}}], \sigma$ in Δ , such that:

- (i) the point v_0 is a boundary point of Δ , while the points $v_1, \dots, v_{g_{\mathcal{L}}}$ are distinct points of Δ_a such that v_1 is a vertex of Δ_a and v_2 sits on $\partial\Delta_a$;
- (ii) two segments σ_i and σ_j intersect if and only if $|i - j| = 1$;
- (iii) the segment σ is a bridge ending at v_2 and disjoint from σ_1 .

Given a snake in Δ , the loops δ_{v_i} and δ_{σ_i} are arranged as in Figure 14.

LEMMA 7.11. *There always exists a snake $\sigma_1 = [v_0, v_1], \sigma_2 = [v_1, v_2], \dots, \sigma_{g_{\mathcal{L}}} = [v_{g_{\mathcal{L}}-1}, v_{g_{\mathcal{L}}}], \sigma$ in Δ . Moreover, if $\tau_{\sigma_1}, \dots, \tau_{\sigma_{g_{\mathcal{L}}}}, \tau_{\sigma}$ are in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_1}], \dots, [\tau_{\sigma_{g_{\mathcal{L}}}}], [\tau_{\sigma}]$ are in $\text{im}([\mu])$), the map μ (respectively $[\mu]$) is surjective.*

Proof. To prove the existence of a snake, choose a vertex κ of Δ_a and take a normalization of Δ at κ . Let $v_0 = (-1, 0), v_1 = \kappa, v_2 = (1, 0)$ and $\sigma = [(0, -1), (1, 0)]$. We number the rest of the lattice points in Δ_a by going through them in colexicographic order.

We know from Theorem 3 that, for $i = 1, \dots, g_{\mathcal{L}}$, the Dehn twist τ_{v_i} is in $\text{im}(\mu)$. The second part of the lemma then follows from Humphries’ theorem [Hum79], which states that the family $\tau_{\sigma_1}, \tau_{v_1}, \dots, \tau_{\sigma_{g_{\mathcal{L}}}}, \tau_{v_{g_{\mathcal{L}}}}$, and τ_{σ} generates the group $\text{MCG}(C_0)$. \square

Proof of Theorem 1, case $d = 2$ and $n = 1$. Assume that the largest order of a root of $K_X \otimes \mathcal{L}$ is 1. We know from Proposition 3.1 that $\text{gcd}(\{l_{\epsilon} \mid \epsilon \text{ edge of } \Delta_a\}) = 1$. Thus it follows from Proposition 7.7 that, for any bridge, the associated Dehn twist is in $\text{im}(\mu)$. Proposition 7.6 then

implies that, for any primitive integer segment σ joining two points of $\Delta \cap \mathbb{Z}^2$ not both on the boundary of Δ , we have $\tau_\sigma \in \text{im}(\mu)$. In particular, taking any snake in Δ , all the corresponding Dehn twists are in $\text{im}(\mu)$. Lemma 7.11 then gives the result we wanted. \square

7.4 $K_X \otimes \mathcal{L}$ odd

Proof of Theorem 2, case $d = 2$ and n odd. Since $K_X \otimes \mathcal{L}$ does not have a square root, the largest order of one of its roots is odd. Let us show that the algebraic monodromy $[\mu]$ is surjective on $\text{Sp}(H_1(C_0, \mathbb{Z}))$.

Notice first that since n is odd, we know from Proposition 3.1 that the greatest common divisor s of the lengths of the edges of Δ_a is odd.

Using Lemma 7.11, take a snake $\sigma_1 = [v_0, v_1], \sigma_2 = [v_1, v_2], \dots, \sigma_{g_{\mathcal{L}}} = [v_{g_{\mathcal{L}}-1}, v_{g_{\mathcal{L}}}], \sigma$ in Δ . We know from Proposition 7.7 that τ_σ^s is in $\text{im}(\mu)$.

Conversely, $[\tau_\sigma]^2$ is in $\text{im}([\mu])$. Indeed, we know from Propositions 6.6 and 6.7 and Theorem 3 that $[\tau_{\sigma_1}], [\tau_{\sigma_2}],$ and $[\tau_{v_1}]$ are in $\text{im}([\mu])$. Since both boundary components of a closed regular neighborhood of $\delta_{\sigma_1} \cup \delta_{v_1} \cup \delta_{\sigma_2}$ are homologous to δ_σ in C_0 if one orients them carefully, using the chain rule (see [FM11, Proposition 4.12]), we have

$$([\tau_{\sigma_1}][\tau_{v_1}][\tau_{\sigma_2}])^4 = [\tau_\sigma]^2 \in \text{im}([\mu]).$$

Since s is odd, we deduce that $[\tau_\sigma]$ is in $\text{im}([\mu])$. We apply Proposition 7.6 to deduce that, for any $i = 1, \dots, g_{\mathcal{L}}, [\tau_{\sigma_i}]$ is in $\text{im}([\mu])$. Lemma 7.11 provides the last piece of the proof. \square

7.5 About Conjecture 1

We show in this section that, when the adjoint bundle of \mathcal{L} admits a non-trivial root \mathcal{S} , we can still exhibit a lot of (powers of) Dehn twists in $\text{im}(\mu)$ and $\text{im}([\mu])$. This is a motivation for Conjecture 1 as well as a preparation for the results of [CL17]. Indeed, we will show in [CL17] that the conjecture is true when the highest order of a root of $K_X \otimes \mathcal{L}$ is 2.

Let $d \geq 1$ be an integer and $h_{1/d, \kappa}$ be the homothety of ratio $1/d$ and centered at κ . When $h_{1/d, \kappa}(\Delta_a)$ is again a lattice polygon, we say that Δ_a is divisible by d and we denote by $\Delta_a(d)$ the subset $h_{1/d, \kappa}^{-1}(h_{1/d, \kappa}(\Delta_a) \cap \mathbb{Z})$. Note that neither d nor $\Delta_a(d)$ depend on the choice of the vertex κ . In this case, we introduce a variation of the graphs $\mathcal{G}_{\kappa, \kappa', v}^{m_1, m_2}$ and $\mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2}$, which we will use to motivate conjecture 1.

Assume that $v = h_{1/d, \kappa}^{-1}(u) \in \Delta_a(d)$ and denote by $\mathcal{G}_{\kappa, \kappa', v}^{m_1, m_2}(d)$ (respectively $\mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2}(d)$) the following weighted graphs. The graph $G_{\kappa, \kappa', v}(d)$ (respectively $G_{\kappa', \kappa, v}(d)$) is given as the reunion of $h_{1/d, \kappa}^{-1}(G_{\kappa, \kappa', u} \cap \Delta_a)$ (respectively of $h_{1/d, \kappa}^{-1}(G_{\kappa', \kappa, u} \cap \Delta_a)$) and of the segments $[\alpha'_{\kappa}, h_{1/d, \kappa}^{-1}(\kappa')], [\alpha'_{\kappa}, \kappa],$ and $[\alpha_{\kappa}, \kappa]$. The weight function on $G_{\kappa, \kappa', v}(d)$ (respectively on $G_{\kappa', \kappa, v}(d)$) is equal to $m_{\kappa, \kappa', u}^{m_1, m_2} \circ h_{1/d, \kappa}$ (respectively to $m_{\kappa', \kappa, u}^{m_1, m_2} \circ h_{1/d, \kappa}$) inside Δ_a and adjusted on the last three segments to be balanced at κ and $h_{1/d, \kappa}^{-1}(\kappa')$. We denote by σ_1 and σ_2 the two primitive integer segments in $G_{\kappa, \kappa', v}(d)$ (respectively in $G_{\kappa', \kappa, v}(d)$) that have an end at v .

We have the analogue of Lemma 7.5. We omit its proof, as it is the same as that of Lemma 7.5.

LEMMA 7.12. *Let $d \geq 1$ be an integer and assume that Δ_a is divisible by d . Let $v \in \Delta_a(d)$.*

The weighted graphs $\mathcal{G}_{\kappa, \kappa', v}^{m_1, m_2}(d)$ and $\mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2}(d)$ satisfy the following properties.

- (i) *The edges $\sigma_1 = \sigma_{1,0}$ and $\sigma_2 = \sigma_{2,0}$ generate the lattice.*
- (ii) *The weight function $m_{\kappa, \kappa', v}^{m_1, m_2}$ (respectively $m_{\kappa', \kappa, v}^{m_1, m_2}$) satisfies the balancing condition (5) at every element of $V(G_{\kappa, \kappa', v}(d)) \cap \text{int}\Delta$ (respectively $V(G_{\kappa', \kappa, v}(d)) \cap \text{int}\Delta$), except at v .*

Assume, moreover, that there is a bridge σ' ending at $h_{1/d,\kappa}^{-1}(\kappa')$, such that $\tau_{\sigma'}$ is in $\text{im}(\mu)$ (respectively $[\tau_{\sigma'}]$ is in $\text{im}([\mu])$). Then τ_{σ_1} and τ_{σ_2} are in $\text{im}(\mu)$ (respectively $[\tau_{\sigma_1}]$ and $[\tau_{\sigma_2}]$ are in $\text{im}([\mu])$). \square

PROPOSITION 7.13. *Let $d \geq 1$ be an integer and assume that Δ_a is divisible by d . Assume that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$) for any bridge σ' ending at a point in $\Delta_a(d)$. Then we have $\tau_\sigma \in \text{im}(\mu)$ (respectively $[\tau_\sigma] \in \text{im}([\mu])$) for any primitive integer segment $\sigma \subset \Delta$ such that the line supported by σ intersects $\Delta_a(d)$.*

Proof. The proof uses the same ideas as that of Proposition 7.6. Namely, let v and w be the two ends of σ . Let us denote by L the line supported by σ and u , a point in $\Delta_a(d) \cap L$. We may assume that v is on the segment $[u, w]$ and that $[u, w] \cap \Delta_a(d) = \{u\}$. We will only give the proof in the case where both u and w are in the interior of Δ_a , as the other cases follow the same pattern as in Proposition 7.6.

To this end, choose κ and ξ two consecutive vertices of Δ_a that are on the same side of L and such that the points u, w, ξ , and κ appear in this order when following the boundary of their convex hull in the clockwise orientation. Take a normalization of Δ at κ such that the edge $[\kappa, \xi]$ is horizontal.

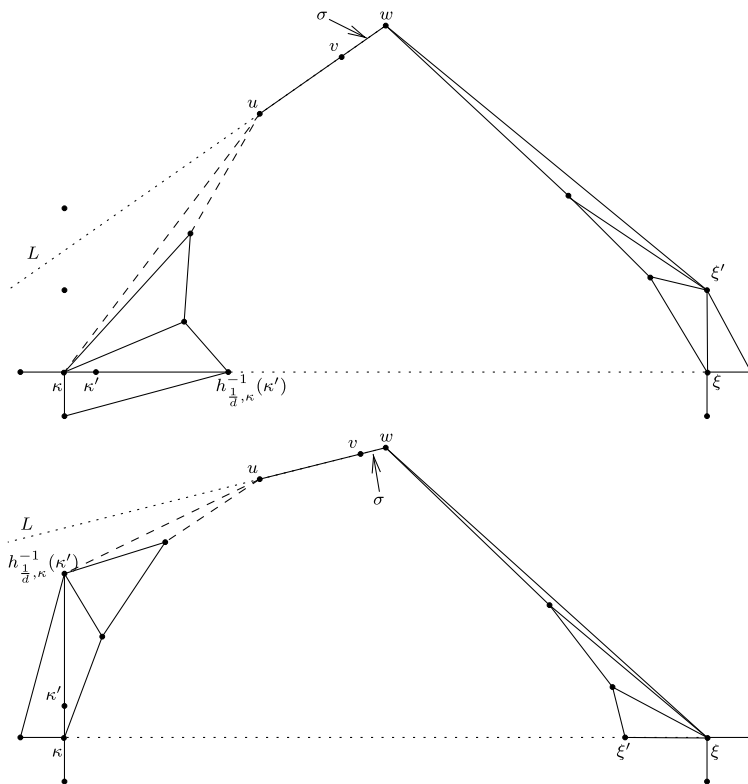


FIGURE 15. Rough sketch of the admissible graph \mathcal{G} in the two cases.

Since the roles of v and w are not the same, we will need to consider two cases. If the line L intersects the vertical line through κ in the interval $[\kappa, (0, d))$, take $\kappa' = (1, 0)$ and ξ' the boundary lattice point of Δ_a adjacent to ξ and not on the segment $[\kappa, \xi]$. In the other case, take $\kappa' = (0, 1)$ and ξ' the boundary point of Δ_a adjacent to ξ and on the segment $[\kappa, \xi]$. Now consider the graph G to be the reunion of $G_{\kappa',\kappa,u}(d)$, $[u, w]$ and $G_{\xi,\xi',w}$ in the first case and the reunion of $G_{\kappa,\kappa',u}(d)$, $[u, w]$ and $G_{\xi',\xi,w}$ in the second case (see Figure 15). Notice that, in the first case, the pentagon κ, u, w, ξ', ξ is convex and, in the second case, the pentagon $\kappa, h_{1/d,\kappa}^{-1}(\kappa'), u, w, \xi$ is convex. It can be shown, as in the proof of Proposition 7.6, that G is supported by a unimodular convex subdivision.

We next define a weighted graph $\mathcal{G} = (G, m)$. Let σ_1 and σ_2 (respectively η_1 and η_2) be the primitive integer segments in G going out of u (respectively out of w). Since σ_1 and σ_2 generate the lattice, choose m_1 and m_2 such that $\sigma + m_1\sigma_1 + m_2\sigma_2 = 0$ (where the orientations go out of u). In the same manner, choose m'_1 and m'_2 such that $\sigma + m'_1\eta_1 + m'_2\eta_2 = 0$ (where the orientations go out of w). In the first case, take the weight function m to be that of $\mathcal{G}_{\kappa',\kappa,u}^{m_1,m_2}(d)$ on $G_{\kappa',\kappa,u}(d)$, that of $\mathcal{G}_{\xi,\xi',w}^{m'_1,m'_2}$ on $G_{\xi,\xi',w}$, and equal to 1 on $[u, w]$. In the second case, take the weight function of $\mathcal{G}_{\kappa,\kappa',u}^{m_1,m_2}(d)$ on $G_{\kappa,\kappa',u}(d)$, that of $\mathcal{G}_{\xi',\xi,w}^{m'_1,m'_2}$ on $G_{\xi',\xi,w}$, and equal to 1 on $[u, w]$. The weighted graph \mathcal{G} is admissible, so from Theorem 5, we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$. The conclusion is the same as in Proposition 7.6.

The cases where at least one of the ends of $[u, w]$ is not in $\text{int}(\Delta)$ can be treated in the same way as in Proposition 7.6. \square

As we noticed in Corollary 2.8, when Δ_a is divisible by an integer $d > 1$, we cannot have $\tau_\sigma \in \text{im}(\mu)$ for all primitive integer segments in Δ . However, we have the following two statements.

LEMMA 7.14. *Let $d > 1$ be an integer and assume that Δ_a is divisible by d . Assume that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$) for any bridge σ' ending at a point in $\Delta_a(d)$. Let $w \in \Delta_a$ be an interior lattice point, κ any vertex of Δ_a , and κ' and κ'' the lattice points of $\partial\Delta_a$ next to κ on each side. Then, for any integers m_1 and m_2 ,*

$$(\tau_{\mathcal{G}_{\kappa,\kappa',w}^{m_1,m_2}})^d, (\tau_{\mathcal{G}_{\kappa',\kappa,w}^{m_1,m_2}})^d, (\tau_{\mathcal{G}_{\kappa,\kappa'',w}^{m_1,m_2}})^d, (\tau_{\mathcal{G}_{\kappa'',\kappa,w}^{m_1,m_2}})^d \in \text{im}(\mu).$$

We prove this lemma after the following proposition.

PROPOSITION 7.15. *Let $d > 1$ be an integer and assume that Δ_a is divisible by d . Assume that $\tau_{\sigma'} \in \text{im}(\mu)$ (respectively $[\tau_{\sigma'}] \in \text{im}([\mu])$) for any bridge σ' ending at a point in $\Delta_a(d)$. Then for any primitive integer segment $\sigma \subset \Delta$, we have $\tau_{\sigma}^d \in \text{im}(\mu)$ (respectively $[\tau_{\sigma}]^d \in \text{im}([\mu])$).*

Proof. The idea of the proof is similar to that of Proposition 7.6. Namely, if v and w denote the two ends of σ , we first assume that they are both in the interior of Δ_a and we consider exactly the same weighted graph $\mathcal{G} = (G, m)$ as in Proposition 7.6. Recall that it contains two subgraphs, $\mathcal{G}_1 = \mathcal{G}_{\kappa', \kappa, v}^{m_1, m_2}$ and $\mathcal{G}_2 = \mathcal{G}_{\xi, \xi', w}^{m'_1, m'_2}$. From Theorem 5, we know that $\tau_{\mathcal{G}_1} \tau_{\mathcal{G}_2} \tau_{\sigma} \in \text{im}(\mu)$. Lemma 7.14 gives us the conclusion we want.

The cases where one of the ends is not in the interior of Δ_a can be proved in the same way. We leave it to the reader. \square

Proof of Lemma 7.14. Recall that σ_1 and σ_2 are the two primitive integer segments in $\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}$ going out of w . Let us first show that if $\tau_{\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}} \in \text{im}(\mu)$ then for any vertex ξ of Δ_a ,

$$\tau_{\mathcal{G}_{\xi, \xi', w}^{a_1, a_2}}, \tau_{\mathcal{G}_{\xi, \xi'', w}^{b_1, b_2}}, \tau_{\mathcal{G}_{\xi', \xi, w}^{c_1, c_2}}, \tau_{\mathcal{G}_{\xi'', \xi, w}^{d_1, d_2}} \in \text{im}(\mu),$$

where the weights are chosen so that adding $m_1\sigma_1 + m_2\sigma_2$ balances each graph at w .

To this end, we can assume that ξ is a vertex next to κ , so that κ'' and ξ'' are on $[\kappa, \xi]$.

- (i) The weighted graph obtained by concatenating $\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}$ and $\mathcal{G}_{\xi, \xi', w}^{a_1, a_2}$ is admissible, so, by Theorem 5, $\tau_{\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}} \tau_{\mathcal{G}_{\xi, \xi', w}^{a_1, a_2}} \in \text{im}(\mu)$.
- (ii) The weighted graph obtained by concatenating $\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}$ and $\mathcal{G}_{\xi'', \xi', w}^{d_1, d_2}$ is admissible, so, by Theorem 5, $\tau_{\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}} \tau_{\mathcal{G}_{\xi'', \xi', w}^{d_1, d_2}} \in \text{im}(\mu)$.
- (iii) The weighted graph obtained by concatenating $\mathcal{G}_{\xi, \xi', w}^{a_1, a_2}$ and $\mathcal{G}_{\xi'', \xi', w}^{b_1, b_2}$ is admissible, so, by Theorem 5, $\tau_{\mathcal{G}_{\xi, \xi', w}^{a_1, a_2}} \tau_{\mathcal{G}_{\xi'', \xi', w}^{b_1, b_2}} \in \text{im}(\mu)$.

To prove that $\tau_{\mathcal{G}_{\xi', \xi, w}^{c_1, c_2}} \in \text{im}(\mu)$, we consider the vertex ζ next to ξ such that ξ' and ζ' are on $[\xi, \zeta]$.

We choose weights so that adding $m_1\sigma_1 + m_2\sigma_2$ balances the graph $\mathcal{G}_{\zeta', \zeta, w}^{e_1, e_2}$ at w .

- (i) The weighted graph obtained by concatenating $\mathcal{G}_{\xi, \xi'', w}^{b_1, b_2}$ and $\mathcal{G}_{\zeta', \zeta, w}^{e_1, e_2}$ is admissible, so, by Theorem 5, $\tau_{\mathcal{G}_{\xi, \xi'', w}^{b_1, b_2}} \tau_{\mathcal{G}_{\zeta', \zeta, w}^{e_1, e_2}} \in \text{im}(\mu)$.
- (ii) The weighted graph obtained by concatenating $\mathcal{G}_{\xi', \xi, w}^{c_1, c_2}$ and $\mathcal{G}_{\zeta', \zeta, w}^{e_1, e_2}$ is admissible, so, by Theorem 5, $\tau_{\mathcal{G}_{\xi', \xi, w}^{c_1, c_2}} \tau_{\mathcal{G}_{\zeta', \zeta, w}^{e_1, e_2}} \in \text{im}(\mu)$.

Thus, we obtain the result we wanted. Notice that the previous claim is still true if we assume that $\tau_{\mathcal{G}_{\kappa', \kappa, w}^{m_1, m_2}}$ is in $\text{im}(\mu)$ instead of $\tau_{\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}}$.

Now, choose a unimodular convex subdivision of $h_{1/d, \kappa}(\Delta_a)$. The point $h_{1/d, \kappa}(w)$ is in at least one of the triangles of this subdivision, possibly on its boundary. Let x, y , and z be the three vertices of the image of such a triangle by $h_{1/d, \kappa}^{-1}$. Denote by γ_1, γ_2 , and γ_3 , respectively, the primitive integer segments on $[x, w]$, $[y, w]$, and $[z, w]$ ending at w .

Let us now show that $(\tau_{\mathcal{G}_{\kappa, \kappa', w}^{m_1, m_2}})^d \in \text{im}(\mu)$. We proceed as in the proof of Proposition 7.13, using γ_1 in place of σ . Using the same notation, we obtain that $\tau_{\mathcal{G}_{\xi, \xi', w}^{m'_1, m'_2}} \in \text{im}(\mu)$ in the first case, and $\tau_{\mathcal{G}_{\xi', \xi, w}^{m'_1, m'_2}} \in \text{im}(\mu)$ in the second case for some vertex ξ of Δ_a . Using the claim we proved in the beginning, we have that

$$\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a_1, a_2}}, \tau_{\mathcal{G}_{\kappa', \kappa, w}^{b_1, b_2}}, \tau_{\mathcal{G}_{\kappa, \kappa', w}^{c_1, c_2}}, \tau_{\mathcal{G}_{\kappa'', \kappa, w}^{d_1, d_2}} \in \text{im}(\mu),$$

where the weights are chosen so that adding γ_1 with weight 1 balances the graph at w .

We do the same for γ_2 to prove that

$$\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a'_1, a'_2}}, \tau_{\mathcal{G}_{\kappa', \kappa, w}^{b'_1, b'_2}}, \tau_{\mathcal{G}_{\kappa, \kappa'', w}^{c'_1, c'_2}}, \tau_{\mathcal{G}_{\kappa'', \kappa, w}^{d'_1, d'_2}} \in \text{im}(\mu),$$

where the weights are chosen so that adding γ_2 with weight 1 balances the graph at w , and for γ_3 to obtain that

$$\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a''_1, a''_2}}, \tau_{\mathcal{G}_{\kappa', \kappa, w}^{b''_1, b''_2}}, \tau_{\mathcal{G}_{\kappa, \kappa'', w}^{c''_1, c''_2}}, \tau_{\mathcal{G}_{\kappa'', \kappa, w}^{d''_1, d''_2}} \in \text{im}(\mu),$$

where the weights are chosen so that adding γ_3 with weight 1 balances the graph at w .

Since $d\mathbb{Z}$ is included in the lattice generated by γ_1, γ_2 , and γ_3 , we can find integer combinations $\alpha_1\gamma_1 + \alpha_2\gamma_2 + \alpha_3\gamma_3 + d\sigma_1 = 0$ and $\beta_1\gamma_1 + \beta_2\gamma_2 + \beta_3\gamma_3 + d\sigma_2 = 0$. Thus,

$$\tau_{\mathcal{G}_{\kappa, \kappa', w}^{d, 0}} = (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a_1, a_2}})^{\alpha_1} (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a'_1, a'_2}})^{\alpha_2} (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a''_1, a''_2}})^{\alpha_3} \in \text{im}(\mu)$$

and

$$\tau_{\mathcal{G}_{\kappa, \kappa', w}^{0, d}} = (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a_1, a_2}})^{\beta_1} (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a'_1, a'_2}})^{\beta_2} (\tau_{\mathcal{G}_{\kappa, \kappa', w}^{a''_1, a''_2}})^{\beta_3} \in \text{im}(\mu).$$

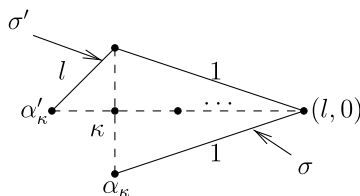


FIGURE 16. Weighted graph \mathcal{G} .

This implies that

$$(\tau_{\mathcal{G}_{\kappa, \kappa', w}}^{m_1, m_2})^d = (\tau_{\mathcal{G}_{\kappa, \kappa', w}}^{d, 0})^{m_1} (\tau_{\mathcal{G}_{\kappa, \kappa', w}}^{0, d})^{m_2} \in \text{im}(\mu).$$

We conclude the proof of Lemma 7.14 using the same argument for the three other graphs. \square

To be able to apply Propositions 7.13 and 7.15, we need to be able to say something about the bridges ending at a point of $\Delta_a(d)$.

PROPOSITION 7.16. *Let $s = \gcd(\{l_\epsilon \mid \epsilon \text{ edge of } \Delta_a\})$. If $v \in \Delta_a(s) \cap \partial\Delta_a$, then, for any bridge σ ending at v , we have $\tau_\sigma \in \text{im}(\mu)$. Moreover, if s is even and $v \in \Delta_a(2)$, then, for any bridge σ ending at v , we have $[\tau_\sigma] \in \text{im}([\mu])$.*

Proof. We may assume that v is not a vertex, as this case is taken care of by Proposition 6.6. Let $v \in \partial\Delta_a$ and let κ be a vertex of Δ_a next to v . Using a normalization at κ , we may assume that v is of the form $(l, 0)$ for some integer $l \geq 1$. Using Lemma 6.5, we may assume that σ joins v to $\alpha_\kappa = (0, -1)$. Now consider the weighted graph \mathcal{G} given in Figure 16, where the horizontal edges have weight $-2l$. This graph is admissible so, by Theorem 5, we know that $\tau_{\mathcal{G}} \in \text{im}(\mu)$.

If $v \in \Delta_a(s)$, we have $l = as$ for some integer $a \geq 1$. We know from Proposition 7.7 that $\tau_{\sigma'}^{as} \in \text{im}(\mu)$. Thus, applying Propositions 6.6 and 6.7 as well as Lemma 6.3, we obtain that $\tau_\sigma \in \text{im}(\mu)$.

If s is even and $v \in \Delta_a(2)$, then $l = 2a$ for some integer $a \geq 1$. Let σ' be the bridge joining $\alpha'_\kappa = (-1, 0)$ to $(0, 1)$. We do not have, in general, that $\tau_{\sigma'}^2 \in \text{im}(\mu)$. However, if we define $\sigma_1 = [\alpha_\kappa, \kappa]$ and $\sigma_2 = [\kappa, (0, 1)]$, the boundary of a regular neighborhood of $\delta_{\sigma_1} \cup \delta_\kappa \cup \delta_{\sigma_2}$ has two connected components both homologous to $\delta_{\sigma'}$ if one orients them carefully. Using the chain rule (see [FM11, Proposition 4.12]) we obtain that

$$([\tau_{\sigma_1}][\tau_\kappa][\tau_{\sigma_2}])^4 = [\tau_{\sigma'}]^2.$$

It follows then from Propositions 6.6 and 6.7, as well as Theorem 3, that $[\tau_{\sigma'}]^2 \in \text{im}([\mu])$. Using the previous construction, we conclude that $[\tau_\sigma] \in \text{im}([\mu])$. \square
