A BARONIAL FAMILY IN MEDIEVAL ENGLAND

The Clares, 1217 - 1314

by Michael Altschul, University of Michigan. This is the first consistent narrative of a thirteenth-century family to be written from the point of view of the earls themselves. Among English baronial families in this period, the Clares were the most successful in developing their lands and power. Mr. Altschul analyses the economic, administrative, and judicial organization of the family estates in England, Ireland, and the Welsh march and discusses the source of manorial income, the development and expansion of the manors, and the way in which land was used and cared for. Exhaustive use has been made of the unpublished family estate accounts and related documents, particularly the still unpublished late thirteenth-century judicial records of the Crown.
