

NOTES ON THE CONTRIBUTORS

ANDY BAKER is an associate professor in the Department of Political Science at the University of Colorado at Boulder. He conducts research on Latin America, mass political behavior, and international political economy. His articles have appeared in the *American Journal of Political Science*, *World Politics*, *Electoral Studies*, and other journals. Baker is the author of *The Market and the Masses in Latin America: Policy Reform and Consumption in Liberalizing Economies* (2009), about the impact of consumer interests on the nature of citizens' attitudes toward free-market policies in eighteen Latin American nations.

JUAN ARIEL BOGLIACCINI is a PhD candidate in political science with a concentration in comparative politics and methods at the University of North Carolina at Chapel Hill. He studies issues of welfare, income distribution, and productive systems with a comparative lens and a focus on Latin America and Southern Europe.

SIMONE BOHN is an associate professor of political science at York University, Toronto, Canada. Her main areas of research are public opinion in Latin America, political parties in South America, and gender and politics in Brazil.

JÜRGEN BUCHENAU is professor and chair of the History Department at the University of North Carolina at Charlotte. His research interests include the Mexican Revolution and the study of Mexican history in its global context. He received his PhD from the University of North Carolina at Chapel Hill. His books include *In the Shadow of the Giant: The Making of Mexico's Central America Policy, 1876–1930* (1996), *Tools of Progress: A German Merchant Family in Mexico City, 1865–Present* (2004), *Plutarco Elías Calles and the Mexican Revolution* (2006), *Mexican Mosaic: A Brief History of Mexico* (2008), and *The Last Caudillo: Álvaro Obregón and the Mexican Revolution* (2011). He has also edited three other books.

DAVID CUPERY is a graduate student in the Department of Political Science at the University of Colorado at Boulder. He conducts research on Latin America, public opinion, and political economy in the developing world. He is writing a dissertation that examines the determinants and impact of mass perceptions of great powers.

JEAN DAUDELIN is associate professor at Carleton University's Norman Paterson School of International Affairs. His current research focuses on Brazilian foreign policy and drug violence in the Americas. Among his recent publications are the following: "Brasil y la desintegración de las Américas" (2012); "A New Drug Warrior? Canada's Security Policy towards Mexico, Central America, and the Caribbean" (2012); "Two Hubs, Many Spokes, No Frame: The Shape of Post-American Americas" (2012); with Sean Burges, "Moving In, Carving Out, Proliferating: The Many Faces of Brazil's Multilateralism since 1989" (2011); and "Le Brésil comme puissance: Portée et paradoxes" (2010).

JOSÉ DEL TRONCO holds a PhD in social and political science from the Universidad Nacional Autónoma de México. He is a full-time professor at Facultad Latinoame-

ricana de Ciencias Sociales (FLACSO) México, where he has been director of the Master's Program in Comparative Public Policy. Currently, he is coordinating a research program on public policy and democracy in Latin America.

JOEL HOROWITZ is a professor of history at St. Bonaventure University. He is a historian of modern Argentina and is currently working on a monograph on civic associations in Buenos Aires. He is the author of *Argentine Unions, the State and the Rise of Perón, 1930–1945* (1990) and *Argentina's Radical Party and Popular Mobilization, 1916–1930* (2008). He has also published extensively on labor, politics, and historiography.

JULIANA MARTÍNEZ FRANZONI is associate professor at the University of Costa Rica, where she is affiliated with the Institute of Social Research and the Center of Political Studies and Research. Her work focuses on social policy formation and socioeconomic and gender inequality in Latin America. With support from the British Academy, her joint investigation with Diego Sánchez-Ancochea addresses the formation of universal social policies in the periphery.

CARMEN MARTÍNEZ NOVO is associate professor of anthropology and director of the Latin American, Caribbean, and Latino Studies Program at the University of Kentucky. She is the author of *Who Defines Indigenous?* (2006) and editor of *Repensando los movimientos indígenas* (2009). She has written numerous peer-reviewed articles and book chapters on indigenous identities and indigenismo in Mexico and Ecuador. She is the recipient of a post-PhD scholarship from the Wenner-Gren Foundation and has been visiting professor at the Johns Hopkins University, Grinnell College, Universidad Central (Colombia), Universidad Iberoamericana (Mexico), and University of Lleida (Spain).

TIMOTHY J. POWER is university lecturer in Brazilian studies and fellow of St. Cross College at the University of Oxford. A former president of the Brazilian Studies Association, he currently directs the Brazilian Studies Program at Oxford. With Paul Chaisty and Nic Cheeseman, he is presently engaged in a three-year Economic and Social Research Council project on coalitional presidentialism in Africa, Latin America, and postcommunist Europe. His most recent book, coedited with Matthew M. Taylor, is *Corruption and Democracy in Brazil: The Struggle for Accountability* (2011).

DIEGO SÁNCHEZ-ANCOCHEA is university lecturer in the political economy of Latin America at the University of Oxford and Governing Body fellow at St. Antony's College. His research has concentrated on state-society relations in small Latin American countries, the role of foreign investment in the process of development, and the analysis of public policy. He is currently working on the study of changes in income distribution in Latin America as well as the determinants of universal social policy (all in collaboration with Professor Juliana Martínez Franzoni).

MARIELA SZWARCBERG is an assistant professor at Reed College. Her research focuses on understanding the incentives that lead to the persistence of clientelism in consolidated democracies. She is also interested in questions of political participation, voter turnout, and gender and development in new democracies. Szwarc-

berg holds a PhD in political science from the University of Chicago and has published articles in *Comparative Politics*, *Social Networks*, *Latin American Politics and Society*, *Nueva Sociedad*, and *Women's Policy Journal of Harvard*.

KIRSTEN WELD is assistant professor of history at Harvard University. She is a historian of modern Latin America, specializing in twentieth-century Mexico, Central America, and the Southern Cone. Her research interests include revolutionary and counterrevolutionary movements; the Cold War; dictatorships and transitional justice; memory; indigenous and First Nations history; and the politics of history, history writing, and archival access in society writ large. Her first book, *Paper Cadavers: The Archives of Dictatorship in Guatemala*, is forthcoming from Duke University Press and is a historical and ethnographic study of the archives generated by Guatemala's National Police. Weld holds a doctorate from Yale University. She previously taught at Brandeis University as the Florence Levy Kay Fellow in Latin American History.

ZAC ZIMMER is an assistant professor of Spanish at Virginia Tech. His research explores questions of literature, aesthetics, politics, and technology in Latin America. His next project, tentatively titled "First Contact," is a comparative study of Latin American science fiction and narratives of the sixteenth-century conquest of the Americas.

CESAR ZUCCO is an assistant professor in the Department of Political Science at Rutgers University. He received his PhD from UCLA and has held visiting positions at Princeton, Yale, and Instituto de Estudos Sociais e Políticos (IESP, formerly Instituto Universitário de Pesquisas do Rio de Janeiro, IUPERJ). His major current projects are on partisan identification and on the politics of conditional cash transfer programs. With Timothy J. Power, he coedited *O Congresso por ele mesmo: Autopercepções da classe política brasileira* (2011). His articles have appeared in *Journal of Politics*, *Legislative Studies Quarterly*, *Electoral Studies*, and various Latin American studies journals.
