The Structure and Foundations of Prudential and Moral Arguments and their Exemplification in Discourse, by D. P. GAUTHIER. This study presents an account of the derivation of judgements about what to do, from premises, which, it is argued, must concern wants. The argument is developed first at the prudential level. Here the relevant premises concern what is worth wanting by the agent. The argument then proceeds to the moral level, at which what is worth wanting by any rational agent is relevant. The account is illustrated and expanded by an examination of our practical discourse, emphasizing expressions of advice and counsel. Finally, an outline of principles, obligations and duties is presented, showing their role in the derivation of practical judgements. (\$6.50)
