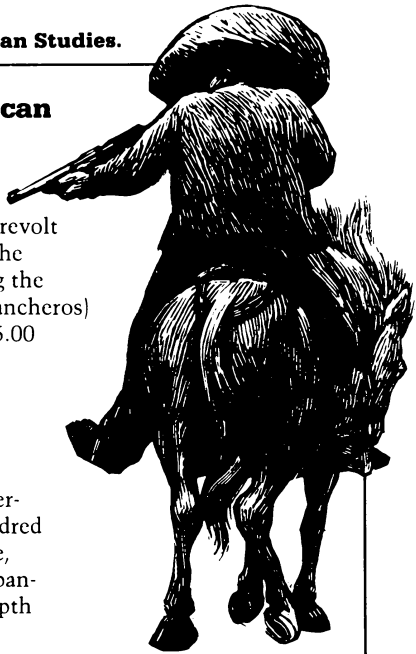

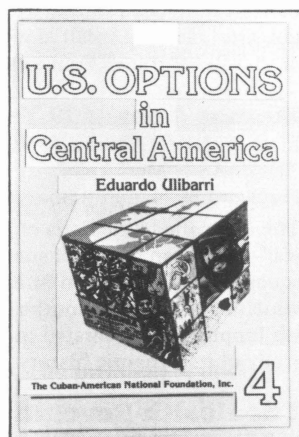

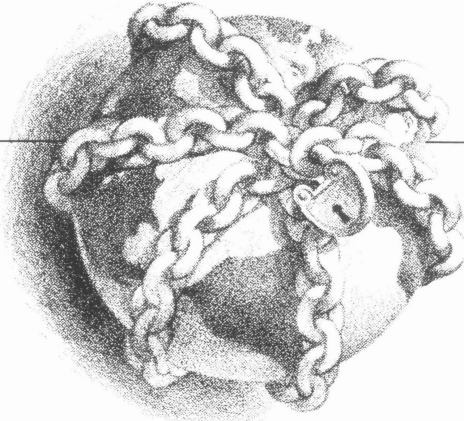

S LAVERY AND SOCIAL DEATH

A Comparative Study

Orlando Patterson

This monumental work is the first, full-scale comparative study of the nature of slavery. Drawing on sixty-six tribal, ancient, pre-modern, and modern societies over time, Patterson shows that slavery is a parasitic relationship involving the violent domination of an alienated—or socially dead—person.

He argues that the phenomenon of slavery as an institution is a single process of recruitment, incorporation on the margin of society, and leads to eventual manumission or death.

Rejecting the legalistic Roman concept of slavery, Patterson emphasizes the sociological, symbolic, and ideological aspects of the institution and uncovers a disquieting relationship between slavery and freedom.

NOTES ON THE CONTRIBUTORS

KENNETH M. COLEMAN is Associate Professor of Political Science at the University of Kentucky. **CHARLES L. DAVIS** is Associate Professor of Political Science at the University of Kentucky Center at Fort Knox. Professors Coleman and Davis, together with Francisco Zapata, Oly Lozada de Izcaray, and Fausto Izcaray, are engaged in a comparative study of the politicization of workers in Venezuela and Mexico.

STEPHEN G. BUNKER conducted research on organizational change and economic development in rural areas of Uganda, Guatemala, and Brazil from 1969 to 1978, when he joined the Department of Sociology at the University of Illinois. He is now completing a monograph on the demographic, ecological, and political effects of extractive-export economies in the Amazon Basin over the past 380 years.

SAMUEL FARBER is Assistant Professor of Sociology at Brooklyn College and at the Graduate School of the City University of New York. He is the author of *Revolution and Counterrevolution in Cuba, 1933–1960*, which appeared in 1976.

JOSEPH S. TULCHIN served as both Associate Editor and Editor of *LARR* from 1974 to 1982. A Professor of History at the University of North Carolina, he has recently become Director of the Office of International Programs.

DAVID P. GEGGUS is the author of *Slavery, War and Revolution: The British Occupation of Saint Domingue (1982)* and is Assistant Professor of History at the University of Florida in Gainesville.

THOMAS LYLE WHIGHAM is a doctoral candidate in Latin American History at Stanford University. His research interests focus on the economic history of the Rio de la Plata during the early modern period. He is currently engaged in research in that region. **JERRY W. NAOMI LINDSTROM is Associate Professor of Spanish at the University of Texas at Austin. She is the author of *Literary Expressionism in Argentina and Macedonio Fernández*.

LOUIS A. PÉREZ, JR., is Professor of History at the University of South Florida.

MARK SIDEL is a graduate of Princeton University, where he studied with Stanley Stein, and of Yale University, where he studied with Emilia Viotti da Costa and Peter Winn. Fluent in Chinese as well as Spanish, he served as the first North American visiting lecturer at the Institute of Latin American Studies of the Chinese Academy of Social Sciences in 1980–81. He is now a student at the Columbia University School of Law.

ABRAHAM F. LOWENTHAL has headed the Wilson Center's Latin American Program since its inception in January 1977. He previously served as Director of Studies at the Council on Foreign Relations. He has authored and co-authored numerous books and articles on Latin America, including *The Dominican Intervention*, *The Peruvian Experiment*, *Armies and Politics in Latin America*, and *Latin America's Emergence*. Currently he is working on a book on U.S.-Latin American relations.
