GERRIT DWOROK is a visiting lecturer at the University of Würzburg (Lehrstuhl für Neueste Geschichte, Universität Würzburg, Am Hubland, 97074 Würzburg, Germany; email: gerrit.dworpok@uni-wuerzburg.de). He is the author of “*Historikerstreit*” und *Nationswerdung: Ursprünge und Deutung eines bundesrepublikanischen Konflikts* (2015). He has also published chapters, interviews, and essays in edited volumes, as well as in a number of books that he coedited, including *The Means to Kill: Essays on the Interdependence of War and Technology from Ancient Rome to the Age of Drones* (2016) and *1968 und die 68er. Ereignisse, Wirkungen und Kontroversen in der Bundesrepublik* (2013). His current research deals with the concepts of nation and nationalism in West German history teaching.

RICHARD J. EVANS is Regius Professor Emeritus of History at the University of Cambridge and Provost of Gresham College (Barnard’s Inn Hall, Holborn, London EC12HH, United Kingdom; email: rje36@cam.ac.uk). He is the author of numerous books on modern German history, including, most recently, *The Third Reich in History and Memory* (2015). He was the principal expert witness in the libel action brought before the High Court in London against Deborah Lipstadt in 2000, as depicted onscreen in the motion picture *Denial*. He has published a large-scale history of the Third Reich in three volumes (2003–2008), and has been coeditor of the *Journal of Contemporary History* since 2000. His most recent book is *The Pursuit of Power: Europe 1815–1914* (volume 7 in the Penguin History of Europe), and he is currently working on a biography of the historian Eric Hobsbawm.

MARY FULBROOK, FBA, is professor of German history and executive dean of the Faculty of Social and Historical Sciences at University College London (Department of German, UCL, Gower Street, London WC1E 6BT, United Kingdom; email: m.fulbrook@ucl.ac.uk). Fulbrook is the author or editor of twenty-five books, and has been awarded major research grants from the Arts and Humanities Research Council and the Leverhulme Trust. Her latest book, *Reckonings: Legacies of Nazi Persecution*, is forthcoming in 2018. Recent publications include the Fraenkel Prize-winning *A Small Town near Auschwitz: Ordinary Nazis and the Holocaust* (2012), and *Dissonant Lives: Generations and Violence through the German Dictatorships* (2011). One of her major research areas has been the German Democratic Republic, on which she wrote *Anatomy of a Dictatorship: Inside the GDR, 1949–89* (1995), as well as *The People’s State: East German Society from Hitler to Honecker* (2005).

WENDY LOWER is the acting director of the Jack, Joseph, and Morton Mandel Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum and professor of history at Claremont McKenna College (850 Columbia Avenue Claremont, CA 91711; email: wlower@cmc.edu). She is the author of *Nazi Empire-Building and the Holocaust in Ukraine* (2005), *The Diary of Samuel Goford and the Holocaust in Galicia* (2011), *Hitler’s Furies: German Women in the Nazi Killing Fields* (2013), and coeditor (with Ray Brandon) of *Shoah in*

*Ukraine: History, Testimony, Memorialization* (2008). She is completing a study of atrocity photography and Holocaust research.

A. DIRK MOSES is professor of modern history at the University of Sydney, where he has taught since 2000 (Department of History, University of Sydney, NSW 2006, Australia; email: [dirk.moses@sydney.edu.au](mailto:dirk.moses@sydney.edu.au)). Between 2011 and 2016, he was professor of Global and Colonial History at the European University Institute in Florence. He is the author of *German Intellectuals and the Nazi Past* (2007), as well as publications on memory, genocide, and mass violence, including *Postcolonial Conflict and the Question of Genocide: The Nigeria-Biafra War, 1967–1970* (coedited with Lasse Heerten, 2017). He is senior editor of the *Journal of Genocide Research* and is finishing an intellectual history of the concept of genocide.

JEFFREY K. OLICK is William R. Kenan, Jr. Professor of Sociology and History at the University of Virginia, where he is chair of the sociology department (202 Randall Hall, PO Box 400766, Charlottesville, VA 22904; email: [jko3k@eservices.virginia.edu](mailto:jko3k@eservices.virginia.edu)). The cofounder and codirector of the Memory Studies Association, he is the editor of *The Collective Memory Reader* (with Vered Vinitzky-Seroussi and Daniel Levy, 2010), and his most recent book is *The Sins of the Fathers: Germany, Memory, Method* (2016).

KATRIN SCHREITER is lecturer in German and European Studies at King's College London (Department of European & International Studies, 22 Kingsway, London, WC2B 6LE, United Kingdom; email: [katrin.schreiter@kcl.ac.uk](mailto:katrin.schreiter@kcl.ac.uk)). Her research focuses on gender, collective identity formation, and more recently, the interplay of economics and culture of the Cold War era, and how these areas are connected to the politics of German and European diplomacy. She has published one article, "European aesthetic convergence and the Common Market: A case study of Cold War East and West Germany," in the edited volume *Europeanisation in the 20th century: The historical lens* (2012), and is the author of a number of contributions to the *Bloomsbury Encyclopaedia of Design* (2015). Her monograph *Designing one nation: The politics of economic culture and trade in divided Germany, 1949–1990* is under contract with an academic press.

TIMOTHY D. SNYDER is the Levin Professor of History at Yale University (Department of History, 320 York Street, P.O. Box 208324, New Haven, CT 06520; email: [timothy.snyder@yale.edu](mailto:timothy.snyder@yale.edu)). He is the author of many books, including *Nationalism, Marxism, and Modern Central Europe: A Biography of Kazimierz Kelles-Krauz* (1997), *The Reconstruction of Nations: Poland, Lithuania, Belarus, Ukraine, 1569–1999* (2003), *Sketches from a Secret War: A Polish Artist's Mission to Liberate Soviet Ukraine* (2005), *The Red Prince: The Secret Lives of a Habsburg Archduke* (2008), *Bloodlands: Europe Between Hitler and Stalin* (2010), *Black Earth: The Holocaust as History and Warning* (2015), *On Tyranny: Twenty Lessons from The Twentieth Century* (2017), two collections of essays—*Russian Politics, Ukrainian Histories, European Futures* (2014) and *The Politics of Life and Death* (2015)—and, along with Tony Judt, the book of conversation *Thinking the Twentieth Century* (2012). He is currently completing a contemporary history of postmodern right-wing politics in Russia, Europe, and the United States.

HEIDI J. S. TWOREK is assistant professor of international history at the University of British Columbia (Department of History, 1873 East Mall, Room 1297, Vancouver, BC V6T 1Z1, Canada; email: heidi.tworek@ubc.ca). Tworek is also a visiting fellow at the Center for History and Economics at Harvard University, and a nonresident fellow at the German Marshall Fund of the United States. Her current book project examines how Germans tried to control world communications in the first half of the twentieth century. Her articles on the history of media and international organizations have appeared in journals including *German History*, *Journal of Global History*, *History & Technology*, *International Journal of Communication*, and *Journal of Policy History*. She is the coeditor of two forthcoming volumes: a handbook on global business history and *Exorbitant Expectations: Communicating International Organizations in the 19th and 20th Centuries*. Finally, she manages the United Nations History Project ([www.unhistoryproject.org](http://www.unhistoryproject.org)), a website on the history of international organizations.

MATTHEW UNANGST is a postdoctoral teaching fellow in the Department of History at Washington State University (P.O. Box 644030, Pullman, WA 99164; email: matthew.unangst@wsu.edu). 

## *Editorial Policy*

*Central European History* publishes articles, review essays, and book reviews that range widely through the history of Germany, Austria, and other German-speaking regions of Central Europe from the medieval era to the present. All topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Contributions that treat new fields, such as post-1945 and post-1989 history, maturing fields such as gender history, and less-represented fields such as medieval history and the history of the Habsburg lands are especially desired. The journal thus aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editor prefers that manuscripts be submitted via ScholarOne (<https://mc.manuscriptcentral.com/ccc>). Please take care to remove author identifying information, following the prompts in ScholarOne, to make your manuscript anonymous. The entire text of all manuscripts, including endnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Endnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
