

NOTES ON THE CONTRIBUTORS

CRISTINA ADAMS is an assistant professor at the School of Arts, Sciences, and Humanities and the Interdisciplinary Research Center on Complex Systems at the University of São Paulo, Brazil. She has a master's degree in environmental science and a PhD in ecology, both from the University of São Paulo. She was a guest researcher at the Department of Geography and Geology, University of Copenhagen, in 2011, and at the Institute for Agricultural Economics and Social Sciences in the Tropics and Subtropics, Hohenheim University, in 2012. Her main research interests are the adaptability of peasant populations to neotropical rain forests, tropical agroforestry systems, and shifting cultivation.

FELIPE CURCÓ COBOS received a PhD from Barcelona University, Catalonia, Spain, and served as associate professor from 2005 to 2007. Currently he is a full-time professor at Instituto Tecnológico Autónomo de México (ITAM). Curcó is specialized in the area of philosophy and political theory. His books and articles focus on the analysis of constitutionalism, institutions and liberal democracies, and the problems of insecurity in Mexico.

SUSAN ECKSTEIN is past director of Latin American studies and professor of international relations and sociology at Boston University. She has written extensively on Mexico, Cuba, and Bolivia, as well as on immigration and its impact across country borders. Her book *The Immigrant Divide: How Cuban Americans Changed the U.S. and Their Homeland* (2009) received the Award for Best 2009 Book on Race, Ethnicity, Political Participation and Public Opinion from the American Political Science Association Section on Race, Ethnicity, and Politics (REP), and the American Sociological Association Section on Global and Transnational Sociology Award for Best Book in 2011. She also authored the prize-winning *Back from the Future: Cuba under Castro* (1994) and *The Poverty of Revolution: The State and Urban Poor in Mexico* (1988). In addition, Eckstein edited *Power and Popular Protest: Latin American Social Movements* (1989) and coedited books on social justice and social rights with Timothy Wickham-Crowley, and on immigrant impacts in their homelands with Adil Najam. She also is coeditor of a 2015 double issue of *Diaspora* that focuses on generational differences within diasporas. Eckstein has received grants and fellowships from the John Simon Guggenheim Memorial Foundation, the Russell Sage Foundation, the John D. and Catherine T. MacArthur Foundation, the Radcliffe Institute, the American Council of Learned Societies, the Social Science Research Council, the Rockefeller Foundation, the Institute for World Order, a Mellon-MIT grant, the Ford Foundation, and the Tinker Foundation.

CÉLIA FUTEMMA is a research scientist and professor at the Center for Research and Studies on Environment (NEPAM) at the University of Campinas in Brazil. She received her MA in cultural anthropology from Tulane University and her PhD from the School of Public and Environmental Affairs at Indiana University. She conducts research in the Amazon and the Atlantic rain forests. Her research interests include environmental anthropology, people and parks, institutional analysis and common-pool resources, and land use and land-cover dynamics.

He is also the associate editor of *Latin American Politics and Society*. His current research programs focus on the evolution of the developmentalist state in Brazil and the Southern Cone. His research has been published in several journals, including *Comparative Politics*, *Journal of Development Studies*, *West European Politics*, and *Latin American Politics and Society*. He is the author of *Brazil: Reversal of Fortune* (2014), *Brazilian Politics: Reforming a Democratic State in a Changing World* (2006), *Shifting States in Global Markets: Subnational Industrial Policy in Contemporary Brazil and Spain* (2002), and coeditor with David J. Samuels of *Decentralization and Democracy in Latin America* (2004).

LÚCIA CHAMLIAN MUNARI is a PhD student in the Department for Land Use Economics in the Tropics and Subtropics (Josef G. He is the author of a dozen articles and chapters on guerrillas, revolutionary movements, and theories of revolution, found in edited collections and in journals such as *Comparative Studies in Society and History*, *Social Science History*, *Politics and Society*, and *Sociological Forum*. He has published two monographs, *Exploring Revolution: Essays on Latin American Insurgency and Revolutionary Theory* (1991) and *Guerrillas and Revolution in Latin America: A Comparative Study of Insurgents and Regimes since 1956* (1992). The latter was nominated for the Distinguished Publication Award of the American Sociological Association. He also coedited with Susan Eckstein *What Justice? Whose Justice? Fighting for Fairness in Latin America* (2003) and *Struggles for Social Rights in Latin America* (2003). His current research and writings seek to explain both national and subnational differences in long-term socioeconomic development in the Americas since 1500.
