Harmsworth and Astbury Awards

The value of Scholarships from both Funds having been raised and provision made for Extension Awards, the following awards will be available in 1964.

Harmsworth and Astbury Scholarships

There will be not less than 10 such Scholarships available. These will normally be tenable for 3 years and will range between £300 and £500 per annum, depending on the qualifications of the successful applicants.

In 1963 there were awarded 2 Scholarships of £500 p.a., 7 of £400 p.a., and 4 of £300 p.a.: subject to the suitability of candidates it is intended that in 1964 Awards be made on a similar scale.

Extension Awards

A limited number of awards will be available to cover one further year after the expiry of a scholarship. The making of such an Award and its amount will depend on the circumstances of the individual candidate.

Harmsworth Entrance Exhibitions

There will be available, if suitable candidates present themselves:

- 6 Major Exhibitions of £130 (to cover admission fees and expenses and call fees).
- 12 Minor Exhibitions of £70 (to cover admission fees and expenses).

All the above Awards are open to any member of Oxford or Cambridge Universities who intends to practise at the Bar of England and Wales save that Astbury Scholarships are confined to male members who have been in residence at a College. Harmsworth Awards are also open to members of other Universities.

The latest dates by which nominations, recommendations, etc., must be lodged in each year are:

- ENTRANCE EXHIBITIONS—between 15th July and 15th November
- SCHOLARSHIPS —30th June
- EXTENSION AWARDS —20th May.

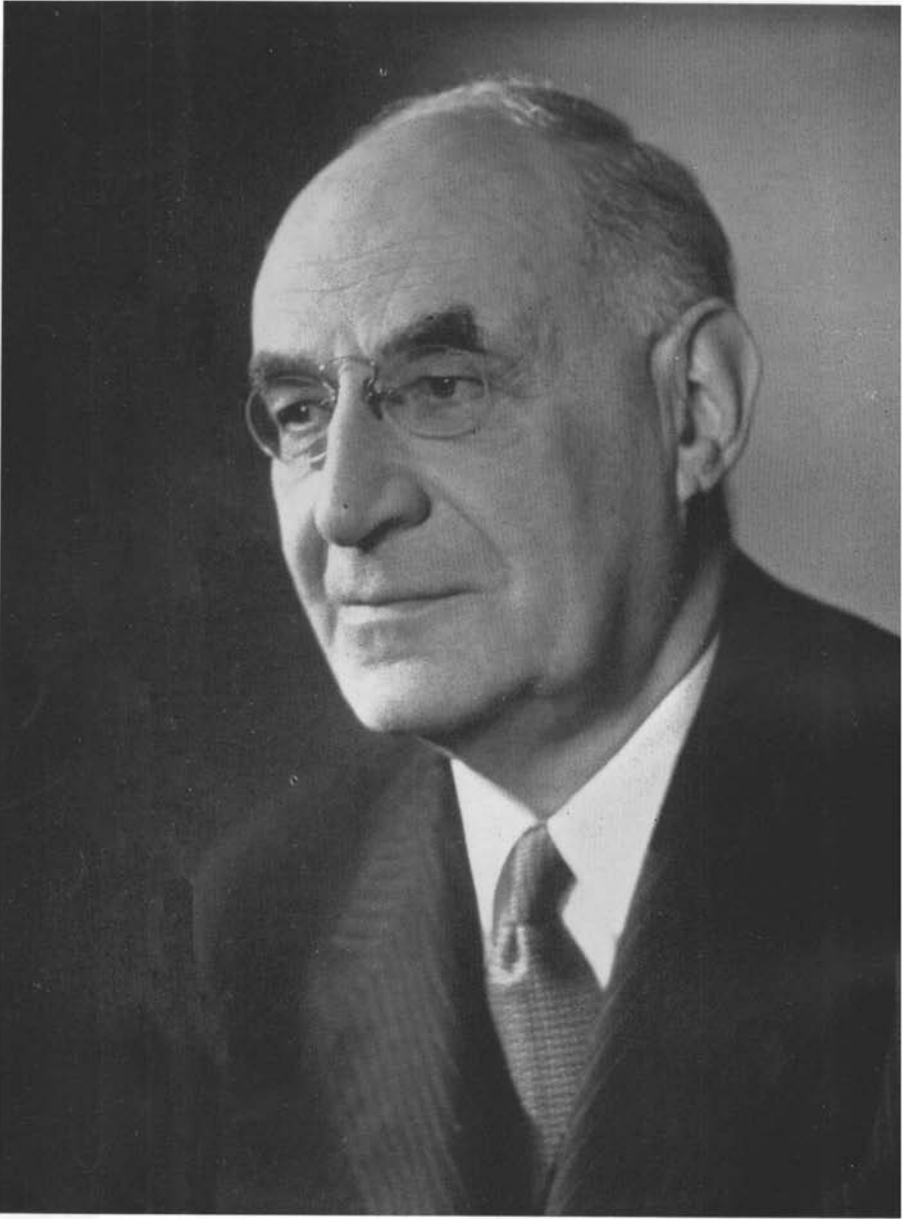
