Items from Irish and English Libraries cover every aspect of events in Ireland: medieval Latin manuscripts are concerned with Irish missionary activities in France, Italy, Spain, Germany and other European countries; and papers from the 16th century on deal mainly with careers of Irishmen in foreign military service and with Ireland's relations with other nations.

Entries are grouped under four main divisions: persons and institutions; subjects; places; and dates. The fifth division consists of Lists of Manuscrips by location.
