# Imprisonment in Medieval England

Mr. Pugh describes the uses of imprisonment and the location, types, custody and appearance of medieval prisons. He corrects prevailing misconceptions about their functions and administration, and the treatment of prisoners. He traces the growth of imprisonment for debt, and devotes several chapters to escaping and its consequences, and the trial of suspected felons.

By showing how the English prison system evolved, this book places in better perspective the conditions which prison reformers have tried to relieve.
