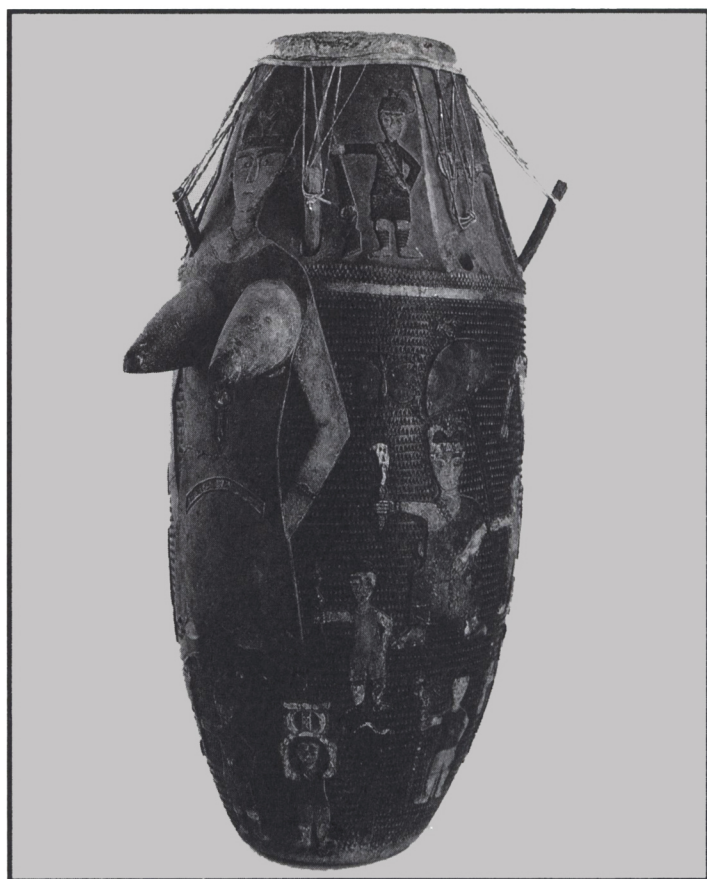

Manuscripts will be submitted anonymously to readers; please include a removable cover page giving name and address; title should be on the first page of text. Avoid self-identification as author throughout article. Include a 250-word abstract. The *ASR* will only consider manuscripts that have not been published elsewhere and are not being considered by other journals.

CONTRIBUTORS

MICHAEL BRATTON is Professor of Political Science and African Studies at Michigan State University. His most recent book, co-edited with Goran Hyden, is *Governance and Politics in Africa*, 1992. His current research projects concern political culture in Zambia and political transitions in Africa from a comparative perspective.

MICHAEL D. FORD is Dean of Multicultural Affairs and Assistant Professor of Politics and Education at Hampshire College. His writing and research have focused on the politics of the African state, with a recent emphasis on democratic transitions in East Africa.

FRANK W. HOLMQUIST is a professor of politics at Hampshire College. He has researched and written on peasant politics in East Africa and, of late, on democratic transitions in Africa.

CATHARINE NEWBURY teaches political science and African studies at the University of North Carolina at Chapel Hill. In addition to study of political transitions in Africa, her current research interests focus on gender, agrarian change and the politics of democratization in Rwanda and Zaire. She is the author of *The Cohesion of Oppression: Clientship and Ethnicity in Rwanda, 1860-1960*.

JULIUS E. NYANG'ORO is Associate Professor and Chairman of African and Afro-American Studies at the University of North Carolina at Chapel Hill. His latest publication is an edited volume: *Discourses on Democracy: Africa in Comparative Perspective*.

PEARL T. ROBINSON is Associate Professor of Political Science at Tufts University. The co-editor and co-author of *Transformation and Resiliency in Africa*, her recent work includes "Niger: Anatomy of a Neotraditional Corporatist State," "Grassroots Legitimation of Military Governance in Burkina Faso and Niger," and editorship of the "Rural Africa" issue of *Sage: A Scholarly Journal on Black Women*.

AILI MARI TRIPP received her doctorate from Northwestern University in 1990. She holds a joint appointment as an assistant professor in the Department of Political Science and the Women's Studies Program at the University of Wisconsin-Madison. She has published

numerous articles and chapters with particular reference to Tanzania and Uganda on the politics of economic liberalization, the informal economy, responses to structural adjustment and the political impact of women's associations.

FREDERICK S. WEAVER, a professor of economics and history at Hampshire College, is a Latin Americanist who, through team teaching with engaging colleagues, has been drawn into issues of African political economy.

JENNIFER A. WIDNER is Associate Professor in the Department of Government at Harvard University and directs the Africa Seminar of the Harvard Center for International Affairs. She is author of *The Rise of a Party-State in Kenya: From Harambee! to Nyayo!* and editor of *The Economics of Political Liberalization in Sub-Saharan Africa*. She has just completed a book that tries to explain the expansion of associational life in rural Africa.
