The CENTER FOR NATIONAL POLICY REVIEW is devoted to assuring that Federal laws and policies in urban areas are implemented to protect the interests of minority groups and the poor. We are a group of lawyers and social scientists engaged in research and legal action on behalf of the principal civil rights groups in the country, including the NAACP, the Urban League, and the National Urban Coalition.

As part of our purpose the CENTER will serve as a clearinghouse for social science research which has implications for Federal policies on equality of opportunity. We are soliciting brief summaries of such research which is either completed or in progress. Currently our principal concerns are with housing, credit practices, federal site selection, employment, and metropolitan school desegregation, but we welcome reports on research in other areas of civil rights concern such as welfare program administration, political participation, and revenue sharing. These research reviews will appear in a quarterly newsletter which will be sent to organizations involved in civil rights reform, urban studies centers, social scientists, and civil rights lawyers. 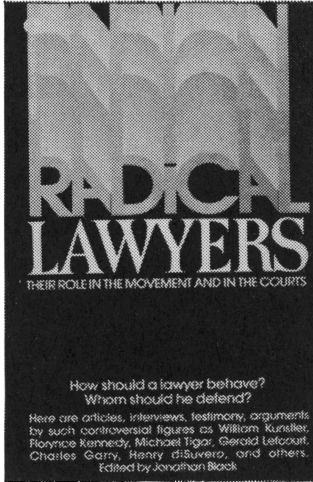

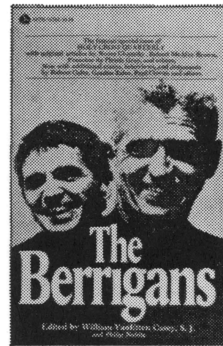

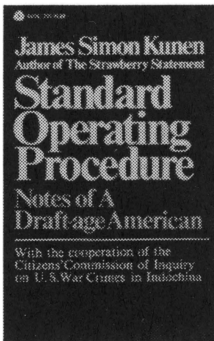
