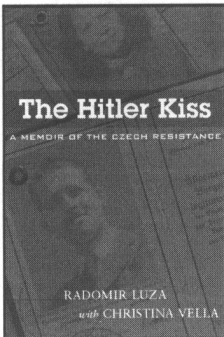

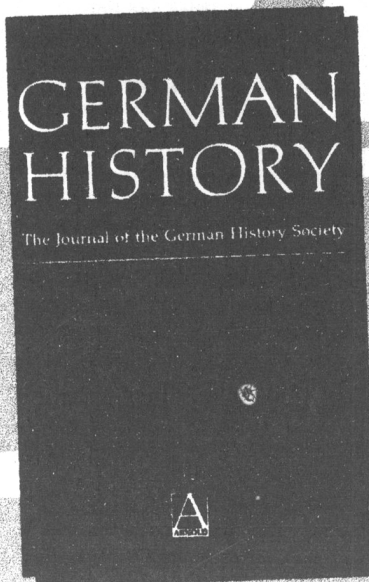

### The Land Question in Ukraine and Russia

*Stephen K. Wegren (\$7.50)*

In the Soviet period, Ukraine and Russia had similar agricultural systems. During the 1990s, however, the two diverged, as Russia pursued neo-liberal reforms while Ukraine maintained the Soviet system of agriculture. With new agrarian reforms introduced in Ukraine in late 1999 and into 2000, Ukraine may pass Russia, although significant obstacles remain.

### Nationalism, Culture, and Religion in Croatia since 1990

*Vjeran Pavlaković, editor (\$7.50)*

Far from being culturally homogeneous, Croatia is home to alternative ethnic, religious, and popular cultural currents, as Vjeran Pavlaković, Vjeko Perica, and Gordana Crnković show in successive chapters. Finally, there is the problematic Tudjman legacy, which, as Sabrina P. Ramet argues in an afterword, combines both positive and negative elements.

### Russian Policy Toward the Middle East under Yeltsin and Putin from 1991 to 2000

*Robert O. Freedman (\$7.50)*

Given its present greatly weakened geopolitical position, Moscow has had to reorient its policy toward the Middle East. Russian policy has had a special focus on Iran and Turkey, has sought to improve relations with Iraq, and has even developed close ties with Israel.

### Statistical Falsification in the Soviet Union: A Comparative Case Study of Projections, Biases, and Trust

*Mark B. Tauger (\$7.50)*

This paper evaluates the Soviet system of biological yield in a detailed comparative perspective. Based on a wide range of sources, the paper is a valuable case study of the early Stalin years.

#### INSTRUCTIONS FOR SUBMITTING MANUSCRIPTS

Manuscripts for consideration should be printed on a letter-quality or near letter-quality printer and submitted by post or courier in four double-spaced copies. Notes and block quotations should also be double-spaced; notes should be placed at the end of the manuscript and not at the bottom of the page. Library of Congress transliteration and the *Chicago Manual of Style* are to be followed. Manuscripts are sent to outside readers in anonymous form and should be prepared accordingly.

In general, articles should not exceed 8,000 words, excluding endnotes. Please indicate the word count on the cover page of the manuscript. Accepted manuscripts will be copyedited electronically, and authors will be asked to submit final versions on computer diskette. Submissions will not be returned.

The policy of *Slavic Review* is not to consider materials that have been published or that are being considered for publication elsewhere. *Slavic Review* is the journal of the American Association for the Advancement of Slavic Studies, whose members support the journal through their dues. *Slavic Review* expects the authors of articles published in the journal to belong to the association.
