For students, not only those studying commercial law, but also students of contract and property, **Commercial Law** will provide the best opportunity of learning what happens in commercial legal life and becoming acquainted, probably for the first time, with many vital commercial matters which have never been aired in the reported cases.

For legal practitioners, particularly those who do not specialise exclusively in commercial law, but nevertheless frequently need to draft and advise on commercial documents, **Commercial Law** will be invaluable.
