This work is a study of verbal behaviour. It centres on a type of grammatical mistake that has been attributed to a psychological influence called the "atmosphere effect". Although the particular verbal effect had been mentioned frequently, little had been done to establish its existence. The book seeks to coax the effect out and then to suggest likely explanations for it. After twenty experiments, involving more than eighteen hundred subjects, the author concludes that the effect indeed operates and that likely explanations for it are in terms of attention, memory or interpretation.
