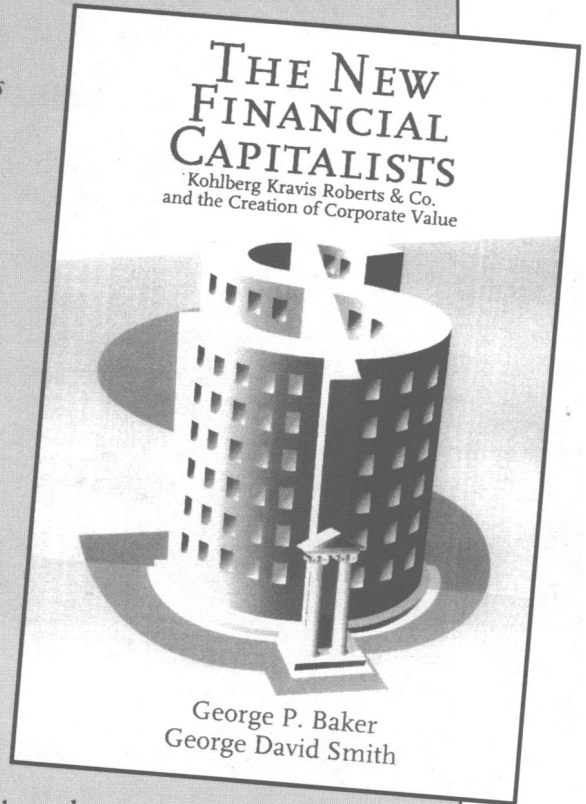

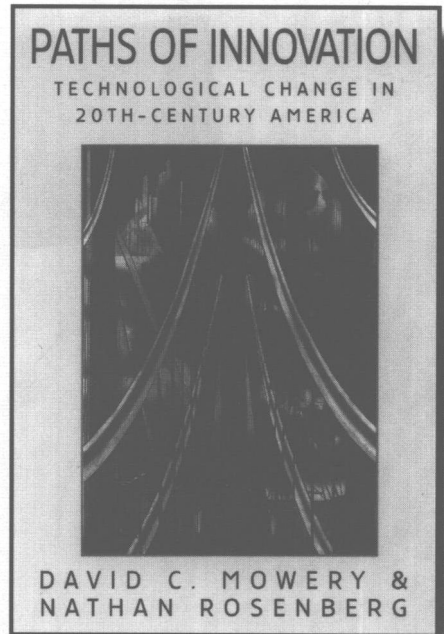

Between discovery and application, between invention and widespread use, there is a world of innovation, of tinkering and improvements and adaptations.

This is the world that David Mowery and Nathan Rosenberg map out in *Paths of Innovation*, an engaging tour of the intersecting routes of technological change and economic growth in twentieth-century America. The authors focus on three areas of innovation that have dominated American technology in this century: the internal combustion engine, electricity, and chemistry. Extremely pervasive in their use, these three clusters of innovation are also highly research-intensive, allowing Mowery and Rosenberg to explore the importance of both "science" and technological innovation and improvement in realizing the economic consequences of technological advances.

Throughout their book, Mowery and Rosenberg demonstrate that the simultaneous emergence of new engineering and applied science disciplines in the universities, in tandem with growth in the R&D industry and scientific research, has been a primary factor in the rapid rate of technological change. Innovation and incentives to develop new, viable processes have led to the creation of new economic resources—which will, in turn, determine the future of American technological innovation and economic growth.

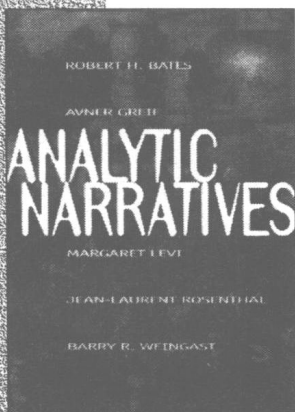

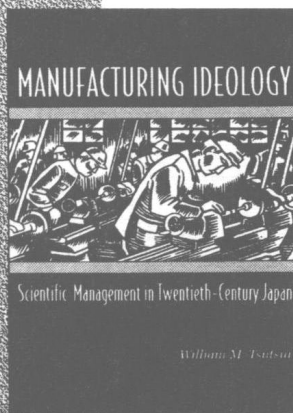
