

Cover: Scale and Scope

The great German electrical manufacturers Allgemeine Elektricitäts Gesellschaft (AEG) and Siemens exemplify the concept of scope economies developed by Alfred D. Chandler, Jr. With their massive works, complex technologies, global sales organizations, and heavy investments in R&D, they became leaders in the global oligopoly in electrical products. The front cover shows a department of the Berlin works of AEG in the 1900s that produced very large three-phase motors and transformers. The back cover shows two views of Siemens' Dynamowerk, part of the Siemensstadt complex in Berlin. The top photograph depicts Hall B, c. 1909, where large motor parts were made; the bottom illustration shows Hall A, c. 1913, where smaller cams, gears and other parts were manufactured.


Brian Gratton joined the department of history at Arizona State University in 1983, and he is now associate professor. He held resident research fellowships at the Hagley Museum and Library in 1988 and at the Archives of Labor and Urban Affairs (the Reuther Library) in 1989. He has just completed a social history of the American elderly, in collaboration with Carole Haber.

Mira Wilkins, professor of economics at Florida International University, holds a Ph.D. from Cambridge University. She has written extensively on the history of American and foreign multinational corporations. Her article is the third that Wilkins has published in the Business History Review on the history of Japanese enterprise in the United States. Her latest book is The History of Foreign Investment in the United States to 1914 (1989); she is now preparing the sequel, which will carry the story from 1914 to the present. Recently, she has edited an anthology entitled The Growth of Multinationals (1991).

John Williams is professor of economic history in the Department of Economics and Agricultural Economics at the University College of Wales, Aberystwyth, where Karel Williams is a senior lecturer; Colin Haslam is principal lecturer in business studies at the Polytechnic of East London. They have published several books and articles on manufacturing, including Why Are the British Bad at Manufacturing? (1983) and The Breakdown of Austin Rover (1987). They are currently working on a history of manufacturing techniques from Ford to Toyota, which will be published under the title Management against Manufacturing in 1992.
