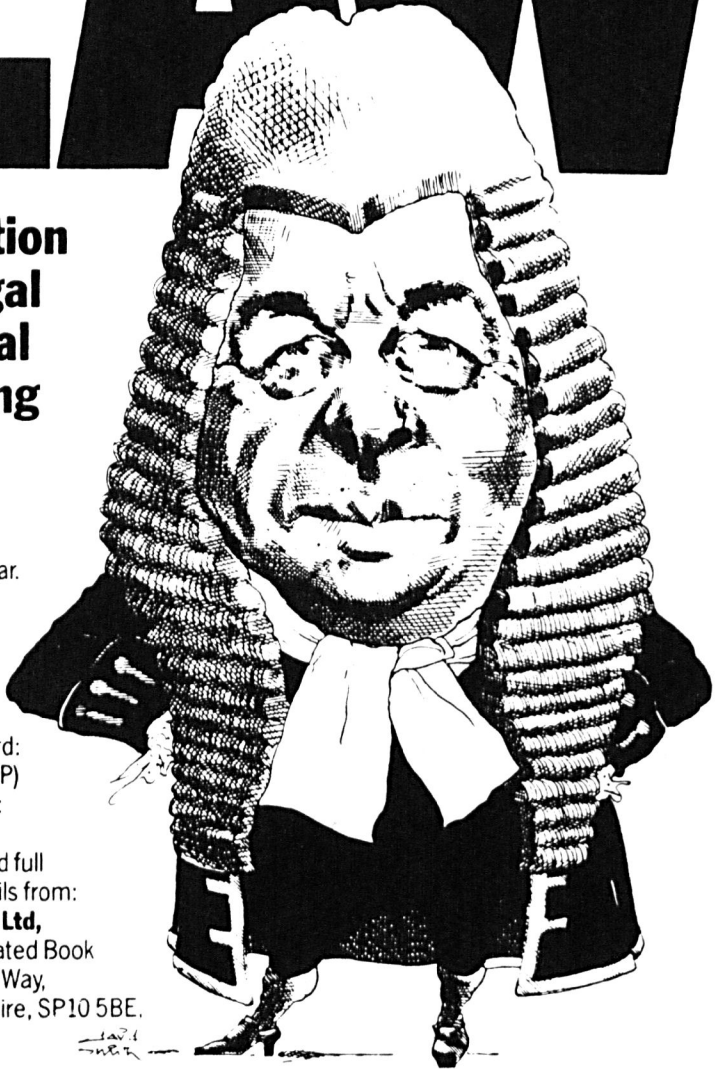

**11th IALL Course on International Law Librarianship,
September 8-11, 1991**

Max-Planck-House—Heidelberg, Germany

This IALL Course will deal with emerging problems that law librarians face in dealing with recent political and legal changes in Europe.

Topics to be discussed will include—“Law Data Banks Today and Tomorrow”, “New Challenges for Law Librarians in Germany”, as well as “Legal Changes and Their Sources in East and Central Europe”.

Among experts who already have committed themselves to be speakers on relevant subjects are Kathie Price, Katalin Balázs-Veredy, Blanka Kudej, Frank Chapman, Andrzej Gwizdź, Igor Kavass, Christian Kohler, Ralph Lansky, Thomas Reynolds, Ivan Sipkov, Raimund-Ekkehard Walter, and others.

The conference fee will be US\$100.00 or DM150.00 for participants and US\$70.00 or DM100.00 for accompanying persons. This fee will include conference materials, two lunches, one dinner and transportation for a full day excursion.
