Hertslet's Commercial Treaties is a valuable serial publication of important British documents. It includes "treaties and conventions between Great Britain and foreign powers," and "laws, decrees, orders in council, etc., concerning the same, so far as they relate to commerce and navigation, slavery, extradition, nationality, copyright, postal matters, etc."

Publication of Hertslet's began in 1827 and continued regularly through 1925 (volume 31) when the British Foreign Office incorporated it in British and Foreign State Papers. Its material is principally that of the nineteenth and twentieth centuries, but some papers are of an earlier date. Hertslet's nearly one hundred year scope and breadth of coverage make it indispensable to historians, in particular.

This ten volume edition reproduces four pages of the original 31-volume set to each page of the reprint, thus reducing the bulk of the set and facilitating its storage and handling. This new format makes it possible to offer the complete *Hertslet's Commercial Treaties* at a lower price, but in no way decreases legibility.

In the second part of the book the major civil rights are considered—in particular the right to equality before the Law and the right to freedom of speech and assembly. It deals with such topics as the development of legal aid and advice; courts and tribunals where legal aid is available; rights, duties and remuneration of solicitors and counsel; and how an applicant's resources are determined. Harvey on Industrial Relations

This authoritative account of the new industrial relations law will be greatly welcomed by all members of the legal profession, especially those who will have to advise on the practical workings of the new Act. Running to about 500 pages, the book is divided into two main Parts. The first consists of an introduction to the Act, followed by a commentary on the implications of its provisions, while Part II gives the text of the Act itself, with extensive annotations and invaluable cross-references to other statutes and authorities. The Appendices deal with essential material such as statutes and provide a list of official publications and Parliamentary debates. Harvey will eventually adopt a loose-leaf format, which will ensure that readers will be fully up-to-date with any rules and ancillary legislation passed in connection with the Act.
