

mudflats, mangroves and man-made salt pans, offer critical habitat for many migratory waterbird species in the East Asian-Australasian Flyway. More than 50 coastal Important Bird and Biodiversity Areas in the region support at least one threatened migratory species, including globally significant wintering congregations of the Endangered black-faced spoonbill Platalea minor (pictured). However, there are major gaps in knowledge of the distribution of migratory waterbirds and important wetland sites along South-east Asia's vast coastline, and in the representation of coastal wetlands across the protected area networks of many countries in this region, hindering effective conservation.
