They are representative for a considerably larger circle of well-wishers and show the very broad field of interest of library activity and at the same time reflect the intellectual world of Joachim Wieder: from specific library questions and the world of the book, through literary history, the humanities to contemporary problems and politics.

From 1958 Joachim Wieder was honorary secretary of IFLA, from 1967 to 1973 its vice-president, and in 1973 he received the Golden IFLA Honorary Medal.
