#### THE SCHIZOPHRENIC SYNDROME

Edited by Leopold Bellak, M.D. and Laurence Loeb, M.D.

A thoughtful and thorough study of schizophreniadisorder that still causes its victims to occupy one out of four hospital beds in the nation at any given time. The book progresses from a comprehensive review of the relevant literature to an in-depth analysis of what the accumulated information seems to add up to. Drawing from thousands of clinical studies and res findings, the status of every clinical, therapeutic, and diagnostic method is defined and illuminated. Actiological and pathogenic theories are covered in chapters on general, biological, biochemical, neurophysio-logical and sociocultural aspects of schizophrenia. #### MODERN PSYCHOANALYSIS OF THE SCHIZOPHRENIC PATIENT

By Hyman Spotnitz, M.D.

This new work is designed to serve as a theoretical guide to the management of ambulatory cases of schizophrenia and to facilitate understanding of their outcome. The author presents a specific working hypothesis, supplemented with clinical illustrations, for the treatment of the schizophrenic patient. A substantial contribution to the development of a systematic approach to therapy of the precedipal disorders and to the establishment of a sound theoretical basis for extensions of the basic model technique. ## THE TREATMENT OF FAMILIES IN CRISIS

By Donald G. Langsley, M.D. and David M. Kaplan, Ph.D.

The purpose of this volume is to describe the techniques for treatment and to elaborate on the various aspects of working with 186 families in crisis. The project, at Colorado Psychiatric Hospital, consisted of baseline evaluations of both experimental and control families, with follow-up measures to test the results. It includes measurement of individual patient functioning, family crisis and crisis management, before and after treatment, family role delineation and performance, together with independent clinical evaluations. Major emphasis is placed on detailed studies which illustrate the specific techniques utilized. (208 pages, \$7.50)

#### **NEW DIRECTIONS IN** MENTAL HEALTH
