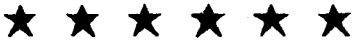

A new chapter entitled "The Improvement of Congress and of Legislative-Executive Relations" has been introduced.

This book has long been noted for its simplicity of style, its accuracy, its direct method of presentation, its distribution of emphasis, and its organization. ESSENTIALS OF AMERICAN GOVERNMENT catches and holds the student's attention, stimulates his interest in the workings of government, and leads him to think intelligently about the problems of government. *To be published in May.*
