
This groundbreaking article uses a focus on the rule of law to raise comparative questions about the construction of sovereignty and rights in China and India, within the larger global processes that shaped the 19th and 20th centuries. These questions include:

- How did the rule of law help to define the principles on which the Indian and Chinese states rested?
- How did this concept define these states' relationships to the societies they ruled?
- How can the rule of law help us to understand the ways that these states legitimized their authority?
- What are the political implications of China's and India's differences (and similarities) in the role of the law in their societies in the 19th century, and how can these help us to understand their different patterns of historical evolution in the 20th century?

This fascinating research is followed by five commentaries by leading legal historians, then a rejoinder by the article's authors. The commentaries are:



IJAS publishes research on Asia, primarily in the social sciences and humanities. The Journal is particularly interested in locating contemporary changes within a historical framework, especially using interdisciplinary approaches, and promotes comparative studies involving the various regions of Asia. While the Journal will publish scholars from around the world, it aims to focus attention on the work of Asian scholars, in order to encourage multi-directional scholarly communication in Asian studies. IJAS seeks both original papers and survey articles that fall within its scope. Submissions

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. Upon acceptance of a paper, the authors will be asked to assign copyright to Cambridge University Press.

Contributors are responsible for obtaining permission to reproduce any materials, including photographs and illustrations, for which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in the manuscript.

All contributions in the journal are peer-reviewed.

Manuscript preparation

Manuscripts must be in English and in principle no more than 12,000 words in length, including footnotes. It should be double-spaced throughout, and include a cover sheet that lists the author's name, address, e-mail address, and title, and an abstract of approximately 200 words. Submissions are accepted by post or as an e-mail attachment.

Text conventions

It is essential that contributors observe the journal's text conventions closely. Contributors should refer to the *Journal*'s rules of citation and points of style, which can be found at http://assets.cambridge.org/LJIL/asi_ifc.pdf. In order to facilitate comprehension among the broadest possible readership, contributors in some cases will be asked to provide Asian fonts for terms, bibliographical references, names of places and personages, etc.

Proofs

Only essential typographical or factual errors may be changed at proof stage. Resist the temptation to revise or add to the text. The publisher reserves the right to charge authors for correction of non-typographical errors.

Offerints

A pdf offprint will be supplied to the contributor at no charge. Production of traditional offprints can be ordered for a small fee.
