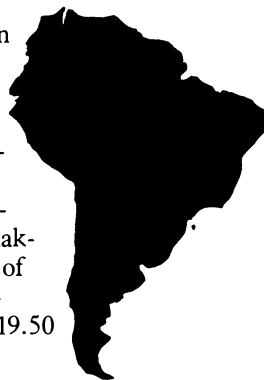


The Peasants of El Dorado *Conflict and Contradiction in a Peruvian Frontier Settlement*

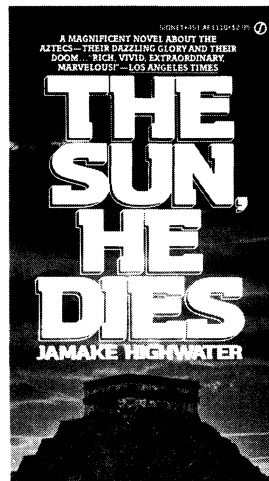
