### Banks and the World Monetary System

#### by JONATHAN D. ARONSON

This volume is an analysis of the role and power of private American banks in the international monetary system. The impact of banks on the creation and downfall of the Bretton Woods monetary system (1944-1971) is discussed in detail as is their influence on several currency crises both before and after the downfall of the dollar. The book also examines the increasingly crucial interaction between banks and underdeveloped countries in the seventies. Aronson concludes that banks have rarely directly determined government policies, but they have had considerable indirect, "circumventing" influence.
