He has co-edited (with Alan O'Day) a book on Britain since 1945, to be published in 1991, and he is currently working on a history of the British brewing industry.

Richard H. K. Vietor, who received his Ph.D. in history from the University of Pittsburgh, is professor of business administration and co-chair of the Business, Government, and Competition Area at the Harvard Business School. Among his publications are *Energy Policy in* America since 1945 (1984), Telecommunications in Transition (1986), and Strategic Management in the Regulatory Environment (1988). He is working on a history of deregulation in the airline, telecommunications, natural gas, and financial services industries.
