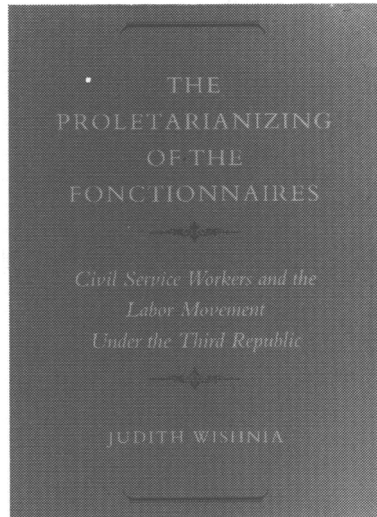
Civil Service Workers and the Labor

## The Proletarian Moment

The Controversy over  
Leftism in Literature

*James F. Murphy*  
With a foreword by  
*Cary Nelson*

Summarizes for the first time the intense international debates about leftism and proletarian literature in the 1930s, offering a view that stands in sharp contrast to previous studies. In a strongly researched challenge to conventional leftist scholarship, Murphy asserts that the portrayal of the original *Partisan Review* as a maverick dissident within the Communist-oriented proletarian literature movement is a myth subsequently fashioned by the *Review's* editors. Murphy provides evidence that international debates over proletarian literature and leftism in party-controlled or party-influenced journals were quite as varied, open, and sophisticated as those that occurred among people who broke with the Communist party in the late 1930s. The supposed intellectual innovations of the original *Partisan Review* had already been fully worked out in party publications years earlier. Murphy establishes an international background that is essential to understanding the debates in the American party-influenced journals. \$26.50.
