Rebels and Revolutionaries in North China, 1845–1945

Elizabeth J. Perry. Why do peasants rebel? In particular, why do some peasants rebel and not others? Starting from the fact that only in certain geographical areas does rebellion seem to recur persistently, the author examines three notable rebel movements in the region of Huai-pei: the Nien rebels of the 1850's and 1860's, the Red Spear Society of the Republican era, and the Communist movement of the 1930's and 1940's. The author also throws new light on the role of secret societies in peasant protest, and offers a fresh interpretation of the relationship between rebellion and revolution. \$25.00

The Emergence of Maoism

Mao Tse-tung, Ch'en Po-ta, and the Search for Chinese Theory, 1935–1945

Raymond F. Wylie. This study investigates the political and ideological context of Mao's rise to power in the Chinese Communist Party, and in particular the development of the political ideology known as "Mao Tse-tung's thought." The author's analysis of the complex interplay of elite politics within the CCP falls into two main periods: 1935-40, when the basic ideas behind the Chinese brand of Marxism were worked out by Mao and Ch'en; and 1940-45, when the two men worked to systematize and disseminate Mao's thought as the CCP's official guiding doctrine. \$25.00
