Call for Papers for the 1990 APLS Convention

The life sciences encompass a broad spectrum of theoretical, empirical, and policy approaches contributing to the study of politics. Theoretical issues include the elucidation of traditional philosophic positions concerning, for example, human nature; epistemological matters concerning the structure of explanation across natural and socal science disciplines; reassessment of the social and biological construction of gender; and consideration of the concepts of genetic and cultural evolution. Empirical studies include the study of somatic and physiological variables affecting the behavior of elites and masses; the naturalistic study of elite behavior, verbal and nonverbal; and the ecological impact of particular types of human behavior. Policy interests range from the effect of aging populations on the political agenda, to traditional health care issues, to the social and political impacts of genetic and biomedical technology on human reproduction and the environment.

In the interest of stimulating broader interest of these issues within political science, panel and paper topics are encouraged which address fundamental concepts and themes in traditional or behavioral political science in light of contemporary research and theory from the life sciences. Panels which show promise in being cosponsored with other organized sections are particularly welcomed. Examples include, but are not limited to, the exploration of the relationship between reproductive technologies and the social control of women; environmental politics, for example, the debate over ozone depletion; and the use of evolutionary theory in assessing traditional concepts in political philosophy. Suggestions for roundtables and workshops are encouraged; however, those with ideas for complete panels are encouraged to submit ideas early to allow time for panel development. Those who wish to serve as panel chairs or discussants should indicate their preferred areas and topics of interest.

PLS Appoints New Managing Editor

Frederick Frankena, the new managing editor of Politics and the Life Sciences, comes to the position from Michigan State University where he was the microcomputer coordinator for the Youth Sports Institute. Beyond the desktop publishing skills he brings to this position, he has a scholarly interest in biopolitics from the perspectives of both social science and ecology. He possesses a Ph.D. from Michigan State, for which he wrote a dissertation on the politics of technical expertise in a renewable energy facility siting controversy. He has presented his research on largescale renewable energy development at national and interational conferences and published it in such journals as Biomass, Environmental Impact Assessment Review, Journal of Forestry, Natural Resources and Society, and Renewable Resources Journal. The culmination of this work will appear early next year in a book published by Lehigh University Press entitled Strategies of Expertise in Technical Controversies: A Study of Wood Energy Development.

UN Environment Program Acts on Ozone Problem

The UNEP treaty to protect the Earth's ozone layer from chemical destruction took effect January 1, 1989 after being ratified by the minimum of 11 countries whose estimated use of ozone-destroying chemicals amounts to two-thirds of global production. In fact, by the end of December the accord had been ratified by 28 governments and the European Community. Together, these countries account for more than 80 per cent of the global consumption of these chemicals. New evidence on the accelerating destruction of the ozone layer presented at a UNEP meeting in the Hague last October led to swift action by concerned governments. The new treaty regulates production of chorofluorocarbons and halons. Parties to the original 1985 Vienna Convention on the Protection of the Ozone Layer met again this Spring in Helsinki to begin the review process.
