





Liberal Arts Fellowships in Law

For the academic year 1973-1974 Harvard Law School offers four or five Liberal Arts Fellowships to college and university teachers in the arts and sciences for a year at the Law School. Holders of these Fellowships will have the title of Fellow in Law and . . . (History, Sociology, Political Science, Economics, Philosophy, etc., depending upon their particular discipline).

The purpose of the fellowships is to enable teachers in the social sciences or humanities to study fundamental techniques, concepts, and aims of law, so that, in their teaching and research, they will be better able to use legal insights which are relevant to their own disciplines.

## Why the poor don't vote: causes, consequences and cure.
