

- If at my death, Fauna and Flora Preservation Society has ceased to exist or has amalgamated with another Charity or has changed its name, the legacy in Clause 1 shall not fail but my executors shall pay it to the charitable organisation which, in their absolute discretion, most nearly fulfils the objects that I intend to benefit.
