British Politics Group

To encourage greater understanding of contemporary British politics and society, a Conference Group on British Politics was founded at the annual meeting of the American Political Science Association at Chicago, August 31, 1974. The meeting was called at the initiative of the Council of European Studies, the major inter-university body concerned with European curricula in American universities. Sam Beer, Stephen Blank, Jorgen Rasmussen, and Richard Rose were responsible for organizing the meeting; Leon Epstein delivered remarks, and Austin Ranney, President of the American Political Science Association, provided a note of personal endorsement for the Group.

The CGBP plans a variety of activities within American universities to promote teaching and research about British politics. It intends to issue a periodic newsletter with information about current research projects, transatlantic visitors, research awards, etc.; to compile a register of research on British politics being undertaken in American universities; to hold an annual meeting in conjunction with the APSA annual convention; to organize conferences in America and in Britian about problems of special concern to American political scientists; to seek funds to support summer pre-dissertation grants to American students planning a Ph.D. about British politics; and to award an annual prize for the best American Ph.D. thesis written about British politics.

Membership in the Conference Group is open to all who have a professional interest in its activities; graduate students as well as teaching staff are welcome to join. A dues schedule has yet to be fixed. Deciding this, and much else, will be the responsibility of the founding committee. It consists of the following scholars who have published books in the field: Samuel Beer, Harvard University; Stephen Blank, Executive Secretary, Council of European Studies; James B. Truman Scholarship

Legislation has been passed by the Congress and signed by the President authorizing public service scholarships as a memorial to President Harry S. Truman.

The Truman measure, Public Law 93-642, will provide four-year scholarships, at either the graduate or undergraduate level, for students preparing for public service careers. The scholarships will cover tuition, books, room and board up to a maximum of \$5,000 a year. The act establishes a 13-member foundation to select the students on the basis of their ability and interest in public service, and stipulates that at least one be awarded in each state where there is a qualified applicant. The scholarships will be financed by the interest on a \$30 million endowment to be set up by the Treasury Department.

ACE:Consultation Service

The American Council on Education has established the Academic Administration Internship Program Consultation Service as part of its Office of Leadership Development in Higher Education. Though preservice, early inservice and continuing education are all important dimensions of an administrator's professional development, the Service will concentrate on the preservice identification, selection, training, and evaluation of prospective administrative officers.

The benefits of preservice administrative training have been demonstrated in the ten-year record of the Academic Administration Internship Program. Now, based on this experience, the Council working through the Consultation Service, is prepared to encourage the expansion of preservice opportunities for many more people than the AAIP itself can accommodate. The Service will assist ACE member institutions and associations, as well as consortia and state systems of higher education, in instituting their own preservice development programs for administrators.

To promote and assist in the development of preservice training programs, the AAIP Consultation Service will:

• Provide advice, operational information, and learning materials for establishing internship programs;

• Consult on the inauguration of other leadership development mechanisms, such as reading programs, short courses, and seminars; • Serve as an information clearinghouse for programs involving potential department chair-persons and mid-level and top-level administrators;

Coordinate and publicize preservice training opportunities nationwide;

• Arrange requisite contacts and exchanges for participants in preservice training programs.

Nominal fees may be applicable depending upon the magnitude of the assistance rendered by the Service.

PRE-PROFESSIONAL — 50 programs essentially pre-professional in nature, either part of a formal graduate program or designed to immediately follow graduate work (such as the management intern programs).

Each listing provides complete information about the program's objectives and design, recruitment, screening and selection procedures, admission requirements, and remuneration.

This first edition of the Directory represents a major first step in compiling a comprehensive nationwide listing of internship opportunities at the post-graduate level. While the Directory is not comprehensive, the National Center has implemented procedures to facilitate the continuous updating of these program listings in order to publish new editions each year. Ohio Data Archives

The archives-library of the Ohio Historical Society has established the Ohio Data Archives, a program to collect data in quantitative form and convert material in the society's holdings from original records into machine readable form.

The Ohio Data Archives will conduct a continual search for quantitative material and will administer the technical functions of accessioning, storing, and diffusing the data on a basic cost basis. The major requirements for data set accessions are that the material must be related to some aspect of Ohio, it must have been collected in a professionally competent manner, and it must have a potential interest for other users. Data may be on punch cards, but all collections will be stored on magnetic tape. Scholars and institutions who donate a copy of their data sets also must be willing to give the archives legal control in dissemination of the materials, subject to prior agreement on restrictions.

The Ohio Data Archives encourages all persons interested in any phase of quantitative research to contact the data archives. The growth of the archives is dependent on the continued cooperation of researchers and institutions. Women's Roster

The Catalyst National Roster, a computerized listing by identification number, is open to women age 24 or over who have completed at least one year of college and who seek administrative, managerial, technical or professional positions on either full-time or part-time schedules. This includes women who are currently women who are currently employed and seeking advancement within their fields as well as those who wish to re-enter the labor force after an absence.

To be listed on the Roster, a woman must request and complete a one-page Roster registration form from Catalyst National Headquarters, a non-profit organization, 14 East 60th St., New York, N.Y. 10022. Upon receipt of her completed form and personal resume, she will be assigned an identification number which will represent her on the Roster where her educational background, years of work experience, position sought, and salary and work schedule desired will be shown. The Roster is distributed monthly to nearly 150 subscribing employers, many of whom are large corporations with facilities in several locations, and to one-time users in cities throughout the U.S. Women are listed on the Roster without charge. Catalyst does not interview candidates in person. Instead, women's resumes are forwarded to employers that request them from the Roster listing or referred for a specific opening when they meet job specifications submitted by the employer for Catalyst screening. After reviewing the resume, an employer contacts the woman directly to schedule a personal interview.

SSRC History

The Social Science Research Council, on the occasion of its Fiftieth Anniversary, has announced the publication of a history of its accomplishments written by Elbridge Sibley, a distinguished sociologist who served on the Council's staff for 26 years.

Entitled *The Social Science Research Council: The First Fifty Years,* the history traces the main activities and achievements of the Council, which was incorporated on December 27, 1924.

The Council is a nonprofit organization, composed of and directed by social scientists, established to advance research in the social sciences. The 30 members of its board of directors are leading social scientists; most are designated to board membership by the American Anthropological Association, the American Economic Association, the American Historical Association, the American Political Science Association, the American Psychological Association, the American Sociological Association, and the American Statistical Association. The board directly and through its committees establishes Council policy and guides the work of a small professional staff. Prominent in the history are accounts of the origin and development of several fields in the social sciences that were invented or encouraged under Council auspices. Included are sections on the applications of mathematics in social science research; the use of social experiments to evaluate governmental welfare and other action programs; the origins of the so-called behavioral revolution in the study of political science; and the strengthening of such interdisciplinary fields as psycholinguistics, sociolinguistics, and behavioral genetics.

The Council derives its major support for the activities of its 30 current committees from private foundations and government agencies. The Council also has a small Sustaining Fund, and during this anniversary year it is seeking gifts from foundations, corporations, and social scientists themselves to augment this Fund for use in program development.

The Council's main offices are at 605 Third Avenue in New York City; a Washington office, located at 1755 Massachusetts Avenue, houses the Council's Center for Coordination of Research on Social Indicators.
