All material should be typed double-spaced, with notes separately at the end of the manuscript. Manuscripts should not exceed 10,000 words, including references, notes, and tables/figures. Please provide a word count including footnotes, endnotes, and references. Papers that significantly exceed the 10,000-word limit will not be considered for review. Tables and figurative material should be kept to a minimum. Each page should be counted as the equivalent of 250 words to be included in the overall word count. Include an abstract of not more than 250 words. For all matters of style, especially format for footnotes and reference lists, please consult the LARR website's Style Guide.
