

The journal is published in English, but articles written in other languages may be considered, and arrangements made as required for translation into English. Contributors should keep one copy of the typescript for use in correcting proofs.

Each contributor will receive, free of charge, 25 offprints of the article and a copy of the issue of the journal in which it appears.
