### **APSA Selects Black American and Chicano/Latino Fellows**

formally recognized as an Organized Section in the Association are:

- Public Administration Organizations and Executives
- Federalism and Intergovernmental Relations
- Law, Courts and Judicial Process
- Legislative Studies
- Political Organizations and Parties
- Policy Studies

Scholars in other subfields are now exploring the possibility of forming their own Organized Sections, the benefits of which include: centralized maintenance of membership lists and collection of group dues by APSA, assistance by the national office in distributing newsletters and other material for the Organized Sections, organizing panels for the annual meeting and having those panels integrated in the formal APSA Program listings, official recognition of the group in APSA's membership brochure and membership renewal forms, and special coverage in *PS*. Some groups have decided that this kind of institutional support can permit them to develop an ongoing organizational structure, and other groups, which were already in existence but unaffiliated with APSA, have found that a somewhat more formal connection to APSA strengthens their organizations.

The decision to become an Organized Section lies with the subfield scholars themselves. Council guidelines governing the formation of Organized Sections are listed in the Fall 1983 issue of *PS* (p. 739). □

## Political Scientists, Reporters Awarded Congressional Fellowships

The American Political Science Association today announced eight winners in the national competition for the 1984-85 Congressional Fellowship Program.

The winners—four political scientists and four journalists—will come to Washington, D.C. for nine months of full-time

work in the offices of U.S. Senators and Representatives.

Sponsored by the Association since 1953, the purpose of the Congressional Fellowship Program is to give outstanding political scientists, journalists, medical faculty and federal agency executives an opportunity to acquire a rich understanding of the national legislative process.

The 1,071 alumni of the program include university presidents, deans and professors; newspaper and magazine publishers, editors and reporters, high ranking executives in the federal bureaucracy, and congressmen and congressional staff aides.

The Congressional Fellows are scheduled to arrive here in early November for an orientation period before beginning work in Congressional offices of their choice. The program ends August 15, 1985.

The eight winners, listed below, were selected on the basis of professional experience, superior academic training, career goals and interest in national politics. Other Congressional Fellows, including Federal Executive Fellows, will be announced later this year.
