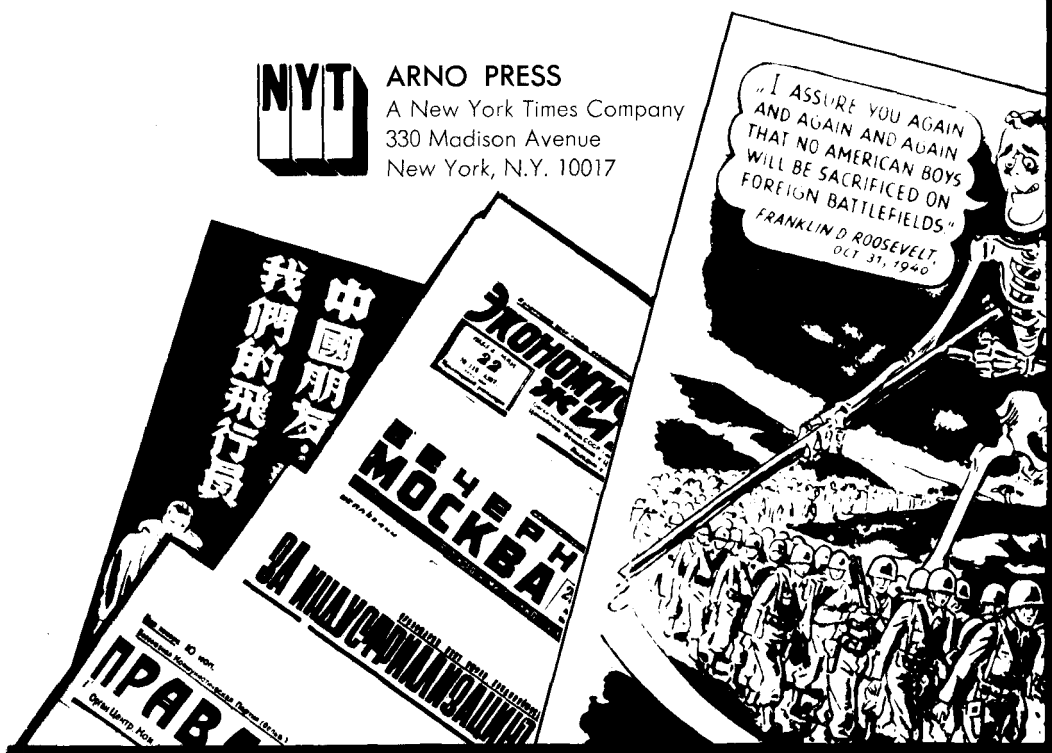

Henry Bretton has produced a first-class manuscript on African political systems. The unique features of the study are manifold, among them being:

1. A clear specification of the material constraints within which different types of African states operate. This specification is not, moreover, merely descriptive but conceptual and functional.
2. The interplay, rather than divergence, of tradition and modernity is stressed throughout.
3. What African elites articulate as self-serving descriptions of their actions and decisions are treated critically. Here the manuscript displays a level of realism and intellectual courage (honesty) that is rare in writings on African political systems.
4. The behavioral constraints on political actors and groups are delineated and dissected, viewed always in comparative perspective.
5. In all parts of the manuscript the political system as such is kept clearly in focus while specific attributes are given detailed examination. The result is that the system qua system is never lost sight of.
6. The writing is thoroughly high-level and rigorous, though always comprehensible to the non-expert reader. In this the manuscript serves at one and the same time the student and the expert on African political affairs.

I conclude, then, that Henry Bretton's manuscript fills a wider range of purposes than any book currently available in African political systems. As such it stands out as a text book; it should capture a large section of the market for serious texts in African Studies.
