

VACANCY: Editor-in-Chief, BJPsych Bulletin

The College is seeking a new Editor-in-Chief for the *BJPsych Bulletin*. The present Editor-in-Chief, Dr Norman Poole, will be standing down at the end of 2022. Applications are invited from College Members who feel they have the drive and vision to continue his work and ensure the journal's continued growth.

The post-holder will report to the Publications Management Board, chaired by the College Editor. They will be responsible for the content of the journal and the strategy for its future direction in

collaboration with PMB. Specifically, this will involve overall responsibility for the peer review process; planning and selection of content; commissioning articles; overseeing the work of the Editorial Board and taking responsibility for the scientific accuracy and validity of the content. They should be committed to keeping strong links with the College, while maintaining the editorial independence of the journal. At the same time, it is expected that they will be in touch with developments in evidence-based psychiatry and in academic psychiatry in general – the Editor-in-Chief should also be aware of the needs of working psychiatrists in peripheral areas.

This is a part-time, voluntary position and there is no remuneration related to the post. The term of office is 5 years. It is anticipated that the successful candidate will be able to devote approximately two sessions per week to this role. Support will be given by College staff in terms of editorial management of the journal, advice and guidance. The production of the journal is handled by Cambridge University Press.
