Contributors

Silvia Marzagalli is professor of modern history at the University of Nice, France. Her book, "Les boulevards de la fraude." Le négoce maritime et le Blocus continental, 1806–1813: Bordeaux, Hambourg, Livourne, was published in 1999. She has written a number of articles on eighteenth- and early-nineteenth-century commercial and maritime history, with a particular focus on French and Bordeaux trade. She has edited two books, Bordeaux et la Marine de Guerre (Bordeaux 2002), and, with Hubert Bonin, Négoce, Ports et Océans: Mélanges offerts à Paul Butel (Bordeaux 2000), and is currently working on a book about Franco-American shipping and the trade networks between Bordeaux and the United States from 1776 to 1815.

John J. McCusker is the Halsell Distinguished Professor of American History and professor of economics at Trinity University in San Antonio, Texas. He is the author of many books and articles on economic history, including, with Russell R. Menard, *The Economy of British America*, 1607–1789 (1991), and, recently, "The Demise of Distance: The Business Press and the Origins of the Information Revolution in the Early Modern Atlantic World," *American Historical Review* (April 2005). He is also the editor-in-chief of the two-volume *Encyclopedia of World Trade since* 1450 (2006).

Kenneth Morgan is professor of history at Brunel Business School, Brunel University, Uxbridge, England. He is a specialist in the early modern Atlantic economy. His books include Bristol and the Atlantic Trade in the Eighteenth Century (1993), Slavery, Atlantic Trade and the British Economy, 1660–1800 (2000), and Slavery and the British Empire (forthcoming).

Linda K. Salvucci is associate professor of history at Trinity University in San Antonio Texas. With Richard J. Salvucci, she wrote "Cuba and the Latin American Terms of Trade in the Nineteenth Century: Old Theories, New Evidence," published in the Journal of Interdisciplinary History (Autumn 2000), which won the 2001 Conference on Latin American History Prize. She has written several other essays on aspects of Atlantic and American history, ranging from reform of the Bourbon fiscal bureaucracy in New Spain to interpretations of the Alamo. She is a coauthor of a series of U.S. history textbooks for junior high-school

students. At present, she is completing a book entitled "Ironies of Empire: The United States-Cuba Trade under Spanish Rule, 1760–1898."

Thomas M. Truxes is visiting lecturer in history at Trinity College in Hartford, Connecticut, where he teaches courses in Irish history and early-modern Atlantic history. His publications include *Irish-American Trade*, 1660–1783 (1988) and a documentary-editing project, *Letter-book of Greg & Cunningham, Merchants of New York and Belfast*, 1756–57, volume 28 of the British Academy's Records of Social and Economic History series (2001). He is presently at work on a booklength treatment of New York City's trade with the French enemy during the Seven Years' War (1756–63) for Yale University Press.
