[^0]:    The Journal of Symbolic Logic is published quarterly, in the months of March, June, September, and December. The Journal is the official organ of the Association for Symbolic Logic, Inc., an international organization for furthering research in symbolic logic and exchange of ideas among mathematicians, philosophers, and others interested in this field.

    Individual membership in the Association is open to anyone interested in its work. Annual dues for students are $\$ 9.00$. Dues for other individual members are $\$ 18.00$ per year. Dues include subscription to the current volume of the JOURNAL. For their personal use, members may purchase back volumes at $25 \%$ discount.

    Institutional membership in the Association is available to any academic institution or department. Annual dues are $\$ 120,00$. Membership privileges include choices of current subscriptions, of back volumes, and of student memberships; a detailed description is available from the Association. Information on corporate membership is also available from the Association.

    For nonmembers, the current annual subscription price is $\$ 48.00$ for a volume in paper form, and $\$ 64.00$ for a combination of paper and microform (microfiche or microfilm). Microfiche of each issue is sent by first class or air mail before the camera copy is sent to the printer. Microfilm copy of a volume is sent at the end of the year. It is available in 16 mm positive or negative form, and may be ordered on spools or in Kodak or 3M cartridges.
