OBJECTS AND MEMBERSHIP

The British Institute of International and Comparative Law was founded in 1958 in order to bring together and expand the work of the Society of Comparative Legislation and International Law (founded in 1894) and the Grotius Society (founded in 1915). The Institute provides a centre for research, discussion and publications on the practical application to contemporary affairs of public and private international law and comparative law. Its membership is drawn from the judiciary, academic and practising lawyers, as well as lawyers engaged in government, commerce and industry in this country and abroad. It occupies modern central premises in Russell Square, London WC1, where it has access to a fine set of conference rooms, together with its own specialised library.

The Institute has a Council of Management of which the Chairman is the Rt Hon Lord Denning and an Advisory Board which is divided into three sections, Public International Law (Chairman, Sir Ian Sinclair), Private International Law (Chairman, Professor R.H. Graveson), and Comparative Law (Chairman, the Rt Hon Sir Robert Megarry). The Institute publishes The International and Comparative Law Quarterly, the fortnightly Bulletin of Legal Developments and other books in each of the fields of the Institute's interests. The I.C.L.Q., published four times each year, is a journal with unique coverage of public and private international law, and comparative law, with particular emphasis on European Community and Commonwealth law. The fortnightly B.L.D. provides an up-to-the-minute information service on developments in law all over the world, including legislation, case law, law reform proposals and international agreements; each issue contains about 90 items of news which are digested under European, Commonwealth and common law countries, international organisations and international developments.

Membership is worldwide and open to individuals, firms and corporations without restriction on nationality. It entitles the member to participate in the activities of the Institute and to receive the *I.C.L.Q.* and a periodic newsletter of its activities.

Full membership is open to individuals entitling them to attend all meetings and lectures of the Institute and to one copy of the I.C.L.Q. Student membership is open to any person studying law in the United Kingdom or overseas full-time at a university or other law school or for call to the Bar or for admission as a solicitor, at half the full membership fee. The half rate is available for up to three years after call or admission but not for more than three years in all. The student should provide particulars of attendance at a full-time course at a law school or of comparable full-time student status with a supporting signature of the Dean or other officer of the law school, or of his principal or master.

Corporate membership is available for institutions, firms and corporations, and entitles corporate members to full information about the activities of the Institute, one copy of the I.C.L.Q. and the fortnightly B.L.D., reduced fees for one participant at the conferences of the Institute and up to three additional copies of the I.C.L.Q. if required, free of charge. The Institute's other publications may be obtained at a 25 per cent. discount.
