# LIBRARIES AND ARCHIVES

University of California, Riverside, Expands Holdings—The Latin American Research Program at the University of California, Riverside, is expanding the library holdings of Latin American materials. Recent purchases include two collections: 1) a collection on Northeast Brazil consisting of 1,000 volumes and 65 additional periodical titles, including back files; and 2) an Argentine collection encompassing 2600 volumes on politics and social thought (1890– 1965). A special archive of Mexican materials is now being established.

Canning House Reports Library Development—Holdings in the Canning House Library now total approximately 35,000 books, principally in Portuguese, Spanish, and English, with the ratio between Hispanic and Luso Brazilian about four to one. The current rate of expansion is over 1,000 volumes each year. The Calouste Gulbenkian Foundation has made a grant of £35,000 to the Luso-Brazilian Council to support the redevelopment of a new and fully up-to-date Portuguese and Brazilian Library with special equipment and ample facilities for study, reading and lectures. The project involves the early acquisition of some 5,000 additional volumes on Portugal and Brazil. The Hispanic Library, with improved facilities, will be installed beside the new Portuguese and Brazilian Library.

CIDOC Increases Collection of Latin American Documents—The Center of Intercultural Documentation (CIDOC) in Cuernavaca, Mexico, houses a rapidly growing collection of Latin American documents. It includes published and unpublished materials on ideological, religious, and social themes dating from the middle of the last century. About 30,000 items classified in the Universal Decimal System are already cross-catalogued, and about 200 periodicals are being collected and indexed.

Conference on Latin American History Programs—A teaching atlas, planned as a black and white set of approximately 150 historical maps arranged for teaching purposes, is being developed. Originally planned by Lyle N. Mc-Alister, the project is now under the direction of Howard F. Cline, and publication is more than two years away.

Still in progress is CLAH's program to prepare and publish the *Relaciones Geográficas* of the 1577 series in New Spain (Mexico) deposited in the Latin American Collection of the University of Texas. Donald Brand, in the department of geography at the University, is editing the materials. The Conference has decided that the native maps and other graphic materials ac-

companying the reports should be reproduced in color, which had significance for sixteenth century artists and draftsmen.

A CLAH publication emerging from the joint program of the Conference on Latin American History and the Hispanic Foundation is "Soviet Images of Latin America, 1945–1965: a documentary history" being compiled by J. Gregory Oswald. It will include approximately 600 printed pages of translated Soviet materials, with introductory and other notes; the work is expected to be ready for publication by September 1967.

Cornell University Lists Latin American Holdings—Glenn Read, Cornell University's Latin American bibliographer recently compiled a list of the library's major rare holdings from Latin America, outstanding monographs, and serials. The majority are from Brazil.

*Erasmus Press Announces Documents on Microcards*—The Erasmus Press (225 Culpepper Road, Lexington, Ky. 40502) now offers in a microcard edition the official and quasi-official documents selected for listing in the "Recent Books" section of the *Revista Interamericana de Bibliografia*. This service was previously offered by Fall City Microcards. Approximately 200–300 titles are available annually at a price averaging around \$2.50 per volume. For collections that require a more comprehensive coverage of current Latin American publications, the material noted above is combined with official and quasi-official documents selected from Library of Congress proof cards, the National Union Catalog, the Bibliography of Agriculture, and certain accession lists of other libraries. This service, too, was formerly offered by Fall City Microcards. It is estimated that some 1,000 to 1,500 titles will be offered annually at a price averaging around \$2.50 per volume. Both projects include all jurisdictions south of the United States.

University of Essex Develops Latin American Collection—Concomitant with the growth of Latin American Studies at the University of Essex is the expansion of the library's Latin American collection. In its first 18 months of operation the library acquired more than 7,000 books on Latin American subjects. It subscribes to more than 50 Latin American periodical publications and has obtained several complete collections of back-runs. In addition, the Brazilian government donated some 3,000 books on Brazil, and the Calouste Gulbenkian Foundation of Lisbon presented the University with some 2,000 volumes on Portuguese and Brazilian topics.

Hispanic Foundation Receives Ford Grant—The Library of Congress was awarded \$266,000 from the Ford Foundation for continued support of bibliographical and publishing activities on Latin America by the Hispanic Foundation.

SALALM Compiles Latin American Studies List-The Ad Hoc Subcommittee on a Basic List of Latin American Materials for New Collections of SALALM (Seminar on the Acquisition of Latin American Library Materials) has determined the bases on which the list should be compiled. The subcommittee agreed that it should be compiled for use not only by colleges and undergraduate area studies programs in the United States and in Europe, but also as a buying guide for institutions in Latin America. Some 1,000 titles exclusive of periodicals, would fall into the following areas: history and geography, 250-300; literature, 300; linguistics, 25; political science, sociology, and economics, 150; philosophy, religion, fine arts, 50-100; archaeology and anthropology, 50; and reference and general works, 100. According to the time-table, the lists are to be prepared and ready for the publishers by December 1967 with a publication date in early 1968. Daniel Newberry, State University of New York at Albany, is editor of the List. Other members of the subcommittee are Hensley Woodbridge, Southern Illinois University, chairman; Nettie Lee Benson, University of Texas; Harvey Johnson, University of Houston; John Veenstra, University of Florida; Carlos Astiz, State University of New York at Albany; and Marietta Daniels Shepard, Pan American Union.

#### Fulbright-Hays Act Supports Projects in Overseas Education

The projects announced in 1966 included: 1) grants for research or study abroad in modern foreign languages and international studies; 2) the services of foreign curriculum specialists to institutions seeking to strengthen area studies and modern foreign language programs; 3) graduate fellowships for study abroad by teachers and prospective teachers in U.S. colleges and universities, for the purpose of improving their skill in foreign languages and cultures of relevant areas; 4) summer seminars for social studies teachers in selected foreign countries (Mexico and Chile are on the roster in 1967); and 5) a program for foreign studies extension to support overseas activities by American higher educational institutions. It is probable that the requirements and application procedures for the 1968-69 programs will be similar to those for 1967-68 described in brochures OE-14128 through OE-14132. New announcements and application materials for 1968-69 will be available in September 1967 and will be sent upon request. Applications for all programs must be initiated between September and November for the following summer and academic year.
