Daniel Little is an Associate Professor of Philosophy at Colgate University. He is the author of *The Scientific Marx* (University of Minnesota, 1986), *Explaining Agrarian Change* (Yale University Press, forthcoming), and articles on Marxism, rational choice, and the philosophy of social science. His current research interests involve the study of various theories of collective action in application to processes of social change in China.

Joshua Cohen is an Associate Professor of Philosophy and Political Science at MIT. He is the co-author (with Joel Rogers) of *On Democracy* (Penguin, 1983), *Inequity and Intervention* (South End, 1986), and *Rules of the Game* (South End, 1986), and his articles on issues of political philosophy and social theory have appeared in the *Journal of Philosophy*, *Philosophy and Public Affairs*, and *Ethics*. He is currently working on issues of democratic theory and on problems at the intersection of ethics and historical sociology, in particular on the connections between the injustice of slavery and its demise.

David Miller is Official Fellow in Social and Political Theory at Nuffield College, Oxford. His books include *Social Justice* (Clarendon Press, 1976), *Philosophy and Ideology in Hume's Political Thought* (Clarendon Press, 1981), and *Anarchism* (Dent, 1984). He has a long-standing research interest in the theoretical foundations of market socialism; his book on this subject, entitled *Market, State and Community*, will be published by the Clarendon Press in 1989.

John E. Roemer is Professor of Economics at the University of California at Davis. His latest book, *Free to Lose: An Introduction to Marxist Economic Philosophy* (Harvard University Press, 1988), uses elementary microeconomic models to study the relationship between exploitation, class, and wealth. In recent work, he has applied methods of mathematical economics to study questions of political philosophy in a formal way, as in, for example, "Egalitarianism, Responsibility, and Information," in *Economics and Philosophy* (1987). Currently, he is working on problems having to do with public ownership.

Jon Elster is a Professor of Political Science at the University of Chicago and Research Director at the Institute for Social Research, Oslo. Among his

publications are: *Leibniz et la Formation de l'Esprit Capitaliste* (1975), *Logic and Society* (1978), *Ulysses and the Sirens* (1979), *Explaining Technical Change* (1983), *Sour Grapes* (1983), and *Making Sense of Marx* (1985). *Solomonic Judgments*, *The Cement of Society*, and *Nuts and Bolts for the Social Sciences* will be published by Cambridge University Press in the fall of 1989.

Loren E. Lomasky is Professor of Philosophy at the University of Minnesota, Duluth and has been a visiting scholar at Virginia Polytechnic Institute, Australian National University, and the Social Philosophy and Policy Center. Lomasky's research interests include ethics, political philosophy, and the philosophy of religion. He is the author of *Persons, Rights, and the Moral Community* (Oxford University Press, 1987) and, with Geoffrey Brennan, *Democracy and Decision* (Cambridge University Press, forthcoming).

Daniel Shapiro is Assistant Professor of Philosophy at West Virginia University. He received his Ph.D. from the University of Minnesota in 1984 and has previously taught at Rice University, the University of North Carolina at Chapel Hill, and Bowling Green State University. Among his areas of interest are rights theory and Marxism. His articles have appeared in *Canadian Journal of Philosophy*, *Public Affairs Quarterly*, and *Philosophical Studies*.

N. Scott Arnold is an Associate Professor of Philosophy at the University of Alabama at Birmingham. He has written extensively on the ethics and economics of capitalism and socialism. In the summers of 1987 and 1988 he was a visiting scholar at the Social Philosophy and Policy Center. His book, *Marx's Radical Critique of Capitalist Society*, will be published by Oxford University Press in the fall of 1989.

John O'Neill is a Lecturer in Philosophy at the University College of North Wales, Bangor. After receiving his Ph.D. in philosophy from Lancaster University in 1984, he was a Lecturer in Philosophy and Politics in Beijing, China (1984–85), and then in 1986–88 was Research Fellow in the Philosophy Department at Lancaster University. His publications include papers in *Inquiry*, *Studies in History and Philosophy of Science*, *The British Journal for the Philosophy of Science*, and *Philosophy of the Social Sciences*. In addition, a play of his was produced by *BBC Radio 3*.

Williamson M. Evers is a National Fellow at the Hoover Institution at Stanford University. He was a Visiting Assistant Professor of Political Science at Emory University during 1987–88, after having received his Ph.D. from Stanford University in 1987. He has published articles on the history of political thought, on political philosophy and public policy, and on legal philosophy. He is currently writing a book on the bioethics of aspects of human genetic engineering.

Alec Nove is Professor Emeritus of Economics and former Director of the Institute of Soviet and East European Studies at the University of Glasgow.
