This book is about the spatial patterns of land use, populations, rural and urban settlement, and economic activities in Latin America. It seeks to identify, describe and explain the major economic and social patterns and processes which are manifested over the Latin American Continent. In his treatment of economic geography, Professor Odell stresses the importance of earlier development in his interpretation for the future of present trends. The socio-geographical section, by Dr. Preston, focuses on features of rural and urban society which in part explain the spatial organisation of the towns and countryside, and on the principal social and ethnic groups in the Latin American population.

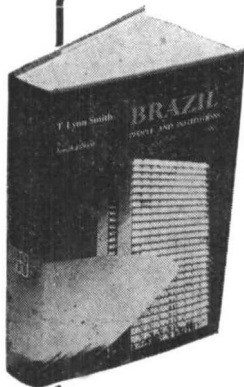

Law and Social Change in Zinacantan

Jane Fishburne Collier

The legal system of a Maya Indian community in southern Mexico is examined by focusing on the options open to persons involved in a quarrel. By examining the factors that influence a litigant's choice of procedure (hamlet settlements, informal town hall hearings, or formal court action), the author charts the relation between social change and legal change within the community. The study treats legal norms as a language for managing the social environment and asks how persons in different relationships phrase disputes in order to influence outcomes. Witchcraft beliefs and shamanistic practices are examined to show how legal concepts relate to ideas of cosmic order. Illustrated. \$10.00

NOTES FOR CONTRIBUTORS

Journal of Latin American Studies is published twice a year under the academic sponsorship of the Centres or Institutes of Latin American Studies at the Universities of Cambridge, Glasgow, Liverpool, London and Oxford.

The scope of the journal is the study of Latin America from the standpoint of the social sciences, including anthropology, archaeology, economics, geography, history, international relations, politics, sociology, etc., though it is not concerned with linguistic or literary studies.

Editorial policy avoids commitment to any political viewpoint or ideology, but welcomes free discussion of such issues in the Latin American context, on the understanding that all responsibility for opinions expressed rests exclusively with the author concerned and not with either the journal or its editors.

Contributions are invited from all parts of the world. Articles should generally not be more than 8,000 words long, and two copies, typed with double-spacing, should be submitted. Diagrams and maps may be included by arrangement with the editors. The journal is published in English, but articles written in other languages will be considered, and arrangements made as required for translation into English. Contributors should keep one copy of the typescript for use in correcting proofs.

All contributions and editorial correspondence should be addressed to *Journal of Latin American Studies*, Institute of Latin American Studies, 31 Tavistock Square, London, WC1H 9HA.

Each contributor will receive, free of charge, 25 offprints of his article and a copy of the issue of the journal in which it appears.
