Each manuscript should be typewritten with wide margins and with double spacing between the lines. Footnotes should be numbered consecutively and should also be typed with wide margins and double spacing, preferably on a separate sheet. Two copies of the manuscript should be sent to the editor, and the author should also keep a complete copy. An article of more than thirty-two printed pages in length may be divided by the editors between two or more, not necessarily consecutive, numbers. Fifty reprints of each article are supplied at no charge, and additional reprints may be purchased if desired.

Authors of papers (excluding reviews) accepted for publication in the JOURNAL are notified of the approximate number of printed pages. At that time they are asked, if funds are available from supporting institutions or grants, to arrange for payment of page charges of \$30.00 per printed page. This involves no financial obligation for the author, and acceptance of the paper will not be affected by whether payment is made.

The JOURNAL invites submission of (1) original technical papers in the field of symbolic logic, (2) expository papers in this field, (3) papers whose main point is philosophical and which either bear upon logic or make use of its methods, and (4) studies in the history of logic in which modern technical developments are taken into account.
