The Nazi Movement in the United States, 1924–1941

This book tells the dramatic story of Germany's attempt to rally German-Americans to its cause before the United States entered World War II. Mr. Diamond makes use of the records of the groups collectively known as the German-American Bund and a wealth of captured German documents to describe the Bund's origins and leaders, its membership and ideology. His is the first comprehensive account of the National Socialist movement in the United States.

Why was the Nazi movement in America unsuccessful? Why did Nazi leaders in Germany believe that the German-American community could and would influence U.S. policy? Why did even the Bund's detractors exaggerate so greatly its size and the scope of its activities? These are some of the important questions confronted by Mr. Diamond.

Based on Federal and state archival materials, personal papers and diaries, and contemporary newspapers and periodicals, the *Documentary History of the First Federal Congress* provides the first full record of the debates and actions of the First Congress. By examining the areas in which executive and congressional powers overlapped in the past, this history offers a different perspective on the recent controversies concerning executive versus congressional jurisdictions. The series will ultimately comprise fifteen volumes, to be published over the next decade.

This second volume in the series documents the executive activities of the First Senate. These include the ratification of a consular convention with France and treaties with various Indian nations; unsuccessful attempts to free American prisoners in Algiers; and, most significant, the approval of appointments to the entire corps of Federal offices. Divided into two parts, the volume consists of the original Senate Executive Journal proper and of related documents. It also has a lengthy appendix of brief biographies of those appointed to Federal Offices, with a selected list of sources on those individuals.

Attitudes toward Work in Early America

J. E. Crowley

Americans in the eighteenth century, in writing about their work and livelihoods, used words peculiar to their society. By examining the terms used publicly between 1700 and 1770 in writings about work, J. E. Crowley reveals the attitudes that contributed to the American work ethic and the limits within which economic activity was given meaning.

Crowley discerns two conflicting valuations of work and economic activity. The Christian, colonial valuation of work was a moralistic one whereby individual considerations were subordinated to the interest of society; the Puritan ethic of self-denial is an example. The other valuation at that time was derived from English mercantilist thought, which separated the realm of morality and the realm of economic livelihood, endorsing commercial exploitation of material and human resources to achieve economic aims.

William Evitts examines the decisive period from 1850 to 1861 not as the decade prior to the Civil War but as a time of change and growth experienced by contemporaries unaware of the coming war. Using Maryland as a microcosm, he studies the economic, social, and political transformations in the minds of the American people themselves.

A critical border state, Maryland was complex and diversified. Its citizens grappled with most of the problems faced by Americans then, including urban growth, immigration, slavery, political realignment, and constitutional reform.

DEMOCRATS AND PROGRESSIVES

**The 1948 Presidential Election as a Test of
Postwar Liberalism**

Allen Yarnell

Third parties have played a prominent part in American politics since the mid-nineteenth century, and today names such as Populists and Progressives are well known. The present volume sets out to test the often held notion that third parties in the American political system significantly influence either or both of the major parties, by focussing on the response of the Democratic Party to the Henry Wallace Progressives in the 1948 presidential campaign.

PERSONALITY AND DEMOCRATIC POLITICS

Paul M. Sniderman

How does a personality characteristic such as self-esteem become translated into political attitudes? How do individual differences in self-esteem affect who becomes a political activist and a political leader? Professor Sniderman addresses these two major questions in this study, which is the first of its kind to be based on large-scale samples of both political leaders and ordinary citizens. He draws from the voluminous research of social psychologists on self-esteem, integrating this with theories drawn from Freud and his followers, and with functional and social learning approaches, ultimately developing a new theory to account for the complex findings.

In 1972, the American Political Science Association gave this study the E. E. Schattschneider Award for the best doctoral dissertation in the field of American government and politics.

PUBLIC HIGHER EDUCATION IN CALIFORNIA

Edited by Neil J. Smelser and Gabriel Almond

From 1950 to 1970 student enrollment in the California system of higher education underwent a five fold increase, a growth rate which generated internal organizational stresses, created frictions among the academic "estates" (students, faculty, graduate students, research personnel), and threatened the system's ability to govern itself.

In a long theoretical essay on social change, Smelser examines the social structure for the origins of conflict and assesses the system's capacity to contain and manage it.

The remaining twelve essays constitute an institutional history of higher education in California and an incisive commentary on the strengths and weaknesses of the Master Plan for Higher Education in the first decade of its existence.

MARK TWAIN'S NOTEBOOKS AND JOURNALS

Volume I (1855–1873)

*Edited by Frederick Anderson, Michael B. Frank and
Kenneth M. Sanderson*

This first volume documents Samuel Clemens' progress from his days as a journeyman printer and apprentice steamboat pilot on the Mississippi River through a foot-loose period of Western mining, vigorous masculine journalism, and travel to the broader and more substantial responsibilities of an author of international reputation, public figure, businessman and family man. The volume affords insights into the writing of *The Innocents Abroad* and *Roughing It*, the major works of the period of the early notebooks, but there are also intriguing hints of persistent themes that emerge in much later works. More than any other source, the notebooks indicate the process of Clemens' art.

Volume II of the notebooks spans the period during which Clemens worked to solidify his literary, financial and social position. His early adventurous years of travel and changing vocations as a steamboat pilot, miner, and newspaper reporter had given rise to his first success and reputation as the boisterous Western humorist. Now he would seek a wider reputation, tempering the sometimes crude local humor of his earlier writings in favor of a more distinctly American voice and expanding his audience to the East and, even further, to Europe.

The records of three trips form the nucleus of the notebooks in this volume: an idyllic vacation in Bermuda, a stay of a year and a half in Europe, and a nostalgic return to the scenes of his youth along the Mississippi.

NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, Department of American Studies, The University, Manchester M13 9PL, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
